15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 74 O.S. 2011, Section 85.3A, as
17	last amended by Section 4, Chapter 98, O.S.L. 2020 (74 O.S. Supp.
18	2020, Section 85.3A), is amended to read as follows:
19	Section 85.3A. A. Compliance with the provisions of the
20	Oklahoma Central Purchasing Act shall not be required of:
21	1. County government;
22	2. The Oklahoma State Regents for Higher Education, the
23	institutions, centers $_{ au}$ or other constituent agencies of The Oklahoma
24	State System of Higher Education;

1 3. The telecommunications network known as OneNet; 2 4. The Department of Public Safety gun range; 3 5. The State Treasurer for the following purchases: services, including, but not limited to, legal 4 a. 5 services to assist in the administration of the Uniform Unclaimed Property Act, as provided in Section 6 668 of Title 60 of the Oklahoma Statutes, and 7 b. software, hardware and associated services to assist 8 9 in the administration of funds and securities held by 10 the state, as provided in Section 71.2 of Title 62 of the Oklahoma Statutes; 11 12 6. Statutorily allowed interagency agreements between state agencies; 13 7. The Oklahoma Department of Veterans Affairs, in accordance 14 with Section 63.22 of Title 72 of the Oklahoma Statutes; or 15 16 8. The Oklahoma Military Department for the purchases of heraldry items including, but limited to, medals, badges and other 17 18 military accoutrements; or 9. A transaction, wholly funded by monies other than state-19 derived funds, in which a state agency functions only as a pass-20 through conduit to fund an acquisition that is required by the 21 funding source for the benefit of another entity or individuals and 22 the state agency does not retain ownership of any part of the 23 acquisition as a result of the transaction. 24

1 The State Purchasing Director may form an advisory committee В. 2 consisting of representatives from entities exempted from the 3 provisions of the Oklahoma Central Purchasing Act. The purpose of the committee shall be to allow committee members to provide input 4 5 into the development of shared state purchasing contracts, 6 collaboratively participate in the integration of their purchasing 7 platforms or electronic purchasing catalogs, analyze solutions that may be used by state government to meet the purchasing needs of the 8 9 entities, explore joint purchases of general use items that result 10 in mutual procurement of quality goods and services at the lowest reasonable cost and explore flexibility, administrative relief $\tau$  and 11 12 transformation changes through utilization of procurement 13 technology.

14 C. At the invitation of the State Purchasing Director entities 15 exempted from the provisions of the Oklahoma Central Purchasing Act 16 shall participate in the advisory committee referenced in subsection 17 B of this section.

D. The State Purchasing Director may invite representatives of political subdivisions, and local common education entities to participate as members of the advisory committee.
