An Act relating to motor vehicles; amending 47 O.S. 2011, Section 15-113, which relates to penalties for parking in a disabled parking place; excluding certain penalties for a person with a Purple Heart recipient license plate; modifying penalty for certain offense; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 15-113, is amended to read as follows:

Section 15-113. A. Any person who knowingly makes or procures the making of a false statement in an application submitted pursuant to Sections 15-111 through 15-113 of this title is guilty of a misdemeanor and upon conviction shall be punished by a fine of Five Hundred Dollars (\$500.00) for each falsified statement. This penalty shall be stated on all applications.

B. 1. Any person who has not been issued a physically disabled parking placard pursuant to the provisions of Section 15-112 of this

1 title, a physically disabled license plate issued pursuant to the  
2 provisions of Section 1135.1 of this title, a disabled veterans  
3 license plate pursuant to the provisions of Section 1135.2 of this  
4 title, a Purple Heart recipient license plate issued pursuant to the  
5 provisions of Section 1135.2 of this title, a disability sticker  
6 issued by the Department of Veterans Affairs and federal military  
7 bases, or a physically disabled placard or license plate issued by  
8 another state, and uses a placard, sticker, or license plate to park  
9 in a disabled parking place is guilty of a misdemeanor and upon  
10 conviction shall be punished by a fine of Five Hundred Dollars  
11 (\$500.00). A person transporting a physically disabled person with  
12 an authorized placard, sticker or license plate, as provided in  
13 subsection A of Section 11-1007 of this title, shall be excluded  
14 from the provisions of this section.

15 2. Any person who has been issued a physically disabled parking  
16 placard pursuant to the provisions of Section 15-112 of this title,  
17 a physically disabled license plate issued pursuant to the  
18 provisions of Section 1135.1 of this title, ~~or~~ a disabled veterans  
19 license plate pursuant to the provisions of Section 1135.2 of this  
20 title or a Purple Heart recipient license plate issued pursuant to  
21 the provisions of Section 1135.2 of this title, and knowingly allows  
22 the placard or license plate to be used by a person not issued the  
23 placard or license plate as described in paragraph 1 of this  
24

1 subsection, is guilty of a misdemeanor and upon conviction shall be  
2 punished by a fine of Five Hundred Dollars (\$500.00).

3 C. A person who knowingly makes a counterfeit physically  
4 disabled parking placard or physically disabled license plate is  
5 guilty of a misdemeanor and upon conviction shall be punished by a  
6 fine of Five Hundred Dollars (\$500.00) for each counterfeit placard  
7 or license plate made by such person.

8 SECTION 2. This act shall become effective November 1, 2021.
