19	Section 601.6. A. The Office of Juvenile System Oversight
20	shall have the responsibility of investigating and reporting

The provisions of this paragraph shall not apply to any complaint by a foster parent regarding the result of a criminal, 4 5 administrative, or civil proceeding for a violation of any law, rule, or contract provision by that foster parent, or the action 6 taken by the Department or a child-placing agency in conformity with 7 the result of any such proceeding; 8

9 5. Issue reports to the Governor, Speaker of the House of
10 Representatives, President Pro Tempore of the Senate, Chief Justice
11 of the Supreme Court of the State of Oklahoma, any appropriate
12 prosecutorial agency, the director of the agency under
13 consideration, and other persons as necessary and appropriate; and

Provide recommendations to the Oklahoma Commission on
 Children and Youth on or before May 1 of each year.

16 C. The Office of Juvenile System Oversight shall not release 17 information that would identify a person who makes a complaint to 18 the Office, unless a court of competent jurisdiction orders release 19 of the information for good cause shown.
