An Act relating to license plate fees; amending 47 O.S. 2011, Section 1116, which relates to registration periods; establishing certain convenience fee; making payment of fee a prerequisite to certain registration actions; providing for deposit of certain fee collections; modifying registration period for certain vehicles; requiring fees for certain plates to be remitted in same registration period; requiring the promulgation of rules; maintaining certain apportionment; amending 47 O.S. 2011, Sections 1135.1, as amended by Section 1, Chapter 26, O.S.L. 2016, 1135.2, as last amended by Section 1, Chapter 434, O.S.L. 2019, 1135.3, as last amended by Section 2, Chapter 434, O.S.L. 2019, 1135.4, as amended by Section 3, Chapter 69, O.S.L. 2018, 1135.5, as last amended by Section 3, Chapter 434, O.S.L. 2019, 1135.6 and 1135.7, as amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020, Sections 1135.1, 1135.2, 1135.3, 1135.4, 1135.5 and 1135.7), which relate to special or personalized license plates; requiring certain single registration period; requiring promulgation of rules; construing provision with respect to apportionment; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1116, is
2 amended to read as follows:

3 Section 1116. A. Twelve registration periods shall be
4 established for vehicles required to be registered on a staggered
5 basis. The registration periods shall start on the first day of
6 each calendar month and shall end on the last day of that month.
7 Unless otherwise provided, all such vehicles where the date of
8 execution of transfer of ownership occurs in this state at any time
9 during a calendar month shall be subject to registration and payment
10 of the fee for the registration period commencing the first day of
11 the month of such date of execution of transfer.

12 B. 1. A person who registers more than one vehicle may have
13 all of such vehicles initially registered at the same time or at
14 separate times. Any person who obtains a vehicle may, upon
15 registration, have the registration period adjusted to allow future
16 registration of all such vehicles at the same period or at a
17 different period.

18 2. Upon the payment of a five-dollar one-time convenience fee,
19 any two or more noncommercial vehicles owned by the same person and
20 previously registered in this state may be registered at the same
21 time regardless of the month or months in which the vehicles were
22 previously registered. The month in which the noncommercial
23 vehicles are newly registered shall be the month in which the
24 registration is renewed annually. If a noncommercial vehicle is

1 registered pursuant to this subsection in the same calendar year in
2 which it was previously registered, license and registration fees
3 shall be prorated to account for the difference between the previous
4 renewal month and the new renewal month and those fees shall be due
5 at the time of registration pursuant to this subsection. Of the
6 monies collected pursuant to the convenience fee created by this
7 paragraph, Two Dollars and fifty cents (\$2.50) shall be deposited to
8 the credit of the Oklahoma Tax Commission Fund created pursuant to
9 Section 221 of Title 62 of the Oklahoma Statutes and Two Dollars and
10 fifty cents (\$2.50) shall be retained by the motor license agent.

11 C. If a special or personalized license plate is issued
12 pursuant to Sections 1135.1 through 1135.7 of this title, any
13 registration fee required for such plate and the fee required
14 pursuant to subsection A of Section 1132 of this title shall be
15 remitted at the same time and subject to a single registration
16 period. The Oklahoma Tax Commission shall promulgate rules
17 establishing a method for making required fee adjustments when a
18 special or personalized license plate is obtained during a twelve-
19 month period for which a registration fee has already been remitted
20 pursuant to this subsection. The combination of fees in a single
21 remittance shall not alter the apportionment otherwise provided for
22 by law.

1 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.1, as
2 amended by Section 1, Chapter 26, O.S.L. 2016 (47 O.S. Supp. 2020,
3 Section 1135.1), is amended to read as follows:

4 Section 1135.1. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons as provided by this section.

7 Special license plates shall not be transferred to any other
8 person but shall be removed from the vehicle upon transfer of
9 ownership and retained. The special license plate may then be used
10 on another vehicle but only after such other vehicle has been
11 registered for the current year.

12 Except as provided in subsection B of this section, special
13 license plates shall be renewed each year by the Tax Commission or a
14 motor license agent. The Tax Commission shall annually notify by
15 mail all persons issued special license plates. The notice shall
16 contain all necessary information and shall contain instructions for
17 the renewal procedure upon presentation to a motor license agent or
18 the Tax Commission. The license plates shall be issued on a
19 staggered system. The motor license agent fees shall be paid out of
20 the Oklahoma Tax Commission Reimbursement Fund.

21 If a special license plate is issued pursuant to this section,
22 any registration fee required for such plate and the fee required
23 pursuant to subsection A of Section 1132 of this title shall be
24 remitted at the same time and subject to a single registration

1 period. The Oklahoma Tax Commission shall promulgate rules
2 establishing a method for making required fee adjustments when a
3 special license plate is obtained during a twelve-month period for
4 which a registration fee has already been remitted pursuant to this
5 subsection. The combination of fees in a single remittance shall
6 not alter the apportionment otherwise provided for by law.

7 B. The special license plates provided by this section are as
8 follows:

9 1. Political Subdivision Plates - such plates shall be designed
10 for any vehicle owned by any political subdivision of this state
11 having obtained a proper Oklahoma certificate of title. Such
12 political subdivisions shall file an annual report with the Tax
13 Commission stating the agency where such vehicle is located. Such
14 license plates shall be permanent in nature and designed in such a
15 manner as to remain with the vehicle for the duration of the life
16 span of the vehicle or until the title is transferred to an owner
17 who is not a political subdivision.

18 The registration fee shall be Eight Dollars (\$8.00) and shall be
19 in addition to all other registration fees provided by law, except
20 the registration fees levied by Section 1132 of this title;

21 2. Tax-Exempt or Nonprofit License Plates - such plates shall
22 be designed for:

23 a. any motor bus, manufactured home, or mobile chapel and
24 power unit owned and operated by a religious

1 corporation or society of this state holding a valid
2 exemption from taxation issued pursuant to Section
3 501(a) of the Internal Revenue Code, 26 U.S.C.,
4 Section 501(a), and listed as an exempt organization
5 in Section 501(c)(3) of the Internal Revenue Code, as
6 amended, 26 U.S.C., Section 501(c)(3), and that is
7 used by the corporation or society solely for the
8 furtherance of its religious functions,

9 b. any vehicle owned and operated only by nonprofit
10 organizations devoted exclusively to youth programs
11 including, but not limited to, the Girl Scouts and Boy
12 Scouts of America,

13 c. any vehicle, except passenger automobiles, owned or
14 operated by nonprofit organizations actually involved
15 in programs for the employment of the handicapped and
16 used exclusively in the transportation of goods or
17 materials for such organization,

18 d. any vehicle owned and operated by a nonprofit
19 organization that provides older persons
20 transportation to and from medical, dental and
21 religious services and relief from business and social
22 isolation,

23 e. any vehicle owned and operated by a private nonprofit
24 organization that:

- (1) warehouses and distributes surplus foods to other nonprofit agencies and organizations, and
 - (2) holds a valid exemption from taxation issued pursuant to Section 501(c) of the Internal Revenue Code, as amended, 26 U.S.C., Section 501(c), and listed as an exempt organization in Section 501(c)(3) of the Internal Revenue Code, as amended, and
 - (3) uses such vehicle exclusively for the transportation of such surplus foods,
- f. any vehicle which:
- (1) is owned and operated by a private, nonprofit organization which is exempt from taxation pursuant to the provisions of Section 501(c)(3) of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), and which is primarily funded by a fraternal or civic service organization with at least one hundred local chapters or clubs, and
 - (2) is designed and used to provide mobile health screening services to the general public at no cost to the recipient, and for which no reimbursement of any kind is received from any health insurance provider, health maintenance organization or governmental program, or

1 g. any vehicle owned and operated by the Civil Air
2 Patrol, a congressionally chartered corporation that
3 also serves an auxiliary of the United States Air
4 Force and which is exempt from taxation pursuant to
5 the provisions of Section 501(c)(3) of the Internal
6 Revenue Code, 26 U.S.C., Section 501(c)(3), and is
7 used exclusively for its corporate missions of
8 aerospace education, cadet programs and emergency
9 services. Such license plates shall be permanent in
10 nature and designed in such a manner as to remain with
11 the vehicle for the duration of the life span of the
12 vehicle or until the title to such vehicle is
13 transferred to an owner who is not subject to this
14 exemption. Such vehicles shall be exempt from the
15 registration fees levied under Section 1132 of this
16 title, except that an initial registration fee of
17 Twenty-five Dollars (\$25.00) shall apply to each
18 vehicle.

19 Any person claiming to be eligible for a tax-exempt or nonprofit
20 license plate under the provisions of this paragraph must have the
21 name of the tax-exempt or nonprofit organization prominently
22 displayed upon the outside of the vehicle, except those vehicles
23 registered pursuant to the provisions of subparagraph b of this
24 paragraph, unless such display is prohibited by federal or state law

1 or by state agency rules. No vehicle shall be licensed as a tax-
2 exempt or nonprofit vehicle unless the vehicle has affixed on each
3 side thereof, in letters not less than two (2) inches high and two
4 (2) inches wide, the name of the tax-exempt or nonprofit
5 organization or the insignia or other symbol of such organization
6 which shall be of sufficient size, shape and color as to be readily
7 legible during daylight hours from a distance of fifty (50) feet
8 while the vehicle is not in motion.

9 Except as provided in subparagraph g of this paragraph, the
10 registration fee shall be Eight Dollars (\$8.00) and shall be in
11 addition to all other registration fees provided by law, except the
12 registration fees levied by Section 1132 of this title;

13 3. Physically Disabled License Plates - such plates shall be
14 designed for persons who are eligible for a physically disabled
15 placard under the provisions of Section 15-112 of this title. It
16 shall prominently display the international accessibility symbol,
17 which is a stylized human figure in a wheelchair. The Tax
18 Commission shall also design physically disabled license plates for
19 motorcycles owned by persons who are eligible for a physically
20 disabled placard pursuant to the provisions of Section 15-112 of
21 this title. Upon the death of the physically disabled person, the
22 disabled license plate shall be returned to the Tax Commission.
23 There shall be no fee for such plate in addition to the rate
24 provided by the Oklahoma Vehicle License and Registration Act for

1 the registration of the vehicle. For an additional fee of Ten
2 Dollars (\$10.00), a person eligible for a physically disabled
3 license plate shall have the option of purchasing a duplicate
4 physically disabled special license plate which shall be securely
5 attached to the front of the vehicle. The original physically
6 disabled special license plate shall be securely attached to the
7 rear of the vehicle at all times.

8 Any person who is eligible for a physically disabled license
9 plate and whose vehicle has had modifications because of the
10 physical disability of the owner or of a family member within the
11 second degree of consanguinity of the owner, may register the
12 vehicle for a flat fee of Twenty-five Dollars (\$25.00). This fee
13 shall be in lieu of all other registration fees provided by the
14 Oklahoma Vehicle License and Registration Act;

15 4. Indian Tribal License Plates - such plates shall be designed
16 for any vehicle of a native American Indian Tribal Association
17 exempted in Sections 201 through 204 of Public Law 97-473 and used
18 by the tribal association exclusively for the furtherance of its
19 tribal functions.

20 The registration fee shall be Eight Dollars (\$8.00) and shall be
21 in addition to all other registration fees provided by law, except
22 the registration fees levied by Section 1132 of this title;

23 5. Hearing Impaired License Plates - such plates shall be
24 designed for persons who are hearing impaired. Such persons may

1 apply for a hearing-impaired license plate for each vehicle with a
2 rated carrying capacity of one (1) ton or less upon the presentment
3 of an application on a form furnished by the Tax Commission and
4 certified by a physician holding a valid license to practice
5 pursuant to the licensing provisions of Title 59 of the Oklahoma
6 Statutes, attesting that the person is hearing impaired. The
7 license plate shall be designed so that such persons may be readily
8 identified as being hearing impaired. There shall be no additional
9 fee for the plate, but all other registration fees provided by the
10 Oklahoma Vehicle License and Registration Act shall apply;

11 6. Antique or Classic Vehicles License Plates - such plates
12 shall be designed and issued for any vehicle twenty-five (25) years
13 of age or older, based upon the date of manufacture thereof and
14 which travels on the highways of this state primarily incidental to
15 historical or exhibition purposes only.

16 The registration fee shall be Eight Dollars (\$8.00) and shall be
17 in addition to all other registration fees provided by law, except
18 the registration fees levied by Section 1132 of this title. Any
19 person registering an antique or classic vehicle may elect to have
20 the vehicle registered for a ten-year period. The registration fee
21 for the elected ten-year registration shall be Seventy-five Dollars
22 (\$75.00). The motor license agent registering the antique or
23 classic vehicle for a ten-year period shall receive one hundred
24 percent (100%) of the fees the motor license agent would have

1 otherwise received pursuant to subsection A of Section 1141.1 of
2 this title if the antique or classic vehicle had been registered on
3 an annual basis; and

4 7. Honorary Consul License Plates - such plates shall be
5 designed to include the words "Honorary Consul" and issued to
6 persons who are honorary consuls authorized by the United States to
7 perform consular duties. Persons applying for such license plates
8 must show proof of standing as an honorary consul. The fee for such
9 plate shall be Eight Dollars (\$8.00) and shall be in addition to all
10 other registration fees required by the Oklahoma Vehicle License and
11 Registration Act. The owner of the vehicle that possesses such
12 license plates shall return the special license plates to the
13 Oklahoma Tax Commission if the owner disposes of the vehicle during
14 the registration year or ceases to be authorized to perform consular
15 duties.

16 C. Special license plates provided by this section shall be
17 designed in such a manner as to identify the use or ownership of the
18 vehicle. Use of any vehicle possessing a special license plate
19 provided by this section for any purpose not specified herein shall
20 be grounds for revocation of the special license plate and
21 registration certificate.

22 D. The fees provided by this section shall be deposited in the
23 Oklahoma Tax Commission Reimbursement Fund.

1 SECTION 3. AMENDATORY 47 O.S. 2011, Section 1135.2, as
2 last amended by Section 1, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
3 2020, Section 1135.2), is amended to read as follows:

4 Section 1135.2. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons in recognition of their service or awards as
7 provided by this section.

8 Special license plates shall not be transferred to any other
9 person but shall be removed from the vehicle upon transfer of
10 ownership and retained. The special license plate may then be used
11 on another vehicle but only after such other vehicle has been
12 registered for the current year.

13 Special license plates shall be renewed each year by the Tax
14 Commission or a motor license agent. The Tax Commission shall
15 annually notify by mail all persons issued special license plates.
16 The notice shall contain all necessary information and shall contain
17 instructions for the renewal procedure upon presentation to a motor
18 license agent or the Tax Commission. The license plates shall be
19 issued on a staggered system except for legislative plates and
20 amateur radio operator license plates.

21 If a special license plate is issued pursuant to this section,
22 any registration fee required for such plate and the fee required
23 pursuant to subsection A of Section 1132 of this title shall be
24 remitted at the same time and subject to a single registration

1 period. The Oklahoma Tax Commission shall promulgate rules
2 establishing a method for making required fee adjustments when a
3 special license plate is obtained during a twelve-month period for
4 which a registration fee has already been remitted pursuant to this
5 subsection. The combination of fees in a single remittance shall
6 not alter the apportionment otherwise provided for by law.

7 The Tax Commission is hereby directed to develop and implement a
8 system whereby motor license agents are permitted to accept
9 applications for special license plates authorized under this
10 section. The motor license agent shall confirm the applicant's
11 eligibility, if applicable, collect and deposit any amount
12 specifically authorized by law, accept and process the necessary
13 information directly into such system and generate a receipt
14 accordingly. For performance of these duties, motor license agents
15 shall retain the fee provided in Section 1141.1 of this title for
16 registration of a motor vehicle. The motor license agent fees for
17 acceptance of applications and renewals shall be paid out of the
18 Oklahoma Tax Commission Reimbursement Fund.

19 B. The special license plates provided by this section are as
20 follows:

21 1. Prisoner of War License Plates - such plates shall be
22 designed for honorably discharged or present members of the United
23 States Armed Forces and civilians who were former prisoners of war
24 held by a foreign country and who can provide proper certification

1 of that status. Such persons may apply for a prisoner of war
2 license plate for no more than two vehicles with each vehicle having
3 a rated carrying capacity of one (1) ton or less. The surviving
4 spouse of any deceased former prisoner of war, if the spouse has not
5 since remarried, or if remarried, the remarriage is terminated by
6 death, divorce, or annulment, may apply for a prisoner of war
7 license plate for one vehicle with a rated carrying capacity of one
8 (1) ton or less. The fee provided by this section for the special
9 license plate authorized by this paragraph shall be in addition to
10 all other registration fees provided by law, except the registration
11 fees levied by Section 1132 of this title;

12 2. National Guard License Plates - such plates shall be
13 designed for active or retired members of the Oklahoma National
14 Guard. Retirees who are eligible for such plates shall provide
15 proof of eligibility upon initial application, but shall not be
16 required to provide proof of eligibility annually;

17 3. Air National Guard License Plates - such plates shall be
18 designed for active or retired members of the Oklahoma Air National
19 Guard. Retirees who are eligible for such plates shall provide
20 proof of eligibility upon initial application, but shall not be
21 required to provide proof of eligibility annually;

22 4. United States Armed Forces License Plates - such plates
23 shall be designed for active, retired, former or reserve members of
24 the United States Armed Forces, and shall identify which branch of

1 service, and carry the emblem and name of either the Army, Navy, Air
2 Force, Marines or Coast Guard, according to the branch of service to
3 which the member belongs or did belong. Former members who have
4 been dishonorably discharged shall not be eligible for such plates.
5 Persons applying for such license plate must show proof of present
6 or past military service by presenting a valid Uniformed Services
7 Identity Card or the United States Department of Defense Form
8 (DD)214. Retired or former members who are eligible for such plates
9 shall provide proof of eligibility upon initial application, but
10 shall not be required to provide proof of eligibility annually;

11 5. Congressional Medal of Honor Recipient License Plates - such
12 plates shall be designed for any resident of this state who has been
13 awarded the Congressional Medal of Honor. Such persons may apply
14 for a Congressional Medal of Honor recipient license plate for each
15 vehicle with a rated carrying capacity of one (1) ton or less.
16 There shall be no registration fee for the issuance of this plate;

17 6. Missing In Action License Plates - such plates shall be
18 designed to honor members of the United States Armed Forces who are
19 missing in action. The spouse of such missing person, if the spouse
20 has not since remarried, or if remarried, the remarriage is
21 terminated by death, divorce, or annulment, and each parent of the
22 missing person may apply for a missing in action license plate upon
23 presenting proper certification that the person is missing in action
24 and that the person making the application is the qualifying spouse

1 or the parent of the missing person. The qualifying spouse and each
2 parent of the missing person may each apply for the missing in
3 action license plate for each vehicle with a rated carrying capacity
4 of one (1) ton or less;

5 7. Purple Heart Recipient License Plates - such plates shall be
6 designed for any resident of this state presenting proper
7 certification from the United States Department of Veterans Affairs
8 or the Armed Forces of the United States certifying that such
9 resident has been awarded the Purple Heart military decoration.
10 Such persons may apply for a Purple Heart recipient license plate
11 for vehicles having a rated carrying capacity of one (1) ton or
12 less. The surviving spouse of any deceased veteran who has been
13 awarded the Purple Heart military decoration, if such spouse has not
14 since remarried, or if remarried, the remarriage has been terminated
15 by death, divorce or annulment, may apply for such plate for one
16 vehicle with a rated carrying capacity of one (1) ton or less. The
17 license plate created by this paragraph shall be exempt from the fee
18 provided by this section for special license plates;

19 8. Pearl Harbor Survivor License Plates - such plates shall be
20 designed for any resident of this state who can be verified by the
21 United States Department of Veterans Affairs or the Armed Forces of
22 the United States as being:

- 23 a. a member of the United States Armed Forces on December
24 7, 1941,

1 b. stationed on December 7, 1941, during the hours of
2 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,
3 the island of Oahu, or offshore at a distance not to
4 exceed three (3) miles, and

5 c. a recipient of an honorable discharge from the United
6 States Armed Forces.

7 Such person may apply for a Pearl Harbor Survivor license plate
8 for each vehicle with a rated carrying capacity of one (1) ton or
9 less;

10 9. Iwo Jima License Plates - such plates shall be designed for
11 any resident of this state who can be verified by the United States
12 Department of Veterans Affairs or the Armed Forces of the United
13 States as being:

14 a. a member of the United States Armed Forces in February
15 of 1945,

16 b. stationed in February of 1945 on or in the immediate
17 vicinity of the island of Iwo Jima, and

18 c. a recipient of an honorable discharge from the United
19 States Armed Forces.

20 Such person may apply for an Iwo Jima license plate for each
21 vehicle with a rated carrying capacity of one (1) ton or less.

22 Such license plate shall have the legend "Oklahoma OK" and shall
23 contain three letters and three numbers. Between the letters and
24 numbers shall be a logo of the flag-raising at Iwo Jima. Below the

1 letters, logo and numbers, the plate shall contain the words "FEB."
2 at the left, "Iwo Jima" in the center and "1945" at the right. Such
3 plates shall not be subject to the design requirements of any other
4 license plates prescribed by law other than the space for the
5 placement of the yearly decals for each succeeding year of
6 registration after the initial issue;

7 10. D-Day Survivor License Plates - such plates shall be
8 designed for any resident of this state who can be verified by the
9 United States Department of Veterans Affairs or the Armed Forces of
10 the United States as being:

- 11 a. a member of the United States Armed Forces on June 6,
12 1944,
- 13 b. a participant in the Allied invasion of the coast of
14 Normandy on June 6, 1944; provided, if such
15 participation cannot be verified by the United States
16 Department of Veterans Affairs or the Armed Forces of
17 the United States, the Tax Commission may, in its
18 discretion, accept evidence of such participation from
19 the person applying for the license plate, and
- 20 c. a recipient of an honorable discharge from the United
21 States Armed Forces.

22 Such person may apply for a D-Day Survivor license plate for
23 each vehicle with a rated carrying capacity of one (1) ton or less;
24

1 11. Killed in Action License Plates - such plates shall be
2 designed to honor members of the United States Armed Forces who were
3 killed in action. The spouse of the deceased person, if the spouse
4 has not remarried, or if remarried, the remarriage is terminated by
5 death, divorce, or annulment, may apply for a killed in action
6 license plate upon presenting proper certification that the person
7 was killed in action and that the person making the application is
8 the qualifying spouse of the deceased person. The qualifying spouse
9 may apply for a killed in action license plate for no more than two
10 vehicles with each vehicle with a rated carrying capacity of one (1)
11 ton or less. The fee provided by this section for the special
12 license plate authorized by this paragraph shall be in addition to
13 all other registration fees provided by law, except the registration
14 fees levied by Section 1132 of this title;

15 12. Gold Star Parents License Plates - such plates shall be
16 designed to honor members of the United States Armed Forces who were
17 killed during a war. The parents of the deceased person may apply
18 for a gold star license plate upon presenting proper certification
19 that the person was killed during a war and that the person making
20 the application is the parent of the deceased person. The parent
21 may apply for a gold star parent license plate for no more than two
22 vehicles with each vehicle having a rated carrying capacity of one
23 (1) ton or less. The fee provided by this section for the special
24 license plate authorized by this paragraph shall be in addition to

1 all other registration fees provided by law, except the registration
2 fees levied by Section 1132 of this title;

3 13. Military Decoration License Plates - such plates shall be
4 designed for any resident of this state who has been awarded the
5 Distinguished Service Medal, the Distinguished Service Cross, the
6 Distinguished Flying Cross, the Bronze Star military decoration or
7 the Silver Star military decoration. Such persons may apply for a
8 military decoration license plate for each vehicle with a rated
9 carrying capacity of one (1) ton or less;

10 14. Vietnam Veteran License Plates - such plates shall be
11 designed for honorably discharged or present members of the United
12 States Armed Forces who served in the Vietnam Conflict. Such
13 persons may apply for a Vietnam veteran license plate for each
14 vehicle with a rated carrying capacity of one (1) ton or less;

15 15. Police Officer License Plates - such plates shall be
16 designed for any currently employed, reserve or retired municipal
17 police officer or full-time, reserve or retired university police
18 officer certified by the Council on Law Enforcement Education and
19 Training or common education police officer certified by the Council
20 on Law Enforcement Education and Training. Police officers may
21 apply for police officer license plates for vehicles with a rated
22 capacity of one (1) ton or less or for a motorcycle upon proof of
23 employment by or retirement from a municipal, university or common
24 education police department by either an identification card or

1 letter from the chief of the police department or the Oklahoma
2 Police Pension and Retirement Board. Retirees who are eligible for
3 such plates shall provide proof of eligibility upon initial
4 application, but shall not be required to provide proof of
5 eligibility annually. The license plates shall be designed in
6 consultation with municipal police departments of this state;
7 provided, the license plate for motorcycles may be of similar design
8 to the license plate for motor vehicles or may be a new design in
9 order to meet space requirements for a motorcycle license plate;

10 16. World War II Veteran License Plates - such plates shall be
11 designed to honor honorably discharged former members of the United
12 States Armed Forces who are residents of this state and who can be
13 verified by the Oklahoma Military Department, the Department of
14 Veterans Affairs or the Armed Forces of the United States as having
15 served on federal active duty anytime during the period from
16 September 16, 1940, to December 7, 1945. The former members may
17 apply for a World War II Veteran license plate for vehicles with a
18 rated carrying capacity of one (1) ton or less.

19 The license plate shall have the legend "Oklahoma" and shall
20 contain, in the center of the plate, either the Thunderbird Insignia
21 of the 45th Infantry Division in the prescribed red and gold
22 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,
23 Marines or Coast Guard according to the branch of service to which
24 the member belonged. For the purpose of license plate

1 identification, the plate shall contain four digits, two digits at
2 the left and two digits at the right of the insignia or emblem.
3 Centered on the bottom of the license plate shall be the words
4 "WORLD WAR II";

5 17. Korean War Veteran License Plates - such plates shall be
6 designed to honor honorably discharged former members of the United
7 States Armed Forces who are residents of this state and who can be
8 verified by the Oklahoma Military Department, the Department of
9 Veterans Affairs or the Armed Forces of the United States as having
10 served on federal active duty anytime during the period from June
11 27, 1950, to January 31, 1955, both dates inclusive. The former
12 members may apply for a Korean War Veteran license plate for
13 vehicles with a rated carrying capacity of one (1) ton or less.

14 The license plate shall have the legend "OKLAHOMA" and shall
15 contain, in the center of the plate, either the Thunderbird Insignia
16 of the 45th Infantry Division in the prescribed red and gold
17 coloring or the emblem of the Army, Navy, Air Force, Marines or
18 Coast Guard according to the branch of service to which the member
19 belonged. For the purpose of license plate identification, the
20 plate shall contain four digits, two digits at the left and two
21 digits at the right of the insignia or emblem. Centered on the
22 bottom of the license plate shall be the word "KOREA";

23 18. Municipal Official License Plates - such plates shall be
24 designed for persons elected to a municipal office in this state and

1 shall designate the name of the municipality and the district or
2 ward in which the municipal official serves. The plates shall only
3 be produced upon application;

4 19. Red Cross Volunteer License Plates - such plates shall be
5 designed to honor American Red Cross volunteers and staff who are
6 residents of this state. Such persons must present an
7 identification card issued by the American Red Cross and bearing a
8 photograph of the person. The license plate shall be designed with
9 the assistance of the American Red Cross and shall have the legend
10 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
11 symbol of the American Red Cross and no more than three letters and
12 three numbers shall be in the color Pantone 186C Red. Below the
13 symbol and letters and numbers shall be the words "American Red
14 Cross" in black. The plates shall not be subject to the design
15 requirements of any other license plates prescribed by law other
16 than the space for the placement of the yearly decals for each
17 succeeding year of registration after the initial issue;

18 20. Desert Storm License Plates - such plates shall be designed
19 and issued to any honorably discharged or present member of the
20 United States Armed Forces who served in the Persian Gulf Crisis and
21 the Desert Storm operation. Such persons may apply for a Desert
22 Storm license plate for each vehicle with a rated carrying capacity
23 of one (1) ton or less;

24

1 21. Military Reserve Unit License Plates - such plates shall be
2 designed and issued to any honorably discharged or present member of
3 a reserve unit of the United States Armed Forces. Such persons may
4 apply for a Military Reserve Unit license plate for each vehicle
5 with a rated carrying capacity of one (1) ton or less;

6 22. Oklahoma City Bombing Victims and Survivors License Plates
7 - such plates shall be designed and issued to any victim or survivor
8 of the bombing attack on the Alfred P. Murrah Federal Building in
9 downtown Oklahoma City on April 19, 1995;

10 23. Civil Air Patrol License Plates - such plates shall be
11 designed and issued to any person who is a member of the Civil Air
12 Patrol. Such persons may apply for a Civil Air Patrol license plate
13 for each vehicle with a rated carrying capacity of one (1) ton or
14 less upon proof of membership in the Civil Air Patrol. The license
15 plate shall be designed in consultation with the Civil Air Patrol;

16 24. Ninety-Nines License Plates - such plates shall be designed
17 and issued to members of the Ninety-Nines. Persons applying for
18 such license plate must show proof of membership in the Ninety-
19 Nines. The license plates shall be designed in consultation with
20 the Ninety-Nines;

21 25. Combat Infantryman Badge License Plates - such plates shall
22 be designed to honor recipients of the Combat Infantryman Badge.
23 The plate shall have the legend "Oklahoma OK". Below the legend
24 shall be the Combat Infantryman Badge and three numbers. Below the

1 badge and the numbers shall be the words "Combat Infantryman Badge".
2 Such persons may apply for a Combat Infantryman Badge license plate
3 for each vehicle with a rated carrying capacity of one (1) ton or
4 less;

5 26. Somalia Combat Veterans License Plates - such plates shall
6 be designed and issued to any honorably discharged or present member
7 of the United States Armed Forces who saw combat in the United
8 Nations relief effort. Such persons may apply for a Somalia Combat
9 Veteran license plate for each vehicle with a rated carrying
10 capacity of one (1) ton or less;

11 27. Police Chaplain License Plates - such plates shall be
12 designed and issued to members of the International Conference of
13 Police Chaplains (ICPC) who have completed the ICPC requirements for
14 basic certification as a police chaplain. The license plates shall
15 be designed in consultation with the ICPC;

16 28. Joint Service Commendation Medal License Plates - such
17 plates shall be designed and issued to any resident of this state
18 who has been awarded the Joint Service Commendation Medal by the
19 United States Secretary of Defense;

20 29. Merchant Marine License Plates - such plates shall be
21 designed, subject to criteria to be presented to the Tax Commission
22 by the Oklahoma Department of Veterans Affairs, and issued to any
23 person who during combat was a member of the Merchant Marines as
24 certified by the Oklahoma Department of Veterans Affairs. Such

1 license plate may be issued for each vehicle with a rated carrying
2 capacity of one (1) ton or less;

3 30. Legislative License Plates - such plates shall be designed
4 for persons elected to the Oklahoma Legislature and shall designate
5 the house of the Legislature in which the legislator serves and the
6 district number;

7 31. Disabled Veterans License Plates - such plates shall be
8 designed for persons presenting proper certification from the United
9 States Department of Veterans Affairs or the Armed Forces of the
10 United States certifying such veteran has a service-connected
11 disability rating of fifty percent (50%) or more, regardless which
12 agency pays the disability benefits, or that such veteran has been
13 awarded a vehicle by the United States government or receives a
14 grant from the United States Department of Veterans Affairs for the
15 purchase of an automobile due to a service-connected disability
16 rating or due to the loss of use of a limb or an eye. Such persons
17 may apply to the Tax Commission for a disabled veterans license
18 plate or to a motor license agent for a regular license plate for no
19 more than two vehicles with each vehicle having a rated carrying
20 capacity of one (1) ton or less. The surviving spouse of any
21 deceased disabled veteran, if the spouse has not since remarried, or
22 if remarried, the remarriage is terminated by death, divorce, or
23 annulment, or a surviving spouse in receipt of Dependency and
24 Indemnity Compensation from the United States Department of Veterans

1 Affairs, may apply for a disabled veterans license plate for one
2 vehicle with a rated carrying capacity of one (1) ton or less. The
3 fee provided by this section for the special license plate
4 authorized by this paragraph shall be in addition to all other
5 registration fees provided by law, except the registration fees
6 levied by Section 1132 of this title. The total expense of this
7 license plate shall not exceed Five Dollars (\$5.00).

8 If the person qualifies for a disabled veterans license plate
9 and is also eligible for a physically disabled placard under the
10 provisions of Section 15-112 of this title, the person shall be
11 eligible to receive a disabled veterans license plate that also
12 displays the international accessibility symbol, which is a stylized
13 human figure in a wheelchair. Upon the death of the disabled
14 veteran with a disabled veterans license plate with the
15 international accessibility symbol, the plate shall be returned to
16 the Tax Commission;

17 32. United States Air Force Association License Plates - such
18 plates shall be designed for members of the United States Air Force
19 Association. Persons applying for such license plate must show
20 proof of membership in the Association. The license plates shall be
21 designed in consultation with the Association;

22 33. Oklahoma Military Academy Alumni License Plates - such
23 plates shall be designed and issued to any resident of this state
24 who is an alumnus of the Oklahoma Military Academy. Such persons

1 may apply for an Oklahoma Military Academy Alumnus license plate for
2 each vehicle with a rated carrying capacity of one (1) ton or less.
3 The license plates shall be designed in consultation with the
4 Oklahoma Military Academy and shall contain the shield of the
5 Academy;

6 34. Amateur Radio Operator License Plates - such plates shall
7 be designed and issued to any person, holding a valid operator's
8 license, technician class or better, issued by the Federal
9 Communications Commission, and who is also the owner of a motor
10 vehicle currently registered in Oklahoma, in which has been
11 installed amateur mobile transmitting and receiving equipment.
12 Eligible persons shall be entitled to two special vehicle
13 identification plates as herein provided. Application for such
14 identification plates shall be on a form prescribed by the Tax
15 Commission and the plates issued to such applicant shall have
16 stamped thereon the word "Oklahoma" and bear the official call
17 letters of the radio station assigned by the Federal Communications
18 Commission to the individual amateur operator thereof. All
19 applications for such plates must be made to the Tax Commission on
20 or before the first day of October of any year for such plates for
21 the following calendar year and must be accompanied by the fee
22 required in this section together with a certificate, or such other
23 evidence as the Tax Commission may require, of proof that applicant
24 has a valid technician class or better amateur operator's license

1 and proof of applicant's ownership of a vehicle in which radio
2 receiving and transmitting equipment is installed. Applicants shall
3 only be entitled to one set of special identification plates in any
4 one (1) year, and such calendar year shall be stamped thereon. The
5 right to such special identification plates herein provided for
6 shall continue until the amateur radio operator's license of the
7 person to whom such plates are issued expires or is revoked;

8 35. American Legion License Plates - such plates shall be
9 designed for members of the American Legion. Persons applying for
10 such license plate must show proof of membership. The license
11 plates shall be designed in consultation with the American Legion of
12 Oklahoma;

13 36. Deputy Sheriff License Plates - such plates shall be
14 designed for any currently employed or retired county sheriff or
15 deputy sheriff. County sheriffs or deputy sheriffs may apply for
16 such plates for vehicles with a rated capacity of one (1) ton or
17 less upon proof of employment by or retirement from a county
18 sheriff's office by either an identification card or letter from the
19 county sheriff or a government-sponsored retirement board from which
20 the county sheriff or deputy sheriff may be receiving a pension.
21 Retirees who are eligible for such plates shall provide proof of
22 eligibility upon initial application, but shall not be required to
23 provide proof of eligibility annually. The license plates shall be
24

1 designed in consultation with the county sheriff offices of this
2 state;

3 37. Gold Star Surviving Spouse License Plates - such plates
4 shall be designed to honor the surviving spouses and children of
5 qualified veterans. As used in this paragraph, "qualified veteran"
6 shall mean:

7 a. any person honorably discharged from any branch of the
8 United States Armed Forces or as a member of the
9 Oklahoma National Guard, who died as a direct result
10 of the performance of duties for any branch of the
11 United States Armed Forces or Oklahoma National Guard
12 while on active military duty, or

13 b. any person honorably discharged from any branch of the
14 United States Armed Forces or as a member of the
15 Oklahoma National Guard, who died as a result of
16 injury, illness or disease caused by the performance
17 of such duties while on active duty, whether the death
18 occurred while on active duty or after the honorable
19 discharge of such person.

20 The fee provided by this section for the special license plate
21 authorized by this paragraph shall be in addition to all other
22 registration fees provided by law, except the registration fees
23 levied by Section 1132 of this title;
24

1 38. Korea Defense Service Medal License Plates - such plates
2 shall be designed and issued to any resident of this state who has
3 been awarded the Korea Defense Service Medal by the United States
4 Secretary of Defense. Such persons may apply for a Korea Defense
5 Service Medal license plate for each vehicle with a rated carrying
6 capacity of one (1) ton or less;

7 39. 180th Infantry License Plates - such plates shall be
8 designed for members and prior members of the 180th Infantry.
9 Persons applying for such license plate must obtain and provide
10 proof of their membership from the 180th Infantry Association. The
11 license plates shall be designed in consultation with the 180th
12 Infantry;

13 40. Operation Iraqi Freedom Veteran License Plates - such
14 plates shall be designed and issued to any honorably discharged or
15 present member of the United States Armed Forces who served in
16 Operation Iraqi Freedom. Such person may apply for an Operation
17 Iraqi Freedom Veteran license plate for each vehicle with a rated
18 carrying capacity of one (1) ton or less, or for a motorcycle;
19 provided, the license plate for motorcycles may be of similar design
20 to the license plate for motor vehicles or may be a new design in
21 order to meet space requirements for a motorcycle license plate;

22 41. United States Air Force Academy Alumni License Plates -
23 such plates shall be designed and issued to any resident of this
24 state who is an alumnus of the United States Air Force Academy.

1 Such persons may apply for a United States Air Force Academy Alumnus
2 license plate for each vehicle with a rated carrying capacity of one
3 (1) ton or less;

4 42. Operation Enduring Freedom Veteran License Plate - such
5 plates shall be designed and issued to any honorably discharged or
6 present member of the United States Armed Forces who served in
7 Operation Enduring Freedom on or after September 11, 2001. The
8 license plate shall be designed in consultation with the Military
9 Department of the State of Oklahoma. Such person may apply for an
10 Operation Enduring Freedom Veteran license plate for each vehicle
11 with a rated carrying capacity of one (1) ton or less, or for a
12 motorcycle; provided, the license plate for motorcycles may be of
13 similar design to the license plate for motor vehicles or may be a
14 new design in order to meet space requirements for a motorcycle
15 license plate;

16 43. Military Multi-Decoration License Plate - such plates shall
17 be designed and issued to any honorably discharged or present member
18 of the United States Armed Forces who qualifies for more than one
19 military decoration license plate pursuant to the provisions of this
20 section. The Tax Commission shall develop and implement a system
21 whereby the designs of the eligible license plates can be included
22 together on a single license plate. Such person may apply for a
23 Military Multi-Decoration license plate for each vehicle with a
24 rated carrying capacity of one (1) ton or less;

1 44. Global War on Terror Expeditionary License Plate - such
2 plates shall be designed and issued to any honorably discharged or
3 present member of the United States Armed Forces who has earned a
4 Global War on Terror Expeditionary decoration. The license plate
5 shall be designed in consultation with the United States Institute
6 of Heraldry and the Military Department of the State of Oklahoma.
7 Such person may apply for a Global War on Terror Expeditionary
8 license plate for each vehicle with a rated carrying capacity of one
9 (1) ton or less;

10 45. Legion of Merit Medal Recipient License Plates - such
11 plates shall be designed for any resident of this state presenting
12 proper certification from the United States Department of Veterans
13 Affairs or the Armed Forces of the United States certifying that
14 such resident has been awarded the Legion of Merit military
15 decoration. Such persons may apply for a Legion of Merit recipient
16 license plate for vehicles having a rated carrying capacity of one
17 (1) ton or less. The license plate shall be designed in
18 consultation with the Military Department of the State of Oklahoma;

19 46. 1-179th License Plates - such plates shall be designed for
20 members, prior members and members of the household of a member or
21 former member of the 1-179th Infantry. Persons applying for such
22 license plate must obtain and provide proof of their membership
23 association with the 1-179th Infantry Association. The license
24 plate shall be designed in consultation with the 1-179th Infantry;

1 47. 2-179th License Plates - such plates shall be designed for
2 members, prior members and members of the household of a member or
3 former member of the 2-179th Infantry. Persons applying for such
4 license plate must obtain and provide proof of their membership
5 association with the 2-179th Infantry Association. The license
6 plate shall be designed in consultation with the 2-179th Infantry;

7 48. Combat Action Ribbon Recipient License Plates - such plates
8 shall be designed to honor recipients of the Combat Action Ribbon
9 who present proper certification from the United States Department
10 of the Navy. The license plate shall include the Combat Action
11 Ribbon earned by the recipient. Such persons may apply for a Combat
12 Action Ribbon Recipient license plate for vehicles having a rated
13 carrying capacity of one (1) ton or less;

14 49. Oklahoma Submarine Veterans License Plate - such plates
15 shall be designed for any resident of this state who is a United
16 States submarine veteran and presents either a Department of Defense
17 form 214 or other documentation certifying such service. Such
18 persons may apply for an Oklahoma Submarine Veterans license plate
19 for vehicles having a rated capacity of one (1) ton or less. The
20 license plate design shall include both gold and silver dolphins to
21 represent both officer and enlisted service members;

22 50. United States Navy Seabees and Civil Engineer Corps License
23 Plate - such plates shall be designed and issued to any honorably
24 discharged or present member of the United States Navy Seabees or

1 Civil Engineer Corps. Such persons may apply for a United States
2 Navy Seabees and Civil Engineer Corps license plate for vehicles
3 having a rated carrying capacity of one (1) ton or less. The
4 license plate shall be designed in consultation with the Military
5 Department of the State of Oklahoma;

6 51. Combat Action Badge Recipient License Plate - such plates
7 shall be designed to honor recipients of the Combat Action Badge who
8 present proper certification from the United States Army. The
9 license plate shall include the Combat Action Badge earned by the
10 recipient. Such persons may apply for a Combat Action Badge
11 Recipient license plate for vehicles having a rated carrying
12 capacity of one (1) ton or less, or for a motorcycle; provided, the
13 license plate for motorcycles may be of similar design to the
14 license plate for motor vehicles or may be a new design in order to
15 meet space requirements for a motorcycle license plate;

16 52. Iraq Combat Veteran License Plate - such plates shall be
17 designed and issued to any honorably discharged or present member of
18 the United States Armed Forces who saw combat in Operation Iraqi
19 Freedom. Such persons may apply for an Iraq Combat Veteran license
20 plate for each vehicle with a rated carrying capacity of one (1) ton
21 or less, or for a motorcycle; provided, the license plate for
22 motorcycles may be of similar design to the license plate for motor
23 vehicles or may be a new design in order to meet space requirements
24 for a motorcycle license plate;

1 53. Afghanistan Combat Veteran License Plate - such plates
2 shall be designed and issued to any honorably discharged or present
3 member of the United States Armed Forces who saw combat in Operation
4 Enduring Freedom. Such persons may apply for an Afghanistan Combat
5 Veteran license plate for each vehicle with a rated carrying
6 capacity of one (1) ton or less, or for a motorcycle; provided, the
7 license plate for motorcycles may be of similar design to the
8 license plate for motor vehicles or may be a new design in order to
9 meet space requirements for a motorcycle license plate; and

10 54. Special Forces Association License Plates - such plates
11 shall be designed and issued to any honorably discharged or present
12 member of the Army Special Forces qualified and authorized to wear
13 upon the person's United States military uniform the Army Special
14 Forces Tab. Persons applying for the Special Forces Association
15 license plate must provide a copy of the orders awarding the Special
16 Forces Tab or authorizing its wear upon a United States military
17 uniform. The license plate shall be designed in consultation with
18 the Special Forces Association, Chapter 32-50. The Tax Commission
19 shall produce up to two distinct designs for the Special Forces
20 Association license plate. Qualified persons may select one design
21 at the time of application. The plates shall be issued to any
22 qualified person in any combination of numbers and letters from one
23 to a maximum of seven, as for personalized license plates.

1 C. Unless otherwise provided by this section, the fee for such
2 plates shall be Eight Dollars (\$8.00) and shall be in addition to
3 all other registration fees provided by the Oklahoma Vehicle License
4 and Registration Act. Such fees shall be deposited in the Oklahoma
5 Tax Commission Reimbursement Fund to be used for the administration
6 of the Oklahoma Vehicle License and Registration Act.

7 SECTION 4. AMENDATORY 47 O.S. 2011, Section 1135.3, as
8 last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
9 2020, Section 1135.3), is amended to read as follows:

10 Section 1135.3. A. The Oklahoma Tax Commission is hereby
11 authorized to design and issue appropriate official special license
12 plates to persons wishing to demonstrate support, interest, or
13 membership to or for an organization, occupation, cause or other
14 subject as provided by this section.

15 Special license plates shall not be transferred to any other
16 person but shall be removed from the vehicle upon transfer of
17 ownership and retained. The special license plate may then be used
18 on another vehicle but only after such other vehicle has been
19 registered for the current year.

20 Special license plates shall be renewed each year by the Tax
21 Commission or a motor license agent, unless authorized by the Tax
22 Commission to be renewed for a period greater than one (1) year.
23 The Tax Commission shall notify by mail all persons issued special
24 license plates. The notice shall contain all necessary information

1 and shall contain instructions for the renewal procedure upon
2 presentation to a motor license agent or the Tax Commission. The
3 license plates shall be issued on a staggered system.

4 If a special license plate is issued pursuant to this section,
5 any registration fee required for such plate and the fee required
6 pursuant to subsection A of Section 1132 of this title shall be
7 remitted at the same time and subject to a single registration
8 period. The Oklahoma Tax Commission shall promulgate rules
9 establishing a method for making required fee adjustments when a
10 special license plate is obtained during a twelve-month period for
11 which a registration fee has already been remitted pursuant to this
12 subsection. The combination of fees in a single remittance shall
13 not alter the apportionment otherwise provided for by law.

14 The Tax Commission is hereby directed to develop and implement a
15 system whereby motor license agents are permitted to accept
16 applications for special license plates authorized under this
17 section. The motor license agent shall confirm the applicant's
18 eligibility, if applicable, collect and deposit any amount
19 specifically authorized by law, accept and process the necessary
20 information directly into such system and generate a receipt
21 accordingly. For performance of these duties, motor license agents
22 shall retain the fee provided in Section 1141.1 of this title for
23 registration of a motor vehicle. The motor license agent fees for
24

1 acceptance of applications and renewals shall be paid out of the
2 Oklahoma Tax Commission Reimbursement Fund.

3 If fewer than one hundred of any type of special license plates
4 authorized prior to January 1, 2004, are issued prior to January 1,
5 2006, the Tax Commission shall discontinue issuance and renewal of
6 that type of special license plate. Any such authorized special
7 license plate registrant shall be allowed to display the license
8 plate upon the designated vehicle until the registration expiration
9 date. After such time the expired special license plate shall be
10 removed from the vehicle.

11 Except as otherwise provided in law, for special license plates
12 authorized on or after July 1, 2004, no special license plates shall
13 be developed or issued by the Tax Commission until the Commission
14 receives one hundred (100) prepaid applications therefor. The
15 prepaid applications must be received by the Tax Commission within
16 one hundred eighty (180) days of the effective date of the
17 authorization or the authority to issue shall be null and void. In
18 the event one hundred (100) prepaid applications are not received by
19 the Tax Commission within such prescribed time period any payment so
20 received shall be refunded accordingly.

21 B. The special license plates provided by this section are as
22 follows:

23

1 1. Round and Square Dance License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 round and square dancing;

4 2. National Association for the Advancement of Colored People
5 License Plate - such plates shall be designed, subject to the
6 criteria to be presented to the Tax Commission by the NAACP, and
7 issued to any person wishing to demonstrate support for the NAACP;

8 3. National Rifle Association License Plate - such plates shall
9 be designed, subject to the criteria to be presented to the Tax
10 Commission by the National Rifle Association, and issued to any
11 person wishing to demonstrate support for the National Rifle
12 Association;

17 carrying capacity of one (1) ton or less upon proof of a Masonic
18 Fraternity membership or upon the presentment of an application for
19 a Masonic Fraternity license plate authorized and approved by the
20 Grand Lodge of Oklahoma. The license plates shall be designed in
21 consultation with the Masonic Fraternities of Oklahoma and shall
22 contain the Masonic emblem;

23 5. Shriner's Hospitals for Burned and Crippled Children License
24 Plate - such plates shall be designed to demonstrate support for

1 Shriner's Hospitals for Burned and Crippled Children and shall be
2 issued to any resident of this state who is a member of a Shriner's
3 Temple in Oklahoma. The license plate shall be designed in
4 consultation with the Shriner's Temples in Oklahoma and shall
5 contain the Shriner's emblem;

6 6. Balloonists License Plate - such plates shall be designed
7 and issued to any person wishing to demonstrate support for hot air
8 ballooning in this state;

9 7. Order of the Eastern Star License Plate - such plates shall
10 be designed and issued to any resident of this state who is a member
11 of an Order of the Eastern Star. Such persons may apply for an
12 Order of the Eastern Star license plate for each vehicle with a
13 rated carrying capacity of one (1) ton or less upon proof of an
14 Order of the Eastern Star membership or upon the presentment of an
15 application for an Order of the Eastern Star license plate
16 authorized and approved by the organization. The license plate
17 shall be designed in consultation with the Order of the Eastern Star
18 and shall contain the Order of the Eastern Star emblem;

19 8. Knights of Columbus License Plate - such plates shall be
20 designed and issued to any resident of this state who is a member of
21 the Knights of Columbus. Such persons may apply for a Knights of
22 Columbus license plate for each vehicle with a rated carrying
23 capacity of one (1) ton or less upon proof of a Knights of Columbus
24 membership or upon the presentment of an application for a Knights

1 of Columbus license plate authorized and approved by the
2 organization. The license plate shall be designed in consultation
3 with the Knights of Columbus and shall contain the Knights of
4 Columbus emblem;

5 9. Jaycees License Plate - such plates shall be designed and
6 issued to members of the Jaycees. Persons applying for such license
7 plate must show proof of membership in the Jaycees. The license
8 plates shall be designed in consultation with the Jaycees;

9 10. Kiwanis International License Plate - such plates shall be
10 designed and issued to members of Kiwanis International. Persons
11 applying for such license plate must show proof of membership in
12 Kiwanis International. The license plates shall be designed in
13 consultation with Kiwanis International;

14 11. Certified Public Accountants License Plate - such plates
15 shall be designed and issued to any resident of this state who is a
16 Certified Public Accountant. Such persons may apply for a Certified
17 Public Accountant license plate for each vehicle with a rated
18 carrying capacity of one (1) ton or less upon proof of status as a
19 Certified Public Accountant. The license plates shall be designed
20 in consultation with the Oklahoma Society of Certified Public
21 Accountants;

22 12. Civil Emergency Management License Plate - such plates
23 shall be designed and issued to persons wishing to demonstrate
24 support for the state civil emergency management system. Persons

1 applying for such license plate must show proof of official
2 affiliation by presenting a nonexpired proof of employment,
3 affiliation or retirement in the form of an identification card or
4 letter on official letterhead from a municipal, county or state
5 emergency management department head;

6 13. Civilian Conservation Corps License Plate - such plates
7 shall be designed, subject to criteria to be presented to the Tax
8 Commission, by the Civilian Conservation Corps Association, and
9 issued to any person wishing to demonstrate support of the Civilian
10 Conservation Corps;

11 14. Rotarian License Plate - such plates shall be designed and
12 issued to any resident of this state who is a member of a Rotarian
13 Club of Oklahoma. Such persons may apply for a Rotarian license
14 plate for each vehicle with a rated carrying capacity of one (1) ton
15 or less upon proof of a Rotarian Club membership or upon the
16 presentment of an application for a Rotarian license plate
17 authorized and approved by a Rotarian Club of Oklahoma. The license
18 plates shall be designed in consultation with the five Rotarian
19 District Governors and shall contain the Rotarian emblem;

20 15. Benevolent Protective Order of Elks License Plate - such
21 plates shall be designed, subject to criteria to be presented to the
22 Tax Commission, by the Benevolent Protective Order of Elks, and
23 issued to any resident of this state who is a member of the
24 Benevolent Protective Order of Elks;

1 16. Humane Society License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the Humane Society of the United States. The plates shall be issued
4 to any person in any combination of numbers and letters from one to
5 a maximum of seven, as for personalized license plates. The plate
6 shall contain the official Humane Society logo;

7 17. Oklahoma Mustang Club License Plate - such plates shall be
8 designed, subject to criteria to be presented to the Tax Commission,
9 by the Oklahoma Mustang Club, and issued to any resident of this
10 state who is a member of the Oklahoma Mustang Club. Such persons
11 may apply for an Oklahoma Mustang Club license plate upon
12 presentment of proof of membership in the Oklahoma Mustang Club.
13 The plates shall be issued to any person in any combination of
14 numbers and letters from one to a maximum of seven, as for
15 personalized license plates;

16 18. American Business Clubs (AMBUCS) License Plate - such
17 plates shall be designed and issued to members of American Business
18 Clubs. Persons applying for such license plate must show proof of
19 membership in AMBUCS. The license plates shall be designed in
20 consultation with American Business Clubs;

21 19. West Point 200th Anniversary License Plate - such plates
22 shall be designed and issued to any person wishing to commemorate
23 the Two Hundredth Anniversary of the founding of the United States
24 Military Academy at West Point, New York. The license plates shall

1 be designed in consultation with the West Point Society of Central
2 Oklahoma;

3 20. Oklahoma Aquarium License Plate - such plates shall be
4 designed and issued to persons wishing to demonstrate support for
5 the Oklahoma Aquarium. The license plates shall be designed in
6 consultation with the Oklahoma Aquarium;

7 21. The Pride of Broken Arrow License Plate - such plates shall
8 be designed and issued to any person wishing to demonstrate support
9 for The Pride of Broken Arrow marching band. The plates shall be
10 designed in consultation with the Broken Arrow Public School System;

11 22. Fellowship of Christian Athletes License Plate - such
12 plates shall be designed in consultation with the Fellowship of
13 Christian Athletes and issued to members and supporters of the
14 Fellowship of Christian Athletes;

15 23. Parrothead Club License Plate - such plates shall be
16 designed and issued to members and supporters of the Parrothead
17 Club. The license plate shall be issued to any person in any
18 combination of numbers and letters from one to a maximum of seven as
19 for personalized license plates;

20 24. Oklahoma Bicycling Coalition License Plate - such plates
21 shall be designed and issued to any person who is a member of the
22 Oklahoma Bicycling Coalition. The license plates shall be designed
23 in consultation with the Oklahoma Bicycling Coalition;

24

1 25. Electric Lineman License Plate - such plates shall be
2 designed and issued to persons wishing to demonstrate support for
3 Oklahoma's electric linemen. The license plates shall be designed
4 in consultation with the Oklahoma Electric Superintendent's
5 Association;

6 26. Alpha Kappa Alpha License Plate - such plates shall be
7 designed and issued to any person who is a member of Alpha Kappa
8 Alpha Sorority. The license plates shall be designed in
9 consultation with the Oklahoma Chapter of Alpha Kappa Alpha
10 Sorority;

11 27. The National Pan-Hellenic Council Incorporated License
12 Plate - such plates shall be designed and issued to any person
13 wishing to demonstrate support to any of the nine sororities and
14 fraternities recognized by the National Pan-Hellenic Council
15 Incorporated. The license plates shall be designed in consultation
16 with the Oklahoma Chapter of the National Pan-Hellenic Council
17 Incorporated;

18 28. Organ, Eye and Tissue License Plate - such plates shall be
19 designed and issued to persons wishing to demonstrate support and
20 increase awareness for organ, eye and tissue donation. The license
21 plates shall be designed in consultation with the State Department
22 of Health;

23 29. Central Oklahoma Habitat for Humanity License Plate - such
24 plates shall be designed and issued to persons wishing to

1 demonstrate support and increase awareness for Habitat for Humanity.
2 The license plate shall be designed in consultation with Central
3 Oklahoma Habitat for Humanity;

4 30. Family Career and Community Leaders of America Incorporated
5 License Plate - such plates shall be designed and issued to persons
6 wishing to demonstrate support for Family Career and Community
7 Leaders of America Incorporated. The license plates shall be

1 34. 50th Anniversary of the Interstate System of Highways
2 License Plate - such plates shall be designed and issued to persons
3 wishing to commemorate the 50th Anniversary of the Interstate System
4 of Highways. The license plates shall be designed in consultation
5 with the American Association of State Highway and Transportation
6 Officials;

7 35. Kappa Alpha Psi License Plate - such plates shall be
8 designed and issued to any person who is a member of Kappa Alpha Psi
9 Fraternity. The license plates shall be designed in consultation
10 with the Oklahoma Chapter of Kappa Alpha Psi Fraternity
11 Incorporated;

12 36. Sigma Gamma Rho License Plate - such plates shall be
13 designed and issued to any person who is a member of Sigma Gamma Rho
14 Sorority. The license plates shall be designed in consultation with

16 Subject to the provisions of subsection A of this section, the Sigma

22 shall be designed in consultation with the Oklahoma Chapter of the

1 38. Frederick Douglass High School License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for Frederick Douglass High School located in Oklahoma City.
4 The plates shall be designed in consultation with representatives of

6 39. United States Air Force Academy License Plate - such plates
7 shall be designed and issued to any person wishing to demonstrate

9 40. In God We Trust License Plate - such plates shall be

11 issued to any person wishing to demonstrate support for the motto;

12 41. National Weather Center License Plate - such plates shall

9 designed and issued to any person wishing to increase awareness of
10 autism. The license plate shall be designed in consultation with

13 be designed and issued to any person wishing to demonstrate support
14 for the Oklahoma Blood Institute. The license plates shall be
15 designed in consultation with the Oklahoma Blood Institute;

16 47. Zeta Phi Beta and Phi Beta Sigma License Plate - such
17 plates shall be designed and issued to any person who is a member of
18 Zeta Phi Beta Sorority or Phi Beta Sigma Fraternity. The license
19 plates shall be designed in consultation with the Oklahoma chapters
20 of Zeta Phi Beta Sorority Incorporated and Phi Beta Sigma Fraternity
21 Incorporated;

22 48. Star Spencer High School License Plate - such plates shall
23 be designed and issued to any person wishing to demonstrate support
24 for Star Spencer High School located in Oklahoma City. The plates

1 shall be designed in consultation with representatives of the Star
2 Spencer High School Alumni Association. Subject to the provisions
3 of subsection A of this section, the Star Spencer High School
4 License Plate is hereby reauthorized effective November 1, 2015;

5 49. Northeast High School License Plate - such plates shall be
6 designed and issued to any person wishing to demonstrate support for
7 Northeast High School located in Oklahoma City. The plates shall be
8 designed in consultation with representatives of the Northeast High
9 School Alumni Association;

10 50. Oklahoma City Central High School License Plate - such
11 plates shall be designed and issued to any person wishing to
12 demonstrate support for the Oklahoma City Central High School Alumni
13 Association. The plates shall be designed in consultation with
14 representatives of the Oklahoma City Central High School Alumni
15 Association;

16 51. Oklahoma Rifle Association License Plate - such plates
17 shall be designed and issued to any person wishing to demonstrate
18 support for the Oklahoma Rifle Association. The plates shall be

10 plate shall be designed in consultation with the Sunbelt Chapter of
11 the BMW Car Club of America. Subject to the provisions of
12 subsection A of this section, the BMW Car Club of America License
13 Plate is hereby reauthorized effective November 1, 2013;

14 55. Don't Tread On Me License Plate - such plates shall be
15 designed to include the yellow background and rattlesnake emblem
16 above the motto "DON'T TREAD ON ME" as found on the historic Gadsden
17 flag, and shall be issued to any person wishing to demonstrate
18 support for the freedom and liberty of the Republic;

19 56. Oklahomans for the Arts License Plate - such plates shall
20 be designed and issued to any person wishing to demonstrate support
21 for arts, culture and creative industries as well as arts education.
22 The plates shall be designed in consultation with Oklahomans for the
23 Arts;

1 57. Oklahoma City Barons License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the Oklahoma City Barons. The license plate shall be designed in
4 consultation with the Oklahoma City Barons organization. The
5 license plates shall be issued to any person in any combination of
6 numbers and letters from one to a maximum of six;

7 58. Oklahoma City Redhawks License Plate - such plates shall be
8 designed and issued to any person wishing to demonstrate support for
9 the Oklahoma City Redhawks. The license plate shall be designed in
10 consultation with the Oklahoma City Redhawks organization;

11 59. Tulsa Shock License Plate - such plates shall be designed
12 and issued to any person wishing to demonstrate support for the
13 Tulsa Shock. The license plate shall be designed in consultation
14 with the Tulsa Shock organization;

15 60. Tulsa Oilers License Plate - such plates shall be designed
16 and issued to any person wishing to demonstrate support for the
17 Tulsa Oilers. The license plate shall be designed in consultation
18 with the Tulsa Oilers organization;

19 61. Tulsa Drillers License Plate - such plates shall be
20 designed and issued to any person wishing to demonstrate support for
21 the Tulsa Drillers. The license plate shall be designed in
22 consultation with the Tulsa Drillers organization;

23 62. Millwood School District License Plate - such plates shall
24 be designed and issued to any person wishing to demonstrate support

1 for the Millwood School District. The license plate shall be

5 plates shall be issued to persons wishing to demonstrate support for

10 shall be designed to include the current Oklahoma state flag and
11 issued to any person wishing to demonstrate support for the current
12 Oklahoma state flag. The plates shall be designed in consultation
13 with the Friends of the Oklahoma History Center;

14 65. Oklahoma Original State Flag License Plate - such plates
15 shall be designed to include the original Oklahoma state flag and
16 issued to any person wishing to demonstrate support for the original
17 Oklahoma state flag. The plates shall be designed in consultation
18 with the Friends of the Oklahoma History Center. The plates shall
19 be issued to any person in any combination of numbers and letters
20 from one to a maximum of seven, as for personalized plates. Subject
21 to the provisions of subsection A of this section, the Oklahoma
22 Original State Flag license plate is hereby reauthorized effective
23 November 1, 2015;

1 66. Tulsa 66ers License Plate - such plates shall be designed
2 and issued to any person wishing to demonstrate support for the
3 Tulsa 66ers. The plates shall be designed in consultation with the
4 Tulsa 66ers Organization;

5 67. Frederick Bombers License Plate - such plates shall be
6 issued to persons wishing to demonstrate support for the Frederick
7 School District and shall be designed in consultation with
8 representatives of the Frederick School District;

9 68. 911 Dispatcher License Plate - such plates shall be issued
10 to persons wishing to demonstrate support for 911 dispatchers.
11 Persons applying for such license plate must show proof of current
12 employment as a 911 dispatcher or sign an attestation that they are
13 a currently employed or retired 911 dispatcher;

14 69. Oklahoma Fosters License Plate - such plates shall be
15 issued to persons wishing to demonstrate support for the Oklahoma
16 Fosters Initiative and shall be designed in consultation with the
17 Oklahoma Fosters Initiative;

18 70. Red Dirt Jeeps License Plate - such plates shall be
19 designed and issued to any person wishing to demonstrate support for
20 Red Dirt Jeeps and such plates shall be designed in consultation
21 with Red Dirt Jeeps, L.L.C.;

22 71. Sons of the American Revolution License Plate - such plates
23 shall be issued to persons wishing to demonstrate support for the
24 Sons of the American Revolution for a vehicle or motorcycle in any

1 combination of numbers and letters from one to a maximum of seven,
2 as for personalized plates. Such plates shall be designed in
3 consultation with the Oklahoma Society of the Sons of the American
4 Revolution. The license plate for a motorcycle may be of similar
5 design as space permits or a new design in order to meet the space
6 requirements of a motorcycle license plate;

7 72. Daughters of the American Revolution License Plate - such
8 plates shall be issued to persons wishing to demonstrate support for
9 the Daughters of the American Revolution for a vehicle or motorcycle
10 in any combination of numbers and letters from one to a maximum of
11 seven, as for personalized plates. Such plates shall be designed in
12 consultation with the Oklahoma Society of the Daughters of the
13 American Revolution. The license plate for a motorcycle may be of
14 similar design as space permits or a new design in order to meet the
15 space requirements of a motorcycle license plate;

16 73. Air Medal License Plate - such plates shall be designed and
17 issued to Air Medal recipients. An individual requesting the plate
18 is required, at the time of application, to show proof he or she is
19 a recipient of the Air Medal or sign an attestation stating that he
20 or she is a medal recipient. The plates shall be designed to
21 include the Air Medal emblem and shall include the words "Air Medal"
22 on the plate;

23 74. Oklahoma Institute for Child Advocacy License Plate - such
24 plates shall be designed and issued to any person wishing to

1 demonstrate support for the Oklahoma Institute for Child Advocacy.
2 The plates shall be issued to any person in any combination of
3 numbers and letters from one to a maximum of seven, as for
4 personalized license plates. The plates shall contain the official
5 Oklahoma Institute for Child Advocacy logo;

6 75. The Pride of Oklahoma Marching Band License Plate - such
7 plates shall be designed and issued to any person wishing to
8 demonstrate support for the Pride of Oklahoma marching band. The
9 plates shall be designed in consultation with the University of
10 Oklahoma;

11 76. The Spirit of Oklahoma State Marching Band License Plate -
12 such plates shall be designed and issued to any person wishing to
13 demonstrate support for the Spirit of Oklahoma State marching band.
14 The plates shall be designed in consultation with Oklahoma State
15 University;

16 77. Southeast Spartans License Plate - such plates shall be
17 designed and issued to any person wishing to demonstrate support for
18 Southeast High School Spartans and such plates shall be designed in
19 consultation with the Southeast High School Alumni Association;

20 78. Catoosa High School License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 Catoosa High School located in Catoosa. The plates shall bear the
23 image of the Catoosa High School mascot and be designed in
24 consultation with representatives of Catoosa High School;

1 79. Toastmasters International License Plate - such plates
2 shall be issued to persons wishing to demonstrate support for
3 Toastmasters International and shall be designed in consultation
4 with District 16 of Toastmasters International;

5 80. Millwood High School Alumni License Plate - such plates
6 shall be designed and issued to any person wishing to demonstrate
7 support for Millwood High School Alumni. The license plate shall be
8 designed in consultation with representatives of the Millwood High
9 School Alumni Association;

10 81. Patriot Guard Riders License Plate - such plates shall be
11 issued to persons wishing to demonstrate support for Patriot Guard
12 Riders and shall be designed in consultation with the Patriot Guard
13 Riders of Oklahoma; and

14 82. Bixby School District License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 the Bixby School District. The license plate shall be designed in
17 consultation with representatives of the Bixby School District.

18 C. The fee for such plates shall be Fifteen Dollars (\$15.00)
19 per year of renewal and shall be in addition to all other
20 registration fees provided by the Oklahoma Vehicle License and
21 Registration Act. Unless otherwise provided in this section, the
22 fee shall be apportioned as follows: Eight Dollars (\$8.00) per year
23 of renewal of the special license plate fee shall be deposited in
24 the Oklahoma Tax Commission Reimbursement Fund to be used for the

1 administration of the Oklahoma Vehicle License and Registration Act
2 and the remaining Seven Dollars (\$7.00) per year of renewal of the
3 special license plate fee shall be apportioned as provided in
4 Section 1104 of this title.

5 SECTION 5. AMENDATORY 47 O.S. 2011, Section 1135.4, as
6 amended by Section 3, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,
7 Section 1135.4), is amended to read as follows:

8 Section 1135.4. A. The Oklahoma Tax Commission is hereby
9 authorized to design and issue personalized license plates. The
10 personalized license plates shall be issued on a staggered system
11 except for vintage decals.

12 Personalized special license plates shall not be transferred to
13 any other person but shall be removed from the vehicle upon transfer
14 of ownership and retained. The personalized special license plate
15 may then be used on another vehicle but only after such other
16 vehicle has been registered for the current year.

17 Personalized special license plates shall be renewed each year
18 by the Tax Commission or a motor license agent, unless authorized by
19 the Tax Commission to be renewed for a period greater than one (1)
20 year. The Tax Commission shall notify by mail all persons issued
21 special license plates. The notice shall contain all necessary
22 information and shall contain instructions for the renewal procedure
23 upon presentation to a motor license agent or the Tax Commission.

2 Oklahoma Tax Commission Reimbursement Fund.

3 If a personalized license plate is issued pursuant to this
4 section, any registration fee required for such plate and the fee
5 required pursuant to subsection A of Section 1132 of this title
6 shall be remitted at the same time and subject to a single
7 registration period. The Oklahoma Tax Commission shall promulgate
8 rules establishing a method for making required fee adjustments when
9 a personalized license plate is obtained during a twelve-month
10 period for which a registration fee has already been remitted
11 pursuant to this subsection. The combination of fees in a single
12 remittance shall not alter the apportionment otherwise provided for
13 by law.

14 B. Such plates shall be designed and issued for the following:

15 1. Any person in any combination of numbers or letters from one
16 to a maximum of seven;

17 2. Persons eligible for two or more of the military decoration
18 special license plates provided for in this title. Such plates may
19 be issued in any combination of emblems. However, such plates shall
20 only display up to three emblems and shall also display any
21 combination of letters or numbers from one to a maximum of three;

22 3. Motorcycles in any combination of numbers or letters from
23 one to a maximum of six;
24

1 4. Persons eligible for Korean War Veteran license plates
2 provided for in this title. Such plates may display any combination
3 of letters or numbers up to three on each side of the insignia or
4 emblem;

5 5. Persons eligible for World War II Veteran license plates
6 provided for in this title. Such plates may display any combination
7 of letters or numbers up to three on each side of the insignia or
8 emblem; and

9 6. Persons owning vehicles which are twenty-one (21) years and
10 older are qualified to submit for approval by the Tax Commission or
11 a motor license agent a vintage but expired official Oklahoma
12 license plate which is twenty-one (21) years and older. Upon
13 approval of such personalized plate, the owner shall be issued the
14 annual registration decal which the Tax Commission or agent shall
15 direct to be affixed.

16 C. The fee for such plates shall be Twenty Dollars (\$20.00) per
17 year of renewal and shall be in addition to all other registration
18 fees provided by the Oklahoma Vehicle License and Registration Act.
19 Eight Dollars (\$8.00) per year of renewal of the personalized tag
20 fee shall be deposited in the Oklahoma Tax Commission Reimbursement
21 Fund to be used for the administration of the Oklahoma Vehicle
22 License and Registration Act. Twelve Dollars (\$12.00) per year of
23 renewal of the personalized tag fee shall be apportioned as provided
24 in Section 1104 of this title.

1 SECTION 6. AMENDATORY 47 O.S. 2011, Section 1135.5, as
2 last amended by Section 3, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
3 2020, Section 1135.5), is amended to read as follows:

4 Section 1135.5. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support and provide
7 financial assistance as provided by this section.

8 Special license plates shall not be transferred to any other
9 person but shall be removed from the vehicle upon transfer of
10 ownership and retained. The special license plate may then be used
11 on another vehicle but only after such other vehicle has been
12 registered for the current year with a motor license agent.

13 Special license plates shall be renewed each year by the Tax
14 Commission or a motor license agent, unless authorized by the Tax
15 Commission to be renewed for a period greater than one (1) year.
16 The Tax Commission shall notify by mail all persons issued special
17 license plates. The notice shall contain all necessary information
18 and shall contain instructions for the renewal procedure upon
19 presentation to a motor license agent or the Tax Commission. The
20 license plates shall be issued on a staggered system.

21 If a special license plate is issued pursuant to this section,
22 any registration fee required for such plate and the fee required
23 pursuant to subsection A of Section 1132 of this title shall be
24 remitted at the same time and subject to a single registration

1 period. The Oklahoma Tax Commission shall promulgate rules
2 establishing a method for making required fee adjustments when a
3 special license plate is obtained during a twelve-month period for
4 which a registration fee has already been remitted pursuant to this
5 subsection. The combination of fees in a single remittance shall
6 not alter the apportionment otherwise provided for by law.

7 The Tax Commission is hereby directed to develop and implement a
8 system whereby motor license agents are permitted to accept
9 applications for special license plates authorized under this
10 section. The motor license agent shall confirm the applicant's
11 eligibility, if applicable, collect and deposit any amount
12 specifically authorized by law, accept and process the necessary
13 information directly into such system and generate a receipt
14 accordingly. For performance of these duties, motor license agents
15 shall retain the fee provided in Section 1141.1 of this title for
16 registration of a motor vehicle. The motor license agent fees for
17 acceptance of applications and renewals shall be paid out of the
18 Oklahoma Tax Commission Reimbursement Fund.

19 If fewer than one hundred of any type of special license plates
20 authorized prior to January 1, 2004, are issued prior to January 1,
21 2006, the Tax Commission shall discontinue issuance and renewal of
22 that type of special license plate. Any such authorized special
23 license plate registrant shall be allowed to display the license
24 plate upon the designated vehicle until the registration expiration

1 date. After such time the expired special license plate shall be
2 removed from the vehicle.

3 For special license plates authorized on or after July 1, 2004,
4 no special license plates shall be developed or issued by the Tax
5 Commission until the Commission receives one hundred prepaid
6 applications therefor. The prepaid applications must be received by
7 the Tax Commission within one hundred eighty (180) days of the
8 effective date of the authorization or the authority to issue shall
9 be null and void. In the event one hundred prepaid applications are
10 not received by the Tax Commission within such prescribed time
11 period any payment so received shall be refunded accordingly.

12 B. The special license plates provided by this section are as
13 follows:

14 1. University or College Supporter License Plate - such plates
15 shall be designed and issued to any person wishing to demonstrate
16 support to any state-supported or private university or college. As
17 provided in this section, an amount of the fee collected shall be
18 apportioned as provided in Section 1104.1 of this title;

19 2. Environmental Awareness License Plate - such plates shall be
20 designed, subject to the criteria to be presented to the Tax
21 Commission by the Department of Environmental Quality in
22 consultation with the Oklahoma Arts Council, and issued to any
23 person wishing to demonstrate support to implement the statewide
24 general public environmental education program created pursuant to

1 the provisions of the Oklahoma Environmental Quality Code. Such
2 plates shall be designed and issued to any person in any combination
3 of numbers and letters from one to a maximum of seven, as for
4 personalized license plates. A dealer's license plate issued
5 pursuant to Section 1116.1 or 1128 of this title may be designated
6 an Environmental Awareness License Plate upon payment of the fee
7 imposed by this section and any other registration fees required by
8 the Oklahoma Vehicle License and Registration Act. As provided in
9 this section, an amount of the fee collected shall be apportioned
10 pursuant to Section 1104.2 of this title;

11 3. Firefighter License Plate - such plates shall be designed
12 for any career or retired firefighter, volunteer or paid.
13 Firefighters may apply for firefighter plates for up to four
14 vehicles with a rated capacity of one (1) ton or less or for a
15 motorcycle upon proof of a fire department membership by either an
16 identification card or letter from the chief of the fire department.
17 Retirees who are eligible for such plates shall provide proof of
18 eligibility upon initial application, but shall not be required to
19 provide proof of eligibility annually. The surviving spouse of any
20 deceased firefighter, if the spouse has not since remarried, may
21 apply for a firefighter license plate for one vehicle with a rated
22 carrying capacity of one (1) ton or less or for a motorcycle upon
23 proof that the deceased firefighter was a member of a fire
24 department by either an identification card or letter from the chief

1 of the fire department. The license plate shall be designed in
2 consultation with the Oklahoma Firefighters Association.

3 As provided in this section, an amount of the fee collected
4 shall be deposited to the Oklahoma State Firemen's Museum Building &
5 Memorial Fund for support of the Oklahoma Firefighters Museum and
6 the Oklahoma Fallen and Living Firefighters Memorial;

7 4. Wildlife Conservation License Plate - such plates shall be
8 designed, subject to the criteria to be presented to the Tax
9 Commission by the Oklahoma Department of Wildlife Conservation in
10 consultation with the Oklahoma Arts Council, and issued to any
11 person wishing to demonstrate support for wildlife conservation in
12 this state through the Wildlife Diversity Fund, provided for in
13 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
14 be designed and issued to any person as for personalized license
15 plates.

16 As provided in this section, an amount of the fee collected
17 shall be apportioned pursuant to subsection D of Section 3-310 of
18 Title 29 of the Oklahoma Statutes;

19 5. Child Abuse Prevention License Plate - such plates shall be
20 designed, subject to the criteria to be presented to the Tax
21 Commission by the Office of Child Abuse Prevention in the State
22 Department of Health and the Oklahoma Committee to Prevent Child
23 Abuse, and issued to any person wishing to demonstrate support for
24 the prevention of child abuse.

1 As provided in this section, an amount of the fee collected
2 shall be deposited in the Child Abuse Prevention Fund;

3 6. United States Olympic Committee Supporter License Plate -
4 such plates shall be designed and issued to any person wishing to
5 demonstrate support for the United States Olympic Committee. The
6 plates shall be issued to any person in any combination of numbers
7 and letters from one to a maximum of seven, as for personalized
8 license plates. The plate shall contain the official United States
9 Olympic Committee logo. The Tax Commission shall be authorized, if
10 necessary, to enter into a licensing agreement with the United
11 States Olympic Committee for any licensing fees which may be
12 required in order to use the United States Olympic Committee logo or
13 design. The licensing agreement shall provide for a payment of not
14 more than Twenty-five Dollars (\$25.00) for each license plate
15 issued;

16 7. Oklahoma History License Plate - such plates shall be
17 designed and issued to any person wishing to demonstrate interest in
18 Oklahoma history. As provided in this section, an amount of the fee
19 collected shall be deposited to the Oklahoma Historical Society
20 Revolving Fund to be used for educational purposes;

21 8. Historic Route 66 License Plate - such:

22 a. vehicle plates shall be designed to honor historic
23 Route 66, also known as the "Mother Road". As
24 provided in this section, an amount of the fee

1 collected for each vehicle license plate shall be
2 apportioned to the Oklahoma Historical Society
3 Revolving Fund to be distributed to the Route 66
4 Museum located in Clinton, Oklahoma, and

5 b. motorcycle plates shall be designed in consultation
6 with the Oklahoma Route 66 Association, Inc. The
7 Oklahoma Tax Commission shall be authorized to enter
8 into a licensing agreement with the Oklahoma Route 66
9 Association, Inc., for any licensing fees which may be
10 required in order to use the Oklahoma Route 66
11 Association, Inc., logo or design. The licensing
12 agreement shall provide for a payment to the Oklahoma
13 Route 66 Association, Inc., of not more than Twenty
14 Dollars (\$20.00) for each motorcycle license plate
15 issued;

16 9. Heart of the Heartland License Plate - such plates shall be
17 designed and issued to any person wishing to honor the victims of
18 the terrorist bombing attack on the Alfred P. Murrah Federal
19 Building in downtown Oklahoma City on April 19, 1995. As provided
20 in this section, an amount of the fee collected shall be deposited
21 in the Heart of the Heartland Scholarship Fund, as established in
22 Section 2282 of Title 70 of the Oklahoma Statutes;

23 10. Emergency Medical Technician License Plate - such plates
24 shall be designed and issued to any person who is an emergency

1 medical technician. Such persons may apply for an emergency medical
2 technician license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less upon proof of an emergency medical
4 technician's license. The license plate shall be designed in
5 consultation with the state association of emergency medical
6 technicians. As provided in this section, an amount of the fee
7 collected shall be apportioned to the Emergency Medical Personnel
8 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
9 of the Oklahoma Statutes;

10 11. Fight Breast Cancer License Plate - such plates shall be
11 designed to demonstrate support for the prevention and treatment of
12 breast cancer in this state. As provided in this section, an amount
13 of the fee collected shall be apportioned to the Breast Cancer Act
14 Revolving Fund;

15 12. Crime Victims Awareness License Plate - such plates shall
16 be designed and issued to any person wishing to demonstrate
17 awareness of and support for victims of crimes. The license plates
18 shall be designed in consultation with the Oklahoma Crime Victims
19 Centre. As provided in this section, an amount of the fee collected
20 shall be apportioned to the Attorney General's Revolving Fund for
21 the Office of the Attorney General, which is hereby directed to use
22 such funds to contract with a statewide nonprofit organization to
23 provide services to crime victims;

1 13. Oklahoma Safe Kids Association License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support and awareness of the Oklahoma Safe Kids Association. The
4 license plate shall be designed in consultation with the Oklahoma
5 Safe Kids Association. As provided in this section, an amount of
6 the fee collected shall be deposited in the Children's Hospital -
7 Oklahoma Safe Kids Association Revolving Fund to be distributed to
8 the Oklahoma Safe Kids Association program;

9 14. Four-H Club License Plate - such plates shall be designed,
10 subject to criteria to be presented to the Tax Commission by the
11 Four-H Foundation, and issued to any person wishing to demonstrate
12 support of the Four-H Club. Such plates may be designed and issued
13 to any person as for personalized license plates. As provided in
14 this section, an amount of the fee collected shall be apportioned to
15 the OSU Extension Service License Plate Revolving Fund created in
16 Section 1104.4 of this title;

17 15. Agricultural Awareness License Plate - such plates shall be
18 designed, subject to criteria to be presented to the Tax Commission,
19 by the Oklahoma Department of Agriculture, Food, and Forestry in
20 consultation with the Oklahoma Arts Council, and issued to any
21 person wishing to demonstrate support of the Department's Ag in the
22 Classroom Education Program. As provided in this section, an amount
23 of the fee collected shall be apportioned as provided in Section
24 1104.3 of this title;

1 16. Oklahoma Statehood Centennial License Plate - such plates
2 shall be designed and issued to any person wishing to commemorate
3 the centennial of Oklahoma's admission to statehood in 1907. The
4 license plates shall be designed in consultation with the Oklahoma
5 Capitol Complex and Centennial Commemoration Commission. As
6 provided in this section, an amount of the fee collected shall be
7 deposited in the Oklahoma ~~Capitol Complex and Centennial~~
8 ~~Commemoration Commission~~ Department of Commerce Revolving Fund
9 created in Section ~~98.5~~ 5012 of Title ~~73~~ 74 of the Oklahoma
10 Statutes;

11 17. Support Education License Plate - such plates shall be
12 designed, subject to criteria to be presented to the Tax Commission
13 by the State Department of Education in consultation with the
14 Oklahoma Arts Council, and issued to any person wishing to
15 demonstrate support for education in this state. All motor license
16 agents shall display a sample of the Support Education License plate
17 in the area of the business accessed by the public. Twenty-three
18 Dollars (\$23.00) of the fee collected shall be apportioned as
19 follows:

- 20 a. five percent (5%) shall be deposited to the Education
21 Reform Revolving Fund,
22 b. five percent (5%) shall be deposited to the Higher
23 Education Revolving Fund,
24

- 1 c. five percent (5%) shall be deposited to the State
2 Career Technology Fund, and
- 3 d. eighty-five percent (85%) ~~of the fee~~ shall be
4 deposited to the Teachers' Retirement Benefit Fund as
5 set forth in Section 17-108 of Title 70 of the
6 Oklahoma Statutes.

7 However, when the Teachers' Retirement Benefit Fund attains a
8 seventy percent (70%) funded ratio based on an annual actuarial
9 valuation as required by law, the amount of the fee shall be
10 apportioned equally pursuant to subparagraphs a, b and c of this
11 paragraph;

12 18. Retired Oklahoma Highway Patrol Officers License Plate -
13 such plates shall be designed and issued to any retired officer of
14 the Oklahoma Highway Patrol. The license plate shall have the
15 legend "Oklahoma" and shall contain, in the center of the plate, the
16 Highway Patrol Officers patch using the same colors and pattern as
17 used in the patch. Centered on the bottom of the license plate
18 shall be the word "Retired". The letters "TRP" shall be used in
19 combination with three numbers on either side of the insignia or
20 emblem. The color of the letters and numbers shall be brown.

21 Retirees who are eligible for such plates shall provide proof of
22 eligibility upon initial application, but shall not be required to
23 provide proof of eligibility annually. The surviving spouse of any
24 deceased retired officer of the Oklahoma Highway Patrol, if the

1 spouse has not since remarried, or if remarried, the remarriage is
2 terminated by death, divorce, or annulment, may apply for a Retired
3 Oklahoma Highway Patrol Officers license plate. As provided in this
4 section, an amount of the fee collected shall be deposited into the
5 Law Enforcement Retirement Fund;

6 19. Boy Scouts of America Supporter License Plate - such plates
7 shall be designed and issued to any person wishing to demonstrate
8 support for the Boy Scouts of America. The plates shall be issued
9 to any person in any combination of numbers and letters from one to
10 a maximum of seven, as for personalized license plates. The plate
11 shall contain the official Boy Scouts of America logo. The Tax
12 Commission shall be authorized, if necessary, to enter into a
13 licensing agreement with the Boy Scouts of America for any licensing
14 fees which may be required in order to use the Boy Scouts of America
15 logo or design. The licensing agreement shall provide for a payment
16 to the Boy Scouts of America of not more than Twenty Dollars
17 (\$20.00) for each license plate issued;

18 20. Urban Forestry and Beautification License Plate - such
19 plates shall be designed, subject to criteria to be presented to the
20 Tax Commission, by the Oklahoma Department of Agriculture, Food, and
21 Forestry in consultation with nonprofit organizations in this state
22 that develop and operate programs to encourage urban forestry and
23 beautification, and issued to any person wishing to demonstrate
24 support of such programs. As provided in this section, an amount of

1 the fee collected shall be apportioned as provided in Section 1104.5
2 of this title;

3 21. Oklahoma State Parks Supporter License Plate - such plates
4 shall be designed, subject to criteria to be presented to the Tax
5 Commission by the Oklahoma Tourism and Recreation Department, and
6 issued to any person wishing to demonstrate support for the Oklahoma
7 state parks system. Twenty-three Dollars (\$23.00) of the fee
8 collected shall be deposited in the Oklahoma Tourism and Recreation
9 Department Revolving Fund. Such money shall be designated for and
10 may only be expended for the support of Oklahoma state parks;

11 22. Adoption Creates Families License Plate - such plates shall
12 be issued to any person wishing to demonstrate support of pregnant
13 women who are committed to placing their children for adoption and
14 wishing to provide assistance to guardians, adoptive parents and
15 other created families to assist in the adoption and placement of
16 children in permanent, safe homes. The license plates shall be
17 designed and final terminology delivered in consultation with the
18 Oklahoma Adoption Coalition and the Department of Human Services.
19 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
20 in a revolving fund established in the State Treasury for and to be
21 used by the Department of Human Services for the implementation of
22 the Investing in Stronger Oklahoma Families Act specifically for
23 created families;

1 23. Choose Life License Plate - such plates shall be designed,
2 subject to criteria presented to the Tax Commission, by Choose Life,
3 Inc., and issued to any person who wishes to demonstrate support of
4 organizations that encourage adoption as a positive choice for women
5 with unplanned pregnancies. As provided in this section, an amount
6 of the fee collected shall be deposited in the Choose Life
7 Assistance Program Revolving Fund established in Section 1104.6 of
8 this title;

9 24. Future Farmers of America License Plate - such plates shall
10 be designed and issued to persons wishing to demonstrate support for
11 the Oklahoma FFA (formerly known as Future Farmers of America). The
12 license plates shall be designed in consultation with the Oklahoma
13 FFA Foundation Board of Directors. As provided in this section, an
14 amount of the fee collected shall be apportioned as provided in
15 Section 1104.7 of this title;

16 25. Lions Club License Plate - such plates shall be designed
17 and issued to persons wishing to demonstrate support for the Lions
18 Club of Oklahoma. The plates shall be issued to any person in any
19 combination of numbers and letters from one to a maximum of seven,
20 as for personalized license plates. The license plates shall be
21 designed in consultation with the Oklahoma Lions Service Foundation
22 and shall contain the official logo of the International Association
23 of Lions Clubs. The Tax Commission shall be authorized to enter
24 into a licensing agreement with the Oklahoma Lions Service

1 Foundation. The licensing agreement shall provide for a payment to
2 the Oklahoma Lions Service Foundation of not more than Ten Dollars
3 (\$10.00) for each license plate issued;

4 26. Color Oklahoma License Plate - such plates shall be
5 designed, subject to criteria to be presented to the Tax Commission
6 by the Oklahoma Native Plant Society, and issued to any person
7 wishing to demonstrate support for preserving and planting
8 wildflowers and native plants in Oklahoma and to promote Oklahoma's
9 wildflower heritage through education. As provided in this section,
10 an amount of the fee collected shall be apportioned as provided in
11 Section 1104.8 of this title;

12 27. Girl Scouts of the United States of America Supporter
13 License Plate - such plates shall be designed and issued to any
14 person wishing to demonstrate support for the Girl Scouts of the
15 United States of America. The plates shall be issued to any person
16 in any combination of numbers and letters from one to a maximum of
17 seven, as for personalized license plates. The plate shall contain
18 the official Girl Scouts of the United States of America logo. The
19 Tax Commission shall be authorized, if necessary, to enter into a
20 licensing agreement with the Girl Scouts of the United States of
21 America for any licensing fees which may be required in order to use
22 the Girl Scouts of the United States of America logo or design. The
23 licensing agreement shall provide for a payment to the Girl Scouts
24 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout

1 councils, of not more than Twenty Dollars (\$20.00) for each license
2 plate issued;

3 28. Oklahoma City Memorial Marathon License Plate - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support for the Oklahoma City Memorial Marathon. The plate shall be
6 designed in consultation with the Oklahoma City Memorial Marathon.
7 The Tax Commission shall be authorized to enter into a licensing
8 agreement with the Oklahoma City Memorial Marathon for any licensing
9 fees which may be required in order to use the Oklahoma City
10 Memorial Marathon logo or design. The licensing agreement shall
11 provide for a payment to the Oklahoma City Memorial Marathon of not
12 more than Twenty Dollars (\$20.00) for each license plate issued;

13 29. Oklahoma Scenic Rivers License Plate - such plates shall be
14 designed to demonstrate support for the Oklahoma Scenic Rivers. The
15 plates shall be designed in consultation with the Oklahoma Scenic
16 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
17 apportioned to the Oklahoma Scenic Rivers Commission;

18 30. Fight Cancer License Plate - such plates shall be designed
19 to demonstrate support for the Oklahoma Central Cancer Registry.
20 The plate shall contain the American Cancer Society logo. The
21 American Cancer Society logo shall be used in accordance with the
22 American Cancer Society's branding guidelines and shall only be
23 utilized to support the Oklahoma Central Cancer Registry. Twenty
24

1 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
2 Central Cancer Registry Revolving Fund;

3 31. Animal Friendly License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 controlling the overpopulation of dogs and cats through educational
6 and sterilization efforts. The plates shall be designed in
7 consultation with the Veterinary Medical Association. Twenty
8 Dollars (\$20.00) of the fee collected shall be designated by the
9 purchaser of the plate to be deposited in the Oklahoma Pet
10 Overpopulation Fund created in Section 2368.13 of Title 68 of the
11 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
12 Section 1104.10 of this title;

13 32. Patriot License Plate - such plates shall be designed in
14 consultation with the Military Department of Oklahoma and issued to
15 any person wishing to demonstrate support for Oklahoma residents who
16 are members of the Oklahoma National Guard and deployed on active
17 duty. The plates shall be issued to any person in any combination
18 of numbers and letters from one to a maximum of seven, as for
19 personalized license plates. As provided in this section, a portion
20 of the fee collected shall be deposited in the Patriot License Plate
21 Revolving Fund created in Section 1104.11 of this title;

22 33. Global War on Terrorism License Plate - such plate shall be
23 designed in consultation with the Military Department of Oklahoma
24 and issued to any person wishing to demonstrate support for Oklahoma

1 residents who are members of the Armed Forces of the United States
2 or Oklahoma National Guard that have served in the Global War on
3 Terrorism. The plate shall be issued to any person in any
4 combination of numbers and letters from one to a maximum of six. As
5 provided in this section, a portion of the fee collected shall be
6 deposited in the 45th Infantry Division Museum Fund created in

16 Ducks Unlimited. The Oklahoma Tax Commission shall be authorized to
17 enter into a licensing agreement with Ducks Unlimited for any
18 licensing fee which may be required in order to use the Ducks
19 Unlimited logo or design. The licensing agreement shall provide for
20 a payment to Ducks Unlimited of not more than Twenty Dollars
21 (\$20.00) for each license plate issued;

22 77. Prisoner of War and Missing in Action License Plate - such
23 plates shall be issued to any person wishing to increase awareness
24 of those who are currently prisoners of war or missing in action and

1 provide financial support for current veterans. The license plates
2 shall be designed in consultation with Rolling Thunder Oklahoma. As
3 provided in this section, an amount of the fee collected shall be
4 deposited in the Prisoner of War and Missing in Action License Plate
5 Revolving Fund created in Section 1104.29 of this title;

6 78. Woodward Boomers License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 the Woodward School District. The license plates shall be designed
9 in consultation with the administration of the Woodward School
10 District. The Tax Commission shall be authorized to enter into a
11 licensing agreement with the Woodward School District for any
12 licensing fees which may be required in order to use the school
13 district's logo or design. The licensing agreement shall provide
14 for a payment to the Woodward School District of not more than
15 Twenty Dollars (\$20.00) for each license plate issued;

16 79. Clinton Public School Foundation License Plate - such
17 plates shall be designed and issued to any person wishing to
18 demonstrate support for the Clinton Public School Foundation. The
19 license plates shall be designed in consultation with the Clinton
20 Public School Foundation. The Tax Commission shall be authorized to
21 enter into a licensing agreement with the Clinton Public School
22 Foundation for any licensing fees which may be required in order to
23 use the school foundation's logo or design. The licensing agreement
24 shall provide for a payment to the Clinton Public School Foundation

1 of not more than Twenty Dollars (\$20.00) for each license plate
2 issued;

3 80. Navajo School Foundation License Plate - such plates shall
4 be issued to any person wishing to demonstrate support for the
5 Navajo School Foundation. The license plates shall be designed in
6 consultation with the administration of the Navajo School
7 Foundation. The Oklahoma Tax Commission shall be authorized to
8 enter into a licensing agreement with the Navajo School Foundation
9 for any licensing fees which may be required in order to use the
10 Foundation's logo or design. The licensing agreement shall provide
11 for a payment to the Navajo School Foundation of not more than
12 Twenty Dollars (\$20.00) for each license plate issued;

13 81. Oklahoma Music Hall of Fame Inc. License Plate - such
14 plates shall be designed in consultation with the Oklahoma Music
15 Hall of Fame Inc. and issued to any member of the organization
16 wishing to demonstrate support. The Tax Commission shall be
17 authorized to enter into a licensing agreement with the Oklahoma
18 Music Hall of Fame Inc. for any licensing fees which may be required
19 in order to use the organization's logo or design. The licensing
20 agreement shall provide for a payment to the Oklahoma Music Hall of
21 Fame Inc. of not more than Twenty Dollars (\$20.00) for each license
22 plate issued. The plates shall incorporate a numbering system
23 agreed upon by the Oklahoma Music Hall of Fame Inc. and the Tax
24 Commission. Subject to the provisions of subsection A of this

1 section, the Oklahoma Music Hall of Fame Inc. License Plate is
2 hereby reauthorized effective November 1, 2019;

3 82. Techlahoma Foundation License Plate - such plates shall be
4 issued to any person wishing to provide financial support for the
5 Techlahoma Foundation. The license plate shall be designed in
6 consultation with the Techlahoma Foundation. The plate shall be
7 issued to any person in any combination of numbers and letters from
8 one to a maximum of seven, as for personalized plates. The Tax
9 Commission shall be authorized to enter into a licensing agreement
10 with the Techlahoma Foundation for any licensing fees, which may be
11 required in order to use the association's logo or design. The
12 licensing agreement shall provide for a payment to the Techlahoma
13 Foundation of not more than Twenty Dollars (\$20.00) for each license
14 plate issued;

15 83. Bethany Public Schools Foundation License Plate - such
16 plates shall be issued to any person wishing to demonstrate support
17 for the Bethany Public Schools Foundation. The license plates shall
18 be designed in consultation with the administration of the Bethany
19 Public Schools Foundation. The Oklahoma Tax Commission shall be
20 authorized to enter into a licensing agreement with the Bethany
21 Public Schools Foundation for any licensing fees which may be
22 required in order to use the Foundation's logo or design. The
23 licensing agreement shall provide for a payment to the Bethany
24

1 Public Schools Foundation of not more than Twenty Dollars (\$20.00)
2 for each license plate issued;

3 84. Cystic Fibrosis Foundation License Plate - such plates
4 shall be issued to any person wishing to demonstrate support for the
5 Cystic Fibrosis Foundation. The license plates shall be designed in
6 consultation with the administration of the Cystic Fibrosis
7 Foundation. The Oklahoma Tax Commission shall be authorized to
8 enter into a licensing agreement with the Cystic Fibrosis Foundation
9 for any licensing fees which may be required in order to use the
10 Foundation's logo or design. The licensing agreement shall provide
11 for a payment to the Cystic Fibrosis Foundation of not more than
12 Twenty Dollars (\$20.00) for each license plate issued;

13 85. Down Syndrome Association of Central Oklahoma License Plate
14 - such plates shall be designed and issued to any person wishing to
15 demonstrate support for the Down Syndrome Association of Central
16 Oklahoma. Such plates shall be designed in consultation with the
17 Association. As provided in this section, an amount of the fee
18 collected shall be deposited in the Down Syndrome Association of
19 Central Oklahoma License Plate Revolving Fund created in Section
20 1104.30 of this title;

21 86. Elk City Education Foundation License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for the Elk City Education Foundation. Such plates shall be
24 designed in consultation with the Foundation. As provided in this

1 section, an amount of the fee collected shall be deposited in the
2 Elk City Education Foundation License Plate Revolving Fund created
3 in Section 1104.31 of this title;

4 87. A Brotherhood Aiming Toward Education of Oklahoma (ABATE)
5 License Plate - such plates shall be designed and issued to any
6 person wishing to provide financial support for ABATE of Oklahoma.
7 Such plates shall be designed in consultation with ABATE of
8 Oklahoma. The plates shall be issued to any person in any
9 combination of numbers and letters from one to a maximum of seven,
10 as for personalized plates. The license plate for a motorcycle may
11 be of similar design as space permits or a new design in order to
12 meet the space requirements of a motorcycle license plate. The
13 Oklahoma Tax Commission shall be authorized to enter into a
14 licensing agreement with ABATE of Oklahoma for any licensing fees
15 which may be required in order to use the ABATE of Oklahoma logo or
16 design. The licensing agreement shall provide for a payment to
17 ABATE of Oklahoma of not more than Twenty Dollars (\$20.00) for each
18 license plate issued;

19 88. Downed Bikers Association License Plate - such plates shall
20 be designed for a vehicle or motorcycle in any combination of
21 numbers and letters from one to a maximum of seven, as for
22 personalized plates, and issued to any person wishing to demonstrate
23 support for the Downed Bikers Association, a nonprofit charitable
24 organization exempt from taxation pursuant to the provisions of the

1 Internal Revenue Code, 26 U.S.C., Section 501(c)(3), which provides
2 emotional and financial support for downed bikers. The license
3 plate shall be designed in consultation with the Central Oklahoma
4 Chapter of the Downed Bikers Association and shall contain any
5 official logo or design of the organization. The license plate for
6 a motorcycle may be of similar design as space permits or a new
7 design in order to meet the space requirements of a motorcycle
8 license plate. The Tax Commission, if necessary, may enter into a
9 licensing agreement with the Downed Bikers Association for any
10 licensing fees which may be required in order to use the
11 organization's logo or design. The licensing agreement shall
12 provide for a payment to the Downed Bikers Association of not more
13 than Twenty Dollars (\$20.00) for each license plate;

14 89. Eagle Scout License Plate - Such plates shall be designed
15 to demonstrate support for Eagle Scouts and shall include the Eagle
16 Scout logo. Plates may be issued to any person who can show proof
17 of having obtained the rank of Eagle Scout. The Oklahoma Tax
18 Commission shall be authorized to enter into a licensing agreement
19 with the various Oklahoma local councils for any licensing fees
20 which may be required in order to use the applicable logo or design.
21 The licensing agreement shall provide for a payment of not more than
22 Twenty Dollars (\$20.00) for each license plate issued to the
23 specific Oklahoma local area Council designated by the applicant;

24

1 90. Extraordinary Educators License Plate - such plates shall
2 be designed and issued to any person wishing to provide financial
3 support for common education in Oklahoma. Such plates shall be
4 designed in consultation with the State Department of Education.
5 The plates shall be issued to any person in any combination of
6 numbers and letters from one to a maximum of seven, as for
7 personalized plates. As provided in this section, an amount of the
8 fee collected shall be deposited in the Extraordinary Educators
9 License Plate Revolving Fund created in Section 1104.32 of this
10 title;

11 91. Former Oklahoma Legislator License Plate - such plates
12 shall be designed and issued to any person who previously served as
13 a member of the Oklahoma House of Representatives or Oklahoma State
14 Senate. The license plates shall be designed in consultation with
15 the Oklahoma Historical Society. As provided in this section, an
16 amount of the fee collected shall be deposited in the Oklahoma
17 Historical Society Capital Improvement and Operations Revolving Fund
18 created in Section 1.10a of Title 53 of the Oklahoma Statutes. The
19 Tax Commission shall create and maintain a list of former members of
20 the Oklahoma House of Representatives and Oklahoma State Senate
21 eligible to be issued such plates; provided, that no former member
22 of the Oklahoma House of Representatives and Oklahoma State Senate
23 shall be eligible to possess more than two of such plates at any one
24 time. The Tax Commission shall confer as needed with the Chief

1 Clerk of the Oklahoma House of Representatives and the Secretary of
2 the Oklahoma State Senate to confirm that such list is complete and
3 accurate;

4 92. Monarch Butterfly License Plate - such plates shall be
5 designed and issued to any person wishing to demonstrate support for
6 the operations of the Nature Conservancy of Oklahoma. Such plates
7 shall be designed in consultation with the Oklahoma Chapter of the
8 Nature Conservancy. The Tax Commission shall be authorized to enter
9 into a licensing agreement with the Nature Conservancy of Oklahoma
10 for any licensing fees which may be required in order to use the
11 foundation's logo or design. The licensing agreement shall provide
12 for a payment to the Nature Conservancy of Oklahoma of not more than
13 Twenty Dollars (\$20.00) for each license plate issued;

14 93. Oklahoma Tennis Foundation License Plate - such plates
15 shall be designed and issued to any person wishing to demonstrate
16 support for the Oklahoma Tennis Foundation. The license plates
17 shall be designed in consultation with the Oklahoma Tennis
18 Foundation. The Tax Commission shall be authorized to enter into a
19 licensing agreement with the Oklahoma Tennis Foundation for any
20 licensing fees which may be required in order to use the
21 foundation's logo or design. The licensing agreement shall provide
22 for a payment to the Oklahoma Tennis Foundation of not more than
23 Twenty Dollars (\$20.00) for each license plate issued;

24

1 94. Veterans of Foreign Wars License Plate - such plates shall
2 be designed and issued to any person wishing to demonstrate support
3 for the Veterans of Foreign Wars Foundation. The license plates
4 shall be designed in consultation with the Veterans of Foreign Wars
5 Foundation. The Tax Commission shall be authorized to enter into a
6 licensing agreement with the Veterans of Foreign Wars Foundation for
7 any licensing fees which may be required in order to use the
8 foundation's logo or design. The licensing agreement shall provide
9 for a payment to the Veterans of Foreign Wars Foundation of not more
10 than Twenty Dollars (\$20.00) for each license plate issued;

11 95. Oklahoma Women Veterans Organization License Plate - such
12 plates shall be designed and issued to any female veteran of any
13 branch of the United States Armed Forces wishing to demonstrate
14 support for the Oklahoma Women Veterans Organization. The license
15 plates shall be designed in consultation with the Oklahoma Women
16 Veterans Organization. The Tax Commission shall be authorized to
17 enter into a licensing agreement with the Oklahoma Women Veterans
18 Organization for any licensing fees which may be required in order
19 to use the organization's logo or design. The licensing agreement
20 shall provide for a payment to the Oklahoma Women Veterans
21 Organization of not more than Twenty Dollars (\$20.00) for each
22 license plate issued;

23 96. FIRST (For Inspiration and Recognition of Science and
24 Technology) License Plate - such plates shall be issued to any

1 person wishing to demonstrate support for FIRST Robotics Programs.
2 The license plates shall be designed in consultation with the
3 administration of FIRST. The Oklahoma Tax Commission shall be
4 authorized to enter into a licensing agreement with FIRST for any
5 licensing fees which may be required in order to use the FIRST logo
6 or design. The licensing agreement shall provide for a payment to
7 FIRST of not more than Twenty Dollars (\$20.00) for each license
8 plate issued;

9 97. Pittsburg State University License Plate - such plates
10 shall be designed and issued to any person wishing to demonstrate
11 support for the Pittsburg State University. The license plates
12 shall be designed in consultation with Pittsburg State University.
13 The Tax Commission shall be authorized to enter into a licensing
14 agreement with Pittsburg State University for any licensing fees
15 which may be required in order to use the school foundation's logo
16 or design. The licensing agreement shall provide for a payment to
17 the Pittsburg State University of not more than Twenty Dollars
18 (\$20.00) for each license plate issued; and

19 98. Historic Greenwood District License Plate - such plates
20 shall be issued to persons wishing to demonstrate support for the
21 Historic Greenwood District Juneteenth Festival held in the Historic
22 Greenwood District in Tulsa, Oklahoma. The plates shall be issued
23 to any person in any combination of numbers and letters from one to
24 a maximum of seven, as for personalized license plates. The license

plates shall be designed in consultation with the Black Wall Street Chamber of Commerce. Twenty-five Dollars (\$25.00) of the fee collected shall be deposited in the Historic Greenwood District/Juneteenth Festival Revolving Fund established in Section 5 2368.32 of this act Title 68 of the Oklahoma Statutes. Two Dollars (\$2.00) of the fee collected shall be deposited in the Public School Classroom Support Revolving Fund, for expenditure as provided in Section 1-123 of Title 70 of the Oklahoma Statutes.

C. The fee for such plates shall be Thirty-five Dollars (\$35.00) per year of renewal and shall be in addition to all other registration fees provided by the Oklahoma Vehicle License and Registration Act. The fee shall be apportioned as follows:

1. Twenty Dollars (\$20.00) per year of renewal or any other amount as provided in this title of the fee shall be apportioned as provided or deposited in a fund as specified within the paragraph authorizing the special license plate;

2. Eight Dollars (\$8.00) per year of renewal of the fee shall be deposited in the Oklahoma Tax Commission Reimbursement Fund to be used for the administration of the Oklahoma Vehicle License and Registration Act; and

3. Any remaining amounts of the fee shall be apportioned as provided in Section 1104 of this title.

SECTION 7. AMENDATORY 47 O.S. 2011, Section 1135.6, is amended to read as follows:

1 Section 1135.6. The Oklahoma Tax Commission is hereby
2 authorized to design and issue National Association for Stock Car
3 Auto Racing Driver ("NASCAR") Theme License Plates. Such plates
4 shall be designed and issued to any person wishing to demonstrate
5 interest in NASCAR auto racing. The plates shall be of such design
6 as the supplier of the license plates in consultation with the
7 Oklahoma Tax Commission may prescribe. The fee for such plate shall
8 be Forty Dollars (\$40.00) and shall be in addition to all other
9 registration fees required by the Oklahoma Vehicle License and
10 Registration Act. If a special license plate is issued pursuant to
11 this section, any registration fee required for such plate and the
12 fee required pursuant to subsection A of Section 1132 of this title
13 shall be remitted at the same time and subject to a single
14 registration period. The Oklahoma Tax Commission shall promulgate
15 rules establishing a method for making required fee adjustments when
16 a special license plate is obtained during a twelve-month period for
17 which a registration fee has already been remitted pursuant to this
18 section. The combination of fees in a single remittance shall not
19 alter the apportionment otherwise provided for by law.

20 The Tax Commission shall be authorized to enter into a licensing
21 agreement with the supplier of such NASCAR Driver license plates or
22 other entity for any required licensing fees. The licensing
23 agreement shall provide for a payment of not more than ~~Twenty-five~~
24 ~~Percent~~ twenty-five percent (25%) of the fee authorized for each

1 license plate issued. Five Dollars (\$5.00) of the forty-dollar fee
2 shall be apportioned to the General Revenue Fund. The remaining
3 amount of such fee shall be deposited in the Oklahoma Tax Commission
4 Reimbursement Fund.

5 For license plates numbered zero (0) through one hundred (100)
6 displaying a particular NASCAR Driver theme, the Oklahoma Tax
7 Commission may establish an auction or similar procedure for the
8 purpose of determining the order in which such distinctive license
9 plates are sold and the amount of the additional fee for the
10 distinctive license plates. This amount shall be due at the time
11 the original application is submitted to the Tax Commission and
12 Forty Dollars (\$40.00) thereafter annually at the time of renewal
13 registration.

14 SECTION 8. AMENDATORY 47 O.S. 2011, Section 1135.7, as
15 amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,
16 Section 1135.7), is amended to read as follows:

17 Section 1135.7. A. The Oklahoma Tax Commission or private
18 vendor with whom the Commission has contracted is authorized to
19 design and issue special license plates to any person that applies
20 to the Tax Commission or private vendor for the creation of a
21 special license plate and meets the minimum standards and
22 qualifications specified in this section.

23 B. If the following standards and guidelines are satisfied, the
24 Tax Commission shall authorize the issuance of a special license

1 plate to the person making application for the special license
2 plate:

3 1. The license plate is to:

4 a. show membership in or affiliation with an
5 organization, or

6 b. demonstrate support for an organization, group or
7 cause;

8 2. The license plate does not advertise or endorse a product,
9 brand, or service that is provided for sale;

10 3. The license plate does not promote any philosophy based on
11 prejudice or that is contrary to state civil rights laws; and

12 4. Two hundred prepaid applications for the special license
13 plate are received by the Tax Commission or private vendor.

14 C. The fee for special license plates shall be determined in
15 accordance with Section 1 of this act. If the special license plate
16 does not provide financial assistance the fee shall be no less than
17 Fifteen Dollars (\$15.00) per year of renewal and shall be in
18 addition to all other registration fees provided by the Oklahoma
19 Vehicle License and Registration Act. Unless otherwise provided in
20 this section, Fifteen Dollars (\$15.00) of the fee shall be
21 apportioned as follows: Eight Dollars (\$8.00) of the special
22 license plate fee shall be deposited in the Oklahoma Tax Commission
23 Reimbursement Fund to be used for the administration of the Oklahoma
24 Vehicle License and Registration Act and the remaining amounts of

1 the special license plate fee shall be apportioned as provided in
2 Section 1104 of this title.

3 D. The fee for special license plates that provide financial
4 assistance shall be determined in accordance with Section 1 of this
5 act. Provided, the fee shall be no less than Thirty-five Dollars
6 (\$35.00) and shall be in addition to all other registration fees
7 provided by the Oklahoma Vehicle License and Registration Act.
8 Thirty-five Dollars (\$35.00) per year of renewal of the fee shall be
9 apportioned as follows:

10 1. Twenty Dollars (\$20.00) of the fee shall be apportioned to
11 the License Plate Special Program Assistance Revolving Fund created
12 in Section 1135.8 of this title to be used in the manner detailed in
13 the application for the special license plate;

14 2. Eight Dollars (\$8.00) of the fee shall be deposited in the
15 Oklahoma Tax Commission Reimbursement Fund to be used for the
16 administration of the Oklahoma Vehicle License and Registration Act;
17 and

18 3. Any remaining amounts of the fee shall be apportioned as
19 provided in Section 1104 of this title.

20 E. If a person applies for a special license plate that
21 provides financial assistance, the application shall designate a
22 state agency to be responsible for expending the funds generated by
23 the special license plate and the application shall designate a
24 specific public purpose for which the funds are to be used. The

1 application shall include an acknowledgment from the designated
2 state agency of their agreement with acceptance of the designated
3 funds.

4 F. Special license plates shall not be transferred to any other
5 person but shall be removed from the vehicle upon transfer of
6 ownership and retained. The special license plate may then be used
7 on another vehicle but only after such other vehicle has been
8 registered for the current year.

9 Special license plates shall be renewed each year by the Tax
10 Commission or a motor license agent, unless authorized by the Tax
11 Commission to be renewed for a period greater than one (1) year.
12 The Tax Commission shall notify all persons issued special license
13 plates of the renewal procedures prior to the expiration of the
14 special license plate. The notice shall contain all necessary
15 information and shall contain instructions for the renewal procedure
16 upon presentation to a motor license agent or the Tax Commission.
17 The license plates shall be issued on a staggered system.

18 If a special license plate is issued pursuant to this section,
19 any registration fee required for such plate and the fee required
20 pursuant to subsection A of Section 1132 of this title shall be
21 remitted at the same time and subject to a single registration
22 period. The Oklahoma Tax Commission shall promulgate rules
23 establishing a method for making required fee adjustments when a
24 special license plate is obtained during a twelve-month period for

1 which a registration fee has already been remitted pursuant to this
2 subsection. The combination of fees in a single remittance shall
3 not alter the apportionment otherwise provided for by law.

4 The Tax Commission is hereby directed to develop and implement a
5 system whereby motor license agents are permitted to accept
6 applications for special license plates authorized under this
7 section. The motor license agent shall confirm the applicant's
8 eligibility, if applicable, collect and deposit any amount
9 specifically authorized by law, accept and process the necessary
10 information directly into such system and generate a receipt
11 accordingly. For performance of these duties, motor license agents
12 shall retain the fee provided in Section 1141.1 of this title for
13 registration of a motor vehicle. The motor license agent fees for
14 acceptance of applications and renewals shall be paid out of the
15 Oklahoma Tax Commission Reimbursement Fund.

16 G. All special plates issued by the Tax Commission prior to the
17 effective date of this act shall not be subject to the requirements
18 and qualifications outlined in this section.

19 H. As used in this section, "person" includes an individual,
20 group, organization or not-for-profit corporation that is recognized
21 as such by the Internal Revenue Service.

22 SECTION 9. This act shall become effective November 1, 2021.
