11 SECTION 2. AMENDATORY 11 O.S. 2021, Section 56-108, is
12 amended to read as follows:

13 Section 56-108. All candidates for municipal office and all
14 elected municipal officers shall be required to file a statement of
15 financial interests with the municipal clerk subject to the same
16 requirements as set forth for ~~candidates for state office required~~
17 ~~to file~~ statements of financial interests filed with the Ethics
18 Commission under Rules of the Ethics Commission promulgated pursuant
19 to Section 3 of Article XXIX of the Oklahoma Constitution, including
20 but not limited to time for filing and contents.

21 SECTION 3. AMENDATORY 19 O.S. 2021, Section 138.12, is
22 amended to read as follows:

23 Section 138.12 A. Definitions of terms used in the County
24 Campaign Finance and Financial Disclosure Act shall be the same as

1 those terms are defined in Rules of the Ethics Commission
2 promulgated pursuant to Section 3 of Article XXIX of the Oklahoma
3 Constitution, unless otherwise provided herein.

4 B. As used in the County Campaign Finance and Financial
5 Disclosure Act:

6 1. "Campaign committee" means a committee which may be composed
7 of one or more persons the purpose of which is to support the
8 election of a specific candidate to county office, whose name as it
9 will appear on the ballot shall appear in the name of the committee;

10 2. "County office" means any elective county office for which
11 Declarations of Candidacy are filed with the secretary of the county
12 election board as required by Section 5-103 of Title 26 of the
13 Oklahoma Statutes; and

14 3. "County political committee" means any committee composed of
15 **one** or more persons whose purpose includes the election or defeat of
16 one or more candidates for county office, or questions submitted to
17 a vote of the people at a county election, but which is not required
18 to register with the Ethics Commission or the Federal Election
19 Commission.

20 **SECTION 4.** AMENDATORY 70 O.S. 2021, Section 2-111, is
21 amended to read as follows:

22 Section 2-111. A. Definitions of terms used in the Technology
23 Center District and Independent School District Campaign Finance and
24 Financial Disclosure Act shall be the same as those terms are

1 defined in Rules of the Ethics Commission promulgated pursuant to
2 Section 3 of Article XXIX of the Oklahoma Constitution, unless
3 otherwise provided herein.

4 B. As used in the Technology Center District and Independent
5 School District Campaign Finance and Disclosure Act:

6 1. "Campaign committee" means a committee which may be composed
7 of one or more persons the purpose of which is to support the
8 election of a specific candidate to school district office, whose
9 name as it will appear on the ballot shall appear in the name of the
10 committee;

11 2. "School district" means a technology center district or an
12 independent school district;

13 3. "School district office" means any elective school district
14 office for which Declarations of Candidacy are filed with the
15 secretary of the county election board as required by Section 13A-
16 105 of Title 26 of the Oklahoma Statutes; and

17 4. "School district political committee" means any committee
18 composed of **one** or more persons whose purpose includes the election
19 or defeat of one or more candidates for school district office, or
20 questions submitted to a vote of the people at a school district
21 election, but which is not required to register with the Ethics
22 Commission or the Federal Election Commission.

23 **SECTION 5.** AMENDATORY 70 O.S. 2021, Section 2-117, is
24 amended to read as follows:

1 Section 2-117. All candidates for school district office and
2 all elected school district officers shall be required to file a
3 statement of financial interests with the school district clerk
4 subject to the same requirements as set forth for ~~candidates for~~
5 ~~state office required to file~~ statements of financial interests
6 filed with the Ethics Commission under Rules of the Ethics
7 Commission promulgated pursuant to Section 3 of Article XXIX of the
8 Oklahoma Constitution, including but not limited to time for filing
9 and contents.

10 **SECTION 6.** AMENDATORY 74 O.S. 2021, Section 4261, is
11 amended to read as follows:

12 Section 4261. The Ethics Commission shall design all forms
13 required for compliance with the County Campaign Finance and
14 Financial Disclosure Act, the Municipal Campaign Finance and
15 Financial Disclosure Act and the Technology Center District and
16 Independent School District Campaign Finance and Financial
17 Disclosure Act. Such forms shall be made available in electronic
18 form on the Commission's ~~Internet~~ website. Additionally, the Ethics
19 Commission shall develop online reporting processes for the
20 reporting of information required by the County Campaign Finance and
21 Financial Disclosure Act, the Municipal Campaign Finance and
22 Financial Disclosure Act, and the Technology Center District and
23 Independent School District Campaign Finance and Financial
24

1 Disclosure Act, as funds are available, to develop and maintain
2 online reporting.

3 **SECTION 7.** This act shall become effective November 1, 2022.
