8	An Act relating to schools; amending 70 O.S. 2021,			
9	Section 1210.284, which relates to vision screening; specifying that optometrists and ophthalmologists may			
10	perform screening; adding certain exemptions; and providing an effective date.

12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:			
13	SECTION 1. AMENDATORY 70 O.S. 2021, Section 1210.284, is			
14	amended to read as follows:			
15	Section 1210.284 A. 1. The parent or guardian of each student			
16	enrolled in kindergarten at a public school in this state shall			
17	provide certification to school personnel that the student passed a			
18	vision screening within the previous twelve (12) months or during			
19	the school year. Such screening shall be conducted by personnel			
20	listed on the statewide registry as maintained by the State			
21	Department of Health, which may include, but not be limited to,			
22	Oklahoma licensed optometrists and ophthalmologists.			
23	2. The parent or guardian of each student enrolled in first or			
24	third grade at a public school in this state shall provide within			

1	thirty (30) days of the beginning of the school year certification
2	to school personnel that the student passed a vision screening
3	within the previous twelve (12) months. Such screening shall be
4	conducted by personnel listed on the statewide registry as
5	maintained by the State Department of Health; provided, Oklahoma
6	licensed optometrists and ophthalmologists shall be exempt from such
7	standards.

- 3. The parent or guardian of each student who receives a vision screening as required by this section shall receive notification that a vision screening is not the equivalent of a comprehensive eye exam.
- B. 1. The Infant and Children's Health Advisory Council created in Section 44 of this act 1-103a.1 of Title 63 of the Oklahoma Statutes shall make recommendations to the State Board of Health on:
  - a. standards for vision screening and referral; provided,

    Oklahoma licensed optometrists and ophthalmologists

    shall be exempt from such standards,
  - p. qualifications for initial recognition and renewal of recognition of vision screeners,
  - c. qualifications for initial recognition and renewal of recognition of vision screener trainers,
  - d. qualifications for initial recognition and renewal of recognition of trainers of vision screener trainers;

  - C. 1. The parent or guardian of each student who fails the vision screening required in subsection A of this section shall receive a recommendation to undergo a comprehensive eye examination performed by an ophthalmologist or optometrist.
  - 2. The ophthalmologist or optometrist shall forward a written report of the results of the comprehensive eye examination to the student's school, parent or guardian, and primary health care provider designated by the parent or guardian. The report shall include, but not be limited to:
    - a. date of report,

- b. name, address and date of birth of the student,
- c. name of the student's school,
- d. type of examination,
- e. a summary of significant findings, including diagnoses, medication used, duration of action of medication, treatment, prognosis, whether or not a return visit is recommended and, if so when,

1	f. recommended educational adjustments for the child, if				
2	any, which may include: preferential seating in the				
3	classroom, eyeglasses for full-time use in school,				
4	eyeglasses for part-time use in school, sight-saving				
5	eyeglasses, and any other recommendations, and				
6	g. name, address and signature of the examiner.				
7	D. No student shall be prohibited from attending school for a				
8	parent's or guardian's failure to furnish a report of the student's				
9	vision screening or an examiner's failure to furnish the results of				
10	a student's comprehensive eye examination required by this section.				
11	E. School districts shall notify parents or guardians of				
12	students who enroll in kindergarten, first, or third grade for the				
13	2007-08 school year and each year thereafter of the requirements of				
14	this section.				
15	F. The State Board of Education shall adopt rules for the				
16	implementation of this section except as provided in subsection B of				
17	this section. The State Department of Education shall issue a				
18	report annually on the impact and effectiveness of this section.				
19	SECTION 2. This act shall become effective November 1, 2022.
