14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 4300 of Title 59, unless there
17	is created a duplication in numbering, reads as follows:
18	This act shall be known and may be cited as the "Oklahoma Home-
19	based Business Fairness Act".
20	SECTION 2. NEW LAW A new section of law to be codified
21	in the Oklahoma Statutes as Section 4300.1 of Title 59, unless there
22	is created a duplication in numbering, reads as follows:
23	A. For purposes of this section:

1 1. "Goods" means any merchandise, equipment, products, supplies or materials; 3 2. "Home-based business" means any business for the manufacture, provision or sale of goods or services that is owned 4 5 and operated by the owner or tenant of the residential dwelling; and "No-impact home-based business" means a home-based business 6 7 for which the following apply: the total number of on-site employees and clients do 8 9 not exceed the municipal occupancy limit for the residential property, and 10 the business activities are characterized by all of 11 b. 12 the following: (1) are limited to the sale of lawful goods and 13 services, 14 15 (2) do not generate on-street parking or a substantial increase in traffic through the 16 residential area, 17 (3) occur inside the residential dwelling or in the 18 yard, and 19 (4) are not visible from the street. 20 The use of a residential dwelling for a home-based business 21

is a permitted use, except that this permission does not supersede

any of the following:

- 1. Any deed restriction, covenant or agreement restricting the use of land including, but not limited to, a property lease agreement; or
  - 2. Any master deed or other document applicable to a common interest ownership community including, but not limited to, a homeowner association (HOA).
  - C. A municipality shall not prohibit a no-impact home-based business or otherwise require a person to apply, register or obtain any permit, license, variance or other type of prior approval from the municipality to operate a no-impact home-based business.
  - D. A municipality may establish reasonable regulations for a home-based business if the regulations are narrowly tailored for any of the following purposes:
  - 1. The protection of the public health and safety including rules and regulations related to fire and building codes, health and sanitation, transportation or traffic control, solid or hazardous waste, pollution and noise control;
    - 2. Ensuring that the business activity is:
      - a. compatible with residential use of the property and surrounding residential use,
      - b. secondary to the use as a residential dwelling, or
      - c. complying with state and federal law and paying applicable taxes; or

1 3. Limiting or prohibiting the use of a home-based business for the purposes of selling illegal drugs, liquor, operating or 2 maintaining a structured sober living home, pornography, obscenity, 3 nude or topless dancing and other adult-oriented businesses. 4 5 E. A municipality shall not require a person as a condition of operating a home-based business to: 6 7 1. Rezone the property for commercial use; or Install or equip fire sprinklers in a single family detached 8 9 residential dwelling or any residential dwelling with not more than 10 two dwelling units. The question of whether a regulation complies with this 11 12 section shall be a judicial question, and the municipality that 13 enacted the regulation shall establish by clear and convincing evidence that the regulation complies with this section. 14 SECTION 3.
