12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY Section 1, Chapter 17, O.S.L. 2017
14	(47 O.S. Supp. 2020, Section 2-108.5), is amended to read as
15	follows:
16	Section 2-108.5. A. 1. There is hereby created the Oklahoma
17	State Award Program Committee. The purpose of the Committee is to
18	create, establish eligibility requirements and make recommendation
19	for awarding the Oklahoma Medal of Valor for meritorious service $\underline{,}$
20	the Oklahoma Distinguished Meritorious Service Medal for extended
21	exemplary service to the state and the Oklahoma Purple Heart for
22	serious line of duty injuries for law enforcement and public safety
23	members employed by municipal, county, state and employees of
24	federal agencies working in Oklahoma.

1 2. There is hereby established the Oklahoma Medal of Valor, the 2 Oklahoma Distinguished Meritorious Service Medal and the Oklahoma 3 Purple Heart, along with authorized appurtenances, for award by the Governor, in the name of the state, to any person who has 4 5 demonstrated meritorious achievement, or a distinct act of courage, 6 shown distinguished meritorious service to the state over an 7 extended period of service or who has incurred injury or wounds, while performing or actively engaged in public service activities. 8 9 The Oklahoma Purple Heart is limited to law enforcement and public 10 safety members employed by municipal, county, state and employees of 11 federal agencies working in Oklahoma.

The purpose of each award is to formally recognize
 extraordinary acts of valor by public safety members and citizens of
 Oklahoma who engage in extraordinary acts of bravery and valor and
 to formally recognize public safety members in Oklahoma who have
 been seriously injured in the line of duty <u>and to acknowledge the</u>
 distinguished meritorious service of citizens to the state.

B. The members of the Oklahoma State Award Program (OSAP)
Committee shall have experience in the field of public safety and
public service. The OSAP Committee shall be composed of nine (9)
members as follows:

The Lieutenant Governor, who shall serve as chair;
 The Adjutant General of the Oklahoma National Guard;
 The Commissioner of the Department of Public Safety;

 5. The Director of the Department of Transportation;
 6. The President of the Oklahoma Sheriffs' Association;
 7. The President of the Oklahoma Association of Chiefs of
 Police;

8. The President of the Oklahoma State Firefighters7 Association; and

8 9. The President of the Oklahoma Sheriffs and Peace Officers9 Association.

C. Except at any meeting to select recipients of the Oklahoma 10 11 Medal of Valor and, the Oklahoma Distinguished Meritorious Service 12 Medal or the Oklahoma Purple Heart, each member, other than the chair, may be represented by a designee; provided, the designee must 13 be an active member in good standing with the agency or association 14 to which the appointed member belongs. The Chairman reserves the 15 right to appoint an advisory board to collect, review and make 16 initial award recommendations to the OSAP committee. The advisory 17 board will be comprised of designees from the nine-member OSAP 18 committee. 19

D. The Committee shall conduct its first meeting no later than ninety (90) calendar days after the appointment of the last member. The Committee shall meet at the direction of the chair, and shall normally meet not less than once each year and not more than three times each year.

 conduct business.

The members of the Committee shall serve without 3 F. compensation, except that the members may be reimbursed for 4 5 reasonable and necessary expenses arising from Committee activities or business. Such expenses shall be paid by the respective agencies 6 at which the member is employed at the time the expense is incurred. 7 G. No member of the OSAP Committee shall solicit, seek or 8 9 request individuals to submit individuals for awards. OSAP 10 Committee members may explain the program to interested individuals. 11 The Committee may secure directly from any department or agency such 12 information as the Committee deems necessary to carry out its 13 duties.

H. The Commissioner of the Department of Public Safety shallpromulgate rules to establish the following:

Design of the Oklahoma Medal of Valor, the Oklahoma
 <u>Distinguished Meritorious Service Medal</u> and the Oklahoma Purple
 Heart and any authorized appurtenances proposed by the Adjutant
 General;

Criteria for eligibility for award of the Oklahoma Medal of
 Valor and, the Oklahoma Distinguished Meritorious Service Medal or
 the Oklahoma Purple Heart proposed by the Adjutant General;

3. Criteria for the proper wear of the Oklahoma Medal of Valor
 and, the Oklahoma Distinguished Meritorious Service Medal or the
 Oklahoma Purple Heart proposed by the Adjutant General;

4 4. Method of purchasing the Oklahoma Medal of Valor and, the
5 Oklahoma Distinguished Meritorious Service Medal or the Oklahoma
6 Purple Heart;

7 5. Order of precedence relating to other state awards; and
8 6. Other rules deemed necessary to carry out the provisions of
9 this act section.

I. The Committee shall consider candidates for award for the
 Oklahoma Medal of Valor and, the Oklahoma Distinguished Meritorious
 <u>Service Medal or</u> the Oklahoma Purple Heart only from the
 applications received. The OSAP Committee may go into executive
 session to deliberate and select recommended recipients. The Chair
 shall present to the Governor the names of recommendations as Medal
 recipients.

J. The Committee shall not disclose any information which may compromise an ongoing law enforcement investigation or information that is otherwise required by law to be kept confidential. Only the final recommendation for receipt of the Oklahoma Medal of Valor, the <u>Oklahoma Distinguished Service Medal</u> and the Oklahoma Purple Heart shall be subject to the Oklahoma Open Records Act.

K. The Oklahoma Medal of Valor, the Oklahoma Distinguished
 <u>Service Medal</u> and the Oklahoma Purple Heart may not be awarded to
 any person who was not selected by the Committee.

L. The award of the Oklahoma Medal of Valor<u>, the Oklahoma</u> <u>Distinguished Service Medal</u> and the Oklahoma Purple Heart may be rescinded for suitable cause. The Chair, with the consent of the Committee, shall forward the recommendation for rescission to the Governor. The final decision to rescind must be approved by the Governor.

10 Μ. The Oklahoma Medal of Valor and, the Oklahoma Distinguished 11 Service Medal or the Oklahoma Purple Heart may be awarded 12 posthumously and may be presented to such representative of the 13 deceased's family as may be deemed appropriate by the Governor.
