	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. There is hereby appropriated to the Oklahoma Tourism
16	and Recreation Department from any monies not otherwise appropriated
17	from the General Revenue Fund of the State Treasury for the fiscal
18	year ending June 30, 2022, the sum of One Hundred Thousand Dollars
19	(\$100,000.00) or so much thereof as may be necessary to perform the
20	duties imposed upon the Oklahoma Tourism and Recreation Department
21	by law.
22	SECTION 2. Appropriations made by this act, not including
23	appropriations made for capital outlay purposes, may be budgeted for
24 27	the fiscal year ending June 30, 2022 (hereafter FY-22), or may be

1 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23). 2 Funds budgeted for FY-22 may be encumbered only through June 30, 3 2022, and must be expended by November 15, 2022. Any funds 4 remaining after November 15, 2022, and not budgeted for FY-23, shall 5 lapse to the credit of the proper fund for the then current fiscal 6 year. Funds budgeted for FY-23 may be encumbered only through June 7 30, 2023. Any funds remaining after November 15, 2023, shall lapse 8 to the credit of the proper fund for the then current fiscal year. 9 These appropriations may not be budgeted in both fiscal years 10 simultaneously. Funds budgeted in FY-22 and not required to pay 11 obligations for that fiscal year, may be budgeted for FY-23, after 12 the agency to which the funds have been appropriated has prepared 13 and submitted a budget work program revision removing these funds 14 from the FY-22 budget work program and after such revision has been 15 approved by the Office of Management and Enterprise Services. 16 SECTION 3.
