As used in the Delayed Sentencing Program for 17 Young Adults: 18 "Offender" means any adult eighteen (18) through twenty-one (21) 19 twenty-five (25) years of age as of the date of a verdict of guilty 20 or a plea of guilty or nolo contendere for a nonviolent felony 21 offense or a juvenile who has been certified to stand trial as an 22 adult for a nonviolent felony offense, who has no charges pending 23 for a violent offense and who has not been convicted sentenced, or 24

adjudicated as a juvenile delinquent or youthful offender, of:
