Supp. 2020, Section 332.18), which relates to placement on docket for 9 parole consideration; modifying qualifying conditions; providing definitions; and providing an 10 effective date. 11 12 13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 14 57 O.S. 2011, Section 332.18, as SECTION 1. AMENDATORY 15 last amended by Section 1, Chapter 42, O.S.L. 2015 (57 O.S. Supp. 16 2020, Section 332.18), is amended to read as follows: 17 Section 332.18. A. The Director of the Department of 18 Corrections shall have the authority to request the Executive 19 Director of the Pardon and Parole Board to place an inmate on the 20 Pardon and Parole Board docket for a medical reason, out of the 21 normal processing procedures. Documentation of the medical 22 condition of such inmate shall be certified by the medical director 23 of the Department of Corrections. The Pardon and Parole Board shall

have the authority to bring any such inmate before the Board at any time, except as otherwise provided in subsection B of this section.

- B. When a request is made for a medical parole review of an inmate who is dying or is near death, or medically frail or medically vulnerable as defined in subsection F of this section and as certified by the medical director of the Department of Corrections or whose medical condition has rendered the inmate no longer an unreasonable threat to public safety, the Executive Director shall place such inmate on the first available parole review docket for a compassionate parole consideration. Inmates who meet the criteria set out in this section are not subject to the two-stage hearing process in subsection C of Section 332.7 of this title.
- C. No person shall be eligible for consideration for medical parole without the concurrence of at least three members of the Pardon and Parole Board. The vote on whether or not to consider such person for parole and the names of the concurring Board members shall be set forth in the written minutes of the meeting of the Board at which the issue is considered.
- D. In the event that due to changes in the medical condition of the parolee granted medical parole or for other reasons, it is determined that the continuation of the medical parole presents an increased risk to the public, the parolee shall be subject to parole revocation. In such case, the Department of Corrections shall

follow the revocation procedure for violators of parole set forth in Section 516 of this title. E. The provisions of this section shall not apply to inmates serving a sentence of life without possibility of parole. F. Definitions: 1. "Medically frail" means an individual with a medical condition who cannot perform two or more activities of daily living on their own; 2. "Medically vulnerable" means an individual with one or more medical conditions which makes the individual more likely to contract an illness or disease in prison that could lead to death or cause an individual to become medically frail; 3. "Medical condition" includes, but is not limited to, the following: disabling mental disorders including dementia, a. Alzheimer's disease, or similar degenerative brain disorders, Human Immunodeficiency Virus (HIV) or Acquired Immune b. Deficiency Syndrome (AIDS), cancer, C. cardiovascular disease, d. chronic lung disease or asthma, е. f. diabetes, Hepatitis C, g.
