12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 70 O.S. 2011, Section 22-108, is
14	amended to read as follows:
15	Section 22-108. A. Each audit of the financial statements of a
16	school district required by the Oklahoma Public School Audit Law
17	shall be completed and the auditor's opinion thereon shall be
18	submitted by the firm to the district board of education within nine
19	(9) months after the close of the fiscal year of the district board
20	of education.
21	B. One copy of the auditor's opinions and related financial
22	statements shall be maintained by the district board of education as
23	a public record for public inspection at all reasonable times at the
24	office of the district board of education. <u>A copy or a hyperlink to</u>

1 <u>a copy of the most recent audit shall be posted on the school</u> 2 <u>district website for public inspection.</u> All records shall be kept 3 at least five (5) years.

The district board of education shall forward a copy of the 4 С. 5 auditor's opinions and related financial statements to the State Board of Education and the State Auditor and Inspector within thirty 6 7 (30) days after receipt of the audit. The State Board of Education shall retain such copy in its office as a public record where it 8 9 shall be available for public inspection at all reasonable times. 10 D. The State Board of Education may make inquiries it deems 11 necessary to determine that each district board of education is 12 properly complying with the Oklahoma Public School Audit Law. Ιf 13 within eleven (11) months after the end of the fiscal year of the 14 school district a copy of the auditor's opinions and related 15 financial statements has not been received by the State Board of 16 Education and by the State Auditor and Inspector, an inquiry shall 17 be made by the State Auditor and Inspector as to why such auditor's 18 opinions and related financial statements have not been filed, 19 pursuant to the provisions of Section 212A of Title 74 of the 20 Oklahoma Statutes. Should the State Auditor and Inspector find that 21 the district board of education has failed to cause an annual audit 22 of the financial statements and compliance requirements of the 23 school district to be commenced, the State Auditor and Inspector 24 shall make a written demand on the board to complete and file such

2	of the school district within thirty (30) days of the date of such
3	demand.
4	SECTION 2. This act shall become effective November 1, 2021.
