| 15 | Section 3-101. A. The State Board of Education shall consist |
| 16 | of seven (7) members. The State Superintendent of Public |

| 17 | Instruction shall be a member and the chairperson of the Board. The |
| 18 | remaining six members shall be appointed by the Governor by and with |
| 19 | the advice and consent of the Senate. Except as otherwise provided |
| 20 | for in subsection B of this section, upon assuming office each |

| 22 | and one member from the state at large. Each appointment shall be |

The Governor shall make initial appointments pursuant 2 to the provisions of this subsection within thirty (30) days of the 3 effective date of this act, with one member appointed from each 4 congressional district and one member appointed from the state at 5 large. The appointments shall be subject to confirmation by the Senate at the next session of the Legislature. The terms for 6 7 members appointed pursuant to this subsection serving on November 1, 2021, shall terminate on April 2, 2015 2023. Thereafter, members 8 9 shall be appointed as provided for in subsection A of this section. 10 C. No person shall be eligible to be appointed to serve on the 11 State Board unless the person has been awarded a high school diploma 12 or certificate of high school equivalency. Any member appointed to 13 the State Board shall complete the workshop requirements of a new 14 school board member pursuant to Section 5-110 of this title within 15 thirteen (13) months following or preceding the appointment of the 16 member. Notwithstanding any provision of law to the contrary, the 17 State Department of Education shall not charge any member of the 18 State Board of Education a fee for any workshop provided by the 19 Department for board members pursuant to Section 5-110 of this title 20 and shall not pay a fee to any organization or institution of higher 21 education on behalf of a member of the State Board of Education, or 22 reimburse any member of the Board for a fee paid to any organization 23 or institution of higher education, for attendance at a workshop or 24 courses to satisfy the requirements of Section 5-110 of this title.
