HOUSE BILL 2176

AS INTRODUCED

An Act relating to schools; amending 70 O.S. 2011, Section 13-101.2, as last amended by Section 1, Chapter 1, O.S.L. 2020 (70 O.S. Supp. 2020, Section 13-101.2), which relates to the Lindsey Nicole Henry Scholarships for Students with Disabilities Program; modifying eligibility for adopted student; including additional disability weights in funding calculation if student is reevaluated; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 70 O.S. 2011, Section 13-101.2, as last amended by Section 1, Chapter 1, O.S.L. 2020 (70 O.S. Supp. 2020, Section 13-101.2), is amended to read as follows:

Section 13-101.2 A. There is hereby created the Lindsey Nicole Henry Scholarships for Students with Disabilities Program. The Lindsey Nicole Henry Scholarships for Students with Disabilities Program is established to provide a scholarship to a private school of choice for students with disabilities for whom an individualized education program (IEP) in accordance with the Individuals with Disabilities Education Act (IDEA) or an individualized service plan pursuant to Section 1-4-704 of Title 10A of the Oklahoma Statutes

1 has been developed at any time prior to notifying the State
2 Department of Education of the intent to participate in the Program
3 and the IEP is in effect at the time the request for a scholarship
4 is received by the State Department of Education. Scholarships
5 shall be awarded beginning with the 2010-2011 school year.

6 B. The parent or legal guardian of a public school student with
7 a disability may exercise their parental option and request to have
8 a Lindsey Nicole Henry Scholarship awarded for the child to enroll
9 in and attend a private school in accordance with this section and
10 the scholarship shall be awarded if:

11 1. The student has spent the prior school year in attendance at
12 a public school in this state. For purposes of this section, "prior
13 school year in attendance" means that the student was enrolled in
14 and reported by a school district for funding purposes during the
15 preceding school year regardless of whether or not the student had
16 an IEP at the time the student was counted for funding purposes. A
17 student who is a child of a member of the United States Armed Forces
18 who transfers to a school in this state from out of state or from a
19 foreign country pursuant to a permanent change of station orders of
20 the parent shall be exempt from the requirements of this paragraph
21 but shall be required to meet all other eligibility requirements to
22 participate as provided for in this section. A student who has been
23 provided services under an Individual Family Service Plan through
24 the SoonerStart program and during transition was evaluated and

1 determined to be eligible for school district services shall be
2 exempt from the requirements of this paragraph but shall be required
3 to meet all other eligibility requirements to participate as
4 provided for in this section. A student who was in out-of-home
5 placement with the Department of Human Services, who was adopted
6 ~~while in the permanent custody of the Department of Human Services~~
7 or who was in out-of-home placement with the Office of Juvenile
8 Affairs shall be exempt from the requirements of this paragraph but
9 shall be required to meet all other eligibility requirements to
10 participate as provided for in this section; and

11 2. The parent or legal guardian has obtained acceptance for
12 admission of the student to a private school that is eligible for
13 the program as provided in subsection H of this section and has
14 notified the State Department of Education of the request for a
15 scholarship. Requests to participate in the program made after
16 December 1 shall be granted, but funding for scholarships requested
17 after December 1 shall not be available until the beginning of the
18 next school year. The request shall be through a communication
19 directly to the Department in a manner that creates a written or
20 electronic record of the request and the date of receipt of the
21 request. The Department shall notify the school district upon
22 receipt of the request. For purposes of continuity of educational
23 choice, the scholarship shall remain in force until the student
24 returns to a public school, graduates from high school or reaches

1 the age of twenty-two (22), whichever occurs first. At any time,
2 the parent or legal guardian of the student may remove the student
3 from the private school and place the student in another private
4 school that is eligible for the program as provided in subsection H
5 of this section or place the student in a public school.

6 C. A student shall be eligible for a scholarship if the parent
7 or legal guardian of the student made a request for a scholarship
8 for the 2010-2011 school year and the student transferred to an
9 eligible private school but was subsequently denied a scholarship
10 because the student did not have an IEP in effect on October 1,
11 2009, but did meet all other eligibility requirements as set forth
12 in the Lindsey Nicole Henry Scholarships for Students with
13 Disabilities Program Act.

14 D. A student shall not be eligible for a Lindsey Nicole Henry
15 Scholarship if the student is not having regular and direct contact
16 with the private school teachers at the physical location of the
17 private school.

18 E. School districts shall notify the parent or legal guardian
19 of a public school student with a disability of all options
20 available pursuant to this section and inform the parent or legal
21 guardian of the availability of information about the program from
22 the State Department of Education through the toll-free telephone
23 number or website. The notification shall be provided with or
24 included in the copy of the "Parents Rights in Special Education:

1 Notice of Procedural Safeguards" document given to parents at least
2 annually or as otherwise required by law.

3 F. 1. Acceptance of a Lindsey Nicole Henry Scholarship shall
4 have the same effect as a parental revocation of consent to service
5 pursuant to 20 U.S.C., Sections 1414(a)(1)(D) and 1414(C) of the
6 IDEA.

7 2. Upon acceptance of a Lindsey Nicole Henry Scholarship, the
8 parent or legal guardian shall assume full financial responsibility
9 for the education of the student, including but not limited to
10 transportation to and from the private school.

11 G. If the parent or legal guardian requests a Lindsey Nicole
12 Henry Scholarship and the student is accepted by the private school
13 pending the availability of a space for the student, the parent or
14 legal guardian of the student shall notify the State Department of
15 Education before entering the private school and before December 1
16 in order to be eligible for the scholarship during the school year
17 when a space becomes available for the student in the private
18 school. If notification is made after December 1, payment of the
19 scholarship shall not begin until the next school year.

20 H. 1. To be eligible to participate in the Lindsey Nicole
21 Henry Scholarships for Students with Disabilities Program, a private
22 school shall notify the State Department of Education of its intent
23 to participate. The notice shall specify the grade levels and
24 services that the private school has available for students with

1 disabilities who are participating in the scholarship program. The
2 State Department of Education shall approve a private school as
3 eligible to participate in the scholarship program upon
4 determination that the private school:

5 a. meets the accreditation requirements set by the State
6 Board of Education or another accrediting association
7 approved by the State Board of Education. The State
8 Department of Education shall list on its website all
9 accrediting associations approved by the Board,

10 b. demonstrates fiscal soundness by having been in
11 operation for one (1) school year or providing the
12 State Department of Education with a statement by a
13 certified public accountant confirming that the
14 private school desiring to participate is insured and
15 the owner or owners have sufficient capital or credit
16 to operate the school for the upcoming year by serving
17 the number of students anticipated with expected
18 revenues from tuition and other sources that may be
19 reasonably expected. In lieu of a statement, a surety
20 bond or letter of credit for the amount equal to the
21 scholarship funds for any quarter may be filed with
22 the Department,

23 c. complies with the antidiscrimination provisions of 42
24 U.S.C., Section 2000d,

- d. meets state and local health and safety laws and codes,
- e. will be academically accountable to the parent or legal guardian for meeting the educational needs of the student,
- f. employs or contracts with teachers who hold baccalaureate or higher degrees, or have at least three (3) years of teaching experience in public or private schools, or have special skills, knowledge, or expertise that qualifies them to provide instruction in subjects taught,
- g. complies with all state laws relating to general regulation of private schools, and
- h. adheres to the tenets of its published disciplinary procedures prior to the expulsion of a scholarship student.

2. Upon approval of a private school, the State Department of Education shall provide on its website all information and material submitted by the private school with its application.

I. 1. Lindsey Nicole Henry Scholarship Program participants shall comply with the following:

- a. the parent or legal guardian shall select the private school from the schools approved for eligibility

1 pursuant to subsection H of this section and apply for
2 the admission of the child,

3 b. the parent or legal guardian shall request the
4 scholarship no later than December 1 of the school
5 year during which the scholarship is requested,

6 c. any student participating in the scholarship program
7 shall attend throughout the school year, unless
8 excused by the school for illness or other good cause,
9 and shall comply fully with the code of conduct for
10 the school,

11 d. the parent or legal guardian shall fully comply with
12 the parental involvement requirements of the private
13 school, unless excused by the school for illness or
14 other good cause, and

15 e. upon issuance of a scholarship warrant, the parent or
16 legal guardian to whom the warrant is made shall
17 restrictively endorse the warrant to the private
18 school for deposit into the account of the private
19 school. The parent or legal guardian may not
20 designate any entity or individual associated with the
21 private school as the attorney in fact for the parent
22 or legal guardian to endorse a warrant. A parent or
23 legal guardian who fails to comply with this
24 subparagraph shall forfeit the scholarship.

1 2. A participant who fails to comply with this subsection
2 forfeits the scholarship.

3 J. Provisions governing payment of a Lindsey Nicole Henry
4 Scholarship shall be as follows:

5 1. The State Department of Education shall calculate the total
6 cost of all scholarships for all eligible students in the state.

7 The State Department of Education shall then reserve or retain from
8 the total amount appropriated to the State Board of Education for
9 State Aid purposes and any other revenue available for allocation
10 for State Aid purposes the total cost for all scholarship payments;

11 2. The maximum scholarship granted for an eligible student with
12 disabilities shall be a calculated amount equivalent to the total
13 State Aid factors for the applicable school year multiplied by the
14 grade and disability weights generated by that student for the
15 applicable school year. The disability weights used in calculating
16 the scholarship amount shall include all disability weights which
17 correspond to the disabilities included in the multidisciplinary
18 evaluation and eligibility group summary for the student at the time
19 the request for a scholarship is made by the parent or legal
20 guardian as well as any additional disability weights which
21 correspond to disabilities included in a reevaluation of the student
22 as requested by the parent or legal guardian and conducted by a
23 public school. The maximum scholarship amount shall be calculated
24

1 by the State Board of Education for each year the student is
2 participating in the scholarship program;

3 3. The amount of the scholarship shall be the amount calculated
4 in paragraph 2 of this subsection or the amount of tuition and fees
5 for the private school, whichever is less, minus up to two and one-
6 half percent (2 1/2%) of the scholarship amount which may be
7 retained by the State Department of Education as a fee for
8 administrative services rendered. The amount of any assessment fee
9 required by the private school and the amount associated with
10 providing services and therapies to address the disabilities of the
11 student may be paid from the total amount of the scholarship. The
12 amount of the scholarship shall be prorated to reflect the number of
13 days remaining in the current school year, if the scholarship
14 request is granted after the beginning of the school year;

15 4. The State Department of Education shall notify the private
16 school of the amount of the scholarship within ten (10) days after
17 receiving the request for a scholarship, when the total State Aid
18 factors have been determined for the current fiscal year. The
19 initial payment shall be made after the Department verifies
20 admission acceptance and enrollment. Quarterly payments shall be
21 made upon verification of continued enrollment and attendance at the
22 private school. Payment shall be made by the Department with an
23 individual warrant made payable to the parent or legal guardian of
24 the student and mailed by the Department to the private school that

1 the parent or legal guardian chooses. The parent or legal guardian
2 shall restrictively endorse the warrant to the private school for
3 deposit into the account of the private school;

4 5. The State Department of Education shall not be responsible
5 for any additional costs associated with special education and
6 related services incurred by the private school for the student
7 including the cost of teachers, equipment, material, and special
8 costs associated with the special education class;

9 6. The State Department of Education shall establish a toll-
10 free telephone number or website that provides parents or legal
11 guardians and private schools with information about the program;

12 7. The State Department of Education shall require an annual,
13 notarized, sworn compliance statement by participating private
14 schools certifying compliance with state laws and shall retain all
15 records received from a participating private school. The State
16 Department of Education shall post on its website the annual
17 compliance statement for each participating private school; and

18 8. The State Department of Education shall cross-check the list
19 of participating scholarship students with the public school
20 enrollments prior to each scholarship payment to avoid duplication.

21 K. 1. The State Superintendent of Public Instruction shall
22 deny, suspend, or revoke the participation of a private school in
23 the scholarship program if it is determined that the private school
24 has failed to comply with the provisions of this section. However,

1 in instances in which the noncompliance is correctable within a
2 reasonable amount of time and in which the health, safety, or
3 welfare of the students is not threatened, the Superintendent may
4 issue a notice of noncompliance which shall provide the private
5 school with a time frame within which to provide evidence of
6 compliance prior to taking action to suspend or revoke participation
7 in the scholarship program.

8 2. If the Superintendent intends to deny, suspend, or revoke
9 the participation of a private school in the scholarship program,
10 the Department shall notify the private school of the proposed
11 action in writing by certified mail and regular mail to the private
12 school's address of record with the Department. The Department
13 shall also notify any parents or legal guardians of scholarship
14 students attending the private school. The notification shall
15 include the reasons for the proposed action and notice of the
16 timelines and procedures set forth in this subsection.

17 3. The private school that is adversely affected by the
18 proposed action shall have fifteen (15) days from receipt of the
19 notice of proposed action to file with the Department a request for
20 an administrative hearing proceeding pursuant to the Administrative
21 Procedures Act.

22 4. Upon receipt of a request for a hearing, the State Board of
23 Education shall commence a hearing within sixty (60) days after the
24

1 receipt of the formal written request and enter an order within
2 thirty (30) days after the hearing.

3 5. The Board may immediately suspend payment of scholarship
4 funds if it is determined that there is probable cause to believe
5 that there is an imminent threat to the health, safety, or welfare
6 of the students or fraudulent activity on the part of the private
7 school.

8 L. No liability shall arise on the part of the state, the State
9 Board of Education, the State Department of Education or a school
10 district based on the award or use of any scholarship provided
11 through the Lindsey Nicole Henry Scholarships for Students with
12 Disabilities Program.

13 M. The inclusion of private schools within options available to
14 public school students in Oklahoma shall not expand the regulatory
15 authority of the state or any school district to impose any
16 additional regulation of private schools beyond those reasonably
17 necessary to enforce the requirements expressly set forth in this
18 section.

19 N. If the State Department of Education determines that a
20 school district prior to the effective date of this act has failed
21 to comply with the provisions of the Lindsey Nicole Henry
22 Scholarships for Students with Disabilities Program Act and has
23 failed to make full or partial scholarship payments for eligible
24 students, the Department shall have authority to reduce the amount

1 of State Aid allocated to the school district or require the school
2 district to make repayment to the Department of State Aid
3 allocations in an amount equal to the amount of scholarship payments
4 the school district failed to make. The Department shall make
5 payment to the parent or legal guardian in the amount the school
6 district failed to make in the manner as provided for in subsection
7 J of this section.

8 O. The State Department of Education shall annually prepare and
9 post on its website a report of Lindsey Nicole Henry Scholarships
10 for Students with Disabilities Program. The annual report shall
11 include, but not be limited to, the following information:

12 1. The total number and amount of scholarships awarded and
13 reported for each participating private school;

14 2. The total number of scholarships denied;

15 3. The total number and amount of scholarship payments
16 suspended for each participating private school; and

17 4. Data on participating students, disaggregated by years of
18 participation in the program, grade level, economically
19 disadvantaged status, racial and ethnic groups and disability
20 category.

21 SECTION 2. This act shall become effective November 1, 2021.
