6 AS INTRODUCED

7 An Act relating to appropriations; making
8 appropriations to the Court of Criminal Appeals,
9 District Attorneys Council, and Supreme Court;
10 stating amounts; stating purposes; providing an
11 effective date; and declaring an emergency.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. There is hereby appropriated to the Court of
14 Criminal Appeals from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2022, the sum of Four Million Twenty-two Thousand
17 Seven Hundred Seven Dollars (\$4,022,707.00) or so much thereof as
18 may be necessary to perform the duties imposed upon the Court of
19 Criminal Appeals by law.

20 SECTION 2. There is hereby appropriated to the District
21 Attorneys Council from any monies not otherwise appropriated from
22 the General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2022, the sum of Sixty-nine Million Thirty-one
24 Thousand Three Hundred Seventy-nine Dollars (\$69,031,379.00) or so

1 much thereof as may be necessary to perform the duties imposed upon
2 the District Attorneys Council by law.

3 SECTION 3. There is hereby appropriated to the Supreme Court
4 from any monies not otherwise appropriated from the General Revenue
5 Fund of the State Treasury for the fiscal year ending June 30, 2022,
6 the sum of Sixty-nine Million Nine Hundred Eighty Thousand Three
7 Hundred Sixty-one Dollars (\$69,980,361.00) or so much thereof as may
8 be necessary to perform the duties imposed upon the District Courts
9 by law.

10 SECTION 4. There is hereby appropriated to the Supreme Court
11 from any monies not otherwise appropriated from the General Revenue
12 Fund of the State Treasury for the fiscal year ending June 30, 2022,
13 the sum of Eighteen Million Nine Hundred Sixty-eight Thousand Nine
14 Hundred Sixty-five Dollars (\$18,968,965.00) or so much thereof as
15 may be necessary to perform the duties imposed upon the Supreme
16 Court or Court of Civil Appeals by law.

17 SECTION 5. This act shall become effective July 1, 2021.

18 SECTION 6. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
