BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1743 of Title 21, unless there is created a duplication in numbering, reads as follows:

AS INTRODUCED

An Act relating to crimes and punishments; making certain acts unlawful; providing penalties; presuming that certain property has been stolen or wrongfully

obtained; allowing presumption to be rebutted by

proof; providing list of circumstances to consider when inquiring about certain property; providing an

exception; defining term; providing for codification;

A. Any person who shall receive, transport, or possess in this state one or multiple stolen automotive catalytic converters or the components thereof under such circumstances that the person knew or should have known that the same was stolen shall, upon conviction, be guilty of a felony and shall be punished by imprisonment in the custody of the Department of Corrections for a term of not less than one (1) year nor more than five (5) years, or confined in the county jail for a term of not less than ninety (90) days nor more than two

hundred (200) days, or fined not less than One Hundred Dollars (\$100.00) nor more than Five Hundred Dollars (\$500.00), or by both such fine and imprisonment.

- B. Every person who, without making reasonable inquiry, buys, receives, conceals, withholds, or aids in concealing or withholding an automotive catalytic converter which has been stolen, embezzled, obtained by false pretense, or robbery, or otherwise feloniously obtained, under such circumstances as should cause such person to make reasonable inquiry to ascertain that the person from whom such property was bought or received had the legal right to sell or deliver the property, shall be presumed to have bought or received such property knowing it to have been so stolen or wrongfully obtained. This presumption may, however, be rebutted by proof.
- C. As provided for in subsection B of this section, circumstances causing a person to make such a reasonable inquiry to ascertain that the person from whom the property is bought or received has the legal right to sell or deliver said property shall include, but not be limited to, the presence of rough, uneven pipe edges indicating said automotive catalytic converter was cut from a vehicle and a lack of documentation regarding the original sale, purchase, or ownership of said automotive catalytic converter.
- D. The provisions of this section shall not apply to automotive catalytic converters in use and attached to a vehicle.
