- 1 Community schools offer evidence-based pathways by providing 2 tailored services before, during, and after school.
 - B. The State Board of Education may assist, and if funding is available, award grants to, local school boards of education to establish pilot projects that create community schools within a school district or at a school site. Projects may involve entire districts, individual school sites, a combination of school sites, or elements of school sites individually or in combination.
 - C. Pilot project plans for community schools shall contain the following minimum elements:
 - 1. A person designated as the Community School Coordinator;
 - 2. A comprehensive needs assessment process that includes the following stakeholders:
 - a. parents,

- b. community leaders,
- c. teachers,
- d. site and district administrators,
- e. other education employees, and
- f. students, where age appropriate;
