11 An Act relating to the Oklahoma Department of Mines;
12 making an appropriation; providing an amount;
13 providing purpose; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Oklahoma
17 Department of Mines from any monies not otherwise appropriated from
18 the General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2021, the sum of Two Hundred Fifty-one Thousand
20 Sixty-eight Dollars (\$251,068.00) or so much thereof as may be
21 necessary to perform the duties imposed upon the Oklahoma Department
22 of Mines by law.

23 SECTION 2. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
