There is hereby appropriated to the Progressing 19 Rural Economic Prosperity Fund created pursuant to Enrolled House 20 Bill No. 4456 of the 2nd Session of the 58th Oklahoma Legislature 21 from any monies not otherwise appropriated from the General Revenue 22 Fund of the State Treasury for the fiscal year ending June 30, 2021, 23 the sum of Two Hundred Fifty Million Dollars (\$250,000,000.00) to be 24 budgeted and expended in accordance with law.

SECTION 2. This act shall become effective July 1, 2022. SECTION 3.
