18	the 2nd Session of the 58th Oklahoma Legislature from any monies not						
19	otherwise appropriated from the General Revenue Fund of the State						
20	Treasury for the fiscal year ending June 30, 2021, the sum of One						
21	Hundred Eighty-one Million Twenty-six Thousand Seven Hundred Fifty						
22	Dollars (\$181,026,750.00) to be budgeted and expended in accordance						
23	with law.						
24	SECTION 2. This act shall become effective July 1, 2022.						

1	SECTION 3. It being immediately necessary for the preservation
2	of the public peace, health or safety, an emergency is hereby
3	declared to exist, by reason whereof this act shall take effect and
4	be in full force from and after its passage and approval.
