11 An Act relating to the State Department of Health;
12 requiring that portions of certain appropriated funds
13 be used for certain purposes; stating purpose of
14 certain disbursement; requiring the use of certain
15 data; directing the Department to develop method of
16 disbursement; authorizing promulgation of rules;
17 providing for lapse of funds under certain
18 conditions; requiring certain budget procedures; and
19 prohibiting certain budget procedures.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. From the funds appropriated to the State Department
22 of Health in Enrolled Senate Bill No. 1040 of the 2nd Session of the
23 58th Oklahoma Legislature, the sum of One Hundred Thousand Dollars
24 (\$100,000.00) shall be used for increased sickle cell outreach.

SECTION 2. From the funds appropriated to the State Department
of Health in Enrolled Senate Bill No. 1040 of the 2nd Session of the

1 58th Oklahoma Legislature, the sum of Two Million Five Hundred
2 Thousand Dollars (\$2,500,000.00) shall be used for targeted salary
3 adjustments for agency employees involved in public health.

4 SECTION 3. From the funds appropriated to the State Department
5 of Health in Enrolled Senate Bill No. 1040 of the 2nd Session of the
6 58th Oklahoma Legislature, the sum of Two Hundred Thousand Dollars
7 (\$200,000.00) shall be used for the operations of the Oklahoma
8 Athletic Commission, pursuant to the provisions of the Oklahoma
9 State Athletic Commission Act.

10 SECTION 4. From the funds appropriated to the State Department
11 of Health in Enrolled Senate Bill No. 1040 of the 2nd Session of the
12 58th Oklahoma Legislature, the sum of Three Million Dollars
13 (\$3,000,000.00) shall be used for the continuation of the Choosing
14 Childbirth Act by the provisions listed in Section 1-740.15 et seq.
15 of Title 63 of the Oklahoma Statutes.

16 SECTION 5. From the funds appropriated to the State Department
17 of Health in Enrolled Senate Bill No. 1040 of the 2nd Session of the
18 58th Oklahoma Legislature, One Million Nine Hundred Thousand Dollars
19 (\$1,900,000.00) shall be disbursed to health centers authorized
20 under Section 330 of the Public Health Service Act, and incorporated
21 in the State of Oklahoma. Any disbursement shall be for the purpose
22 of increasing access to primary health care which may include
23 medical, dental, and or mental health and substance abuse treatment
24 services in or near designated Medically Underserved Areas or

1 Medically Underserved Populations. Any disbursement for increased
2 access to primary health care services shall be supported by data
3 according to proportions of patient volume and access for uninsured.
4 The method of disbursement shall be developed by the State
5 Department of Health. The State Commissioner of Health is
6 authorized to promulgate the method of disbursement into rules.

7 SECTION 6. Appropriations made by Enrolled Senate Bill No. 1040
8 of the 2nd Session of the 58th Oklahoma Legislature, not including
9 appropriations made for capital outlay purposes, may be budgeted for
10 the fiscal year ending June 30, 2023 (hereafter FY-23) or may be
11 budgeted for the fiscal year ending June 30, 2024 (hereafter FY-24).
12 Funds budgeted for FY-23 may be encumbered only through June 30,
13 2023, and must be expended by November 15, 2023. Any funds
14 remaining after November 15, 2023, and not budgeted for FY-24, shall
15 lapse to the credit of the proper fund for the then current fiscal
16 year. Funds budgeted for FY-24 may be encumbered only through June
17 30, 2024. Any funds remaining after November 15, 2024, shall lapse
18 to the credit of the proper fund for the then current fiscal year.
19 These appropriations may not be budgeted in both fiscal years
20 simultaneously. Funds budgeted in FY-23, and not required to pay
21 obligations for that fiscal year, may be budgeted for FY-24, after
22 the agency to which the funds have been appropriated has prepared
23 and submitted a budget work program revision removing these funds
24

1 from the FY-23 budget work program and after such revision has been
2 approved by the Office of Management and Enterprise Services.
