11	An Act relating to support service providers; amending Section 2, Chapter 141, O.S.L. 2018 (74 O.S.
12	Supp. 2020, Section 166.13), which relates to program to broaden availability of support service providers
13	in the deaf-blind community; transferring program to the Department of Human Services; removing certain
14	condition on implementation of program; decreasing limit on total amount of grants; renumbering Section

16	act, which relates to program to broaden availability of support service providers in the deaf-blind

20	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
21	SECTION 1. AMENDATORY Section 2, Chapter 141, O.S.L.
22	2018 (74 O.S. Supp. 2020, Section 166.13), is amended to read as

Section 166.13. A. Subject to the availability of funds, the

State Department of Rehabilitation Services The Department of Human

Services shall:

- 1. Establish a program to broaden the availability of support service providers (SSPs) in the deaf-blind community;
- 2. Develop a mission statement for the program and promulgate rules necessary to implement and administer the program;
- 3. Provide grants to SSPs and organizations that provide services for deaf-blind adults or deaf-blind children and their families. The services shall include but are not limited to:
 - a. transportation for doctor appointments, shopping or errands,
 - b. reading mail or other correspondence,
 - c. making telephone calls,

- d. recreation or wellness activities,
- e. civic or religious activities,
- f. deaf-blind meetings or events, and
- g. occasional special events such as weddings, funerals or religious ceremonies.

The Department may prioritize and limit the amount and scope of services offered subject to funding limitations and considering the needs of the deaf-blind recipients and their families; and

4. Use a request-for-proposal process to award grants to SSPs. SSPs that receive grants pursuant to this section may expend the

grant monies for any purpose authorized in this subsection. The
total amount of grants awarded pursuant to this section shall not
exceed Three Hundred Thousand Dollars (\$300,000.00) Two Hundred
Fifty Thousand Dollars (\$250,000.00) annually.

- B. After establishing a program pursuant to subsection A of this section and subject to the availability of funds, the Department may develop a certification requirement and training program for SSPs and organizations that provide services for deafblind adults or deaf-blind children and their families with the primary priority of service to the deaf-blind recipients and their families.
- C. The structure and scope of the program established in subsection A of this section may be expanded upon legislative approval and funding. The program shall be aligned with other initiatives of the Department to avoid duplication or overlap of services or programming; however, the Department may use a combination of services or programs to provide a comprehensive support program for deaf-blind adults or deaf-blind children and their families. The Department may solicit and accept private or public funds from individuals and entities to implement and administer the program.
- D. There is hereby created in the State Treasury a revolving fund for the State Department of Rehabilitation Services Department of Human Services to be designated the "Support Service Providers

    Grant Program Fund". The fund shall be a continuing fund, not
    subject to fiscal year limitations. The fund shall consist of

    hereby appropriated and may be budgeted and expended by the
