10 An Act relating to the Oklahoma Employment Security
11 Commission; making appropriations; stating purposes;
12 providing for expenditure limitations; providing an
effective date; and declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. There is hereby appropriated to the Employment
16 Security Administration Fund, out of funds made available to this
17 state by the federal Unemployment Compensation Modernization
18 Transfer made on June 25, 2009, pursuant to Section 903(f) of the
19 Social Security Act, 42 U.S.C., Section 1103(f), as amended, the sum
20 of Eleven Million Dollars (\$11,000,000.00) to be used by the
21 Oklahoma Employment Security Commission for the purpose of paying
22 the administrative expenses of the following programs in the
23 following amounts:

1 1. Employer Service Program in the amount of Three Million
2 Dollars (\$3,000,000.00); and

3 2. Unemployment Insurance Program in the amount of Eight
4 Million Dollars (\$8,000,000.00).

5 The funds appropriated by this section shall be expended before
6 December 15, 2023. Expenditures from this appropriation shall be
7 accounted for in accordance with standards established by the United
8 States Secretary of Labor. The Oklahoma Employment Security
9 Commission shall utilize the appropriation made by this section in
10 accordance with the provisions and requirements contained in the
11 Social Security Act, Title 42 of the United States Code.

12 SECTION 2. This act shall become effective July 1, 2022.

13 SECTION 3. It being immediately necessary for the preservation
14 of the public peace, health or safety, an emergency is hereby
15 declared to exist, by reason whereof this act shall take effect and
16 be in full force from and after its passage and approval.
