10 An Act relating to the State Election Board; making
11 an appropriation; stating purpose; making
12 appropriation nonfiscal; making appropriation exempt
13 from certain agency category and budget limits; and
14 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the State Election
17 Board from any monies not otherwise appropriated from the General
18 Revenue Fund of the State Treasury for the fiscal year ending June
19 30, 2021, the sum of Four Hundred and Seventy Thousand Dollars
20 (\$470,000.00) or so much thereof as may be necessary to purchase
21 ballot paper.

22 SECTION 2. The appropriation made by this act shall not be
23 subject to fiscal year limitations and shall be available for
24 encumbrance and expenditure purposes for a period of thirty (30)
months from the date this act is approved.

1 SECTION 3. The appropriations made by this act shall not be
2 subject to fiscal years 2022 and 2023 agency category and budget
3 limits.

4 SECTION 4. It being immediately necessary for the preservation
5 of the public peace, health and safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
