Research Analysis

HB 1064, as introduced, applies a single method of calculating base salary for county officers to all counties, and removes the other method. Current law includes a method for counties which approve an exemption of certain household goods from ad valorem taxation, pursuant to Article X, Section 6 of the Oklahoma Constitution, and a method for counties which have not approved that exemption. Seventy-five of seventy-seven counties have approved the exemption.

The definition of *service-ability* is modified to include gross assessed valuation of all tangible taxable property, rather than net valuation. The upper limit of the county officer base salary is increased from \$44,500 to \$49,500. Calculation of additions to base salary are modified to be based upon gross assessed valuation rather than net valuation. The bill provides for changes in salaries and rates of pay for county officers, deputies and aides to take effect on the first day in July.
