Research Analysis

HJR 1046 is the Omnibus administrative rule approval/disapproval measure. The measure approves all rules promulgated by the various agencies except:

OAC 725:30-4-4 by the Oklahoma Tourism Department relating to weapons in state parks. SUMMARY OF RULE AND EXPLANATION OF NEED: The purpose of the permanent rules amend the rules to update the language in the rules to reflect recent statutory changes; revoke rules that are preempted by statute, no longer in use, or unneeded; and to bring the rules in line with current practices, information, and modernization efforts of the Department.

OAC 365:25-29-8 by the Oklahoma Insurance Department SUMMARY OF RULE AND EXPLANATION OF NEED: 365:25-29-8 date is changed to give the PBM more time for an audited financial statement.

OAC 210:15-3-173 by the Oklahoma State Department of Education BRIEF SUMMARY OF CONTENT OF THE ADOPTED RULE(S): The Information Literacy standards are guidelines for educators and library media professionals to help students learn to research and use information. The Information Literacy guidelines are based on six (6) foundational concepts: Inquire, Include, Collaborate, Curate, Explore, and Engage. Each foundation area is broken down into four (4) competency domains: Think, Create, Share, and Grow.

OAC 800:10-1-4, 800:10-1-7, 800:15-1-1, 800:15-1-2, 800:15-1-3, 800:15-1-4 and 800:15-1-5 by the Oklahoma Department of Wildlife Conservation.

BRIEF SUMMARY OF CONTENT OF THE ADOPTED RULE: The purpose of the proposed rule amendments are to align with Governor Stitt's Executive Order 2020-03 as part of a thorough review of Title 800 to identify costly, ineffective, duplicative and outdated information and regulations. These revisions include housekeeping edits, combination of the size limit and bag limits sections, clarification of culling restrictions, clarification of release of fishes taken by bow and arrow, gig, spear, and speargun, new aggregate bag limit for Close To Home waters, new statewide aggregate trout bag limit, removal of Monday and Friday catch and release requirement for paddlefish, clarified restrictions on cleaning and disposal of fish or fish remains, statewide May closure and catch and release rules clarified for alligator gar, removal of restrictions on tiger muskie, changed labeling requirements for fishing equipment, modification of snagging restrictions on the Arkansas River, new section on harvest tagging and reporting of fish, and allow non-motorized boats on Doc Hollis Lake. The purpose of the proposed rule amendments are to align with Governor Stitt's Executive Order 2020-03 as part of a thorough review of Title 800 to identify costly, ineffective, duplicative and outdated information and regulations. These revisions include housekeeping edits, equipment labeling requirements, and closure of waters of this state to commercial fishing, commercial minnow seining, commercial shad harvest, and commercial mussel harvest.
