16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. AMENDATORY 47 O.S. 2021, Section 1107, as
18	last amended by Section 115 of Enrolled House Bill No. 3419 of the
19	2nd Session of the 58th Legislature, is amended to read as follows:
20	Section 1107. A. In the event of the sale or transfer of the
21	ownership of a vehicle for which a certificate of title has been
22	issued as provided by Section 1105 of this title, the holder of such
23	certificate shall endorse on the back of same a complete assignment
24	thereof with warranty of title in form printed thereon with a

1 statement of all liens or encumbrances on the vehicle, sworn to 2 before a notary public or some other person authorized by law to take acknowledgments, and deliver same to the purchaser or 3 transferee at the time of delivery to the purchaser or transferee of 4 5 the vehicle; provided, a transfer of the ownership of a vehicle to an insurer resulting from the settlement of a total loss claim shall 6 not require a notarized signature on the certificate of title. 7 the event that any other documents required for the transfer of 8 9 ownership of a vehicle to an insurer resulting from the settlement 10 of a total loss claim require a notarized signature, such documents 11 shall be permitted to be signed electronically pursuant to Section 12 15-109 of Title 12A of the Oklahoma Statutes in lieu of such requirement. The purchaser or transferee, unless such person is a 13 bona fide used motor vehicle dealer licensed by this state, a retail 14 implement dealer in connection with the purchase or transfer of off-15 road vehicles or a charitable organization shall, within thirty (30) 16 days from the time of delivery to the purchaser or transferee of the 17 vehicle, present the assigned certificate of title and the insurance 18 security verification to the vehicle to Service Oklahoma, or one of 19 its licensed operators, accompanied by a fee of Eleven Dollars 20 (\$11.00), together with any motor vehicle excise tax or license fee 21 that may be due, whereupon a new certificate of title, shall be 22 issued to the assignee. One Dollar (\$1.00) of each fee shall be 23 deposited in the Oklahoma Tax Commission Reimbursement Fund through 24

- December 31, 2022, and beginning January 1, 2023, this fee shall be deposited in the Service Oklahoma Reimbursement Fund. Any charitable organization utilizing the exemption authorized by this subsection shall receive training as prescribed by the Oklahoma Used Motor Vehicle and Parts, Dismantler, and Manufactured Housing

  Commission.
- A licensed dealer, a retail implement dealer in connection 7 with the sale or disposal of off-road vehicles or a charitable 8 9 organization shall, on selling or otherwise disposing of a vehicle, execute and deliver to the purchaser thereof the certificate of 10 title properly and completely reassigned. Thereupon, the purchaser 11 of the vehicle shall present the reassigned certificate to Service 12 13 Oklahoma, or a licensed operator, accompanied by a fee of Eleven Dollars (\$11.00), and any motor vehicle excise tax or license fee 14 that may be due, whereupon a new certificate of title will be issued 15 to the purchaser. One Dollar (\$1.00) of each fee shall be deposited 16 17 in the Oklahoma Tax Commission Reimbursement Fund through December 31, 2022, and beginning January 1, 2023, this fee shall be deposited 18 in the Service Oklahoma Reimbursement Fund. The certificate, when 19 so assigned and returned to the Commission, together with any 20 subsequent assignment or reissue thereof, shall be appropriately 21 filed and indexed so that at all times it will be possible to trace 22 title to the vehicle designated therein. Provided, when the 23 ownership of any motor vehicle shall pass by operation of law, the 24

person owning the vehicle may, upon furnishing satisfactory proof to the Commission of ownership, procure a title to the motor vehicle, regardless of whether a certificate of title has ever been issued. The dealer shall execute and deliver to the purchaser bills of sale on forms prescribed by the Commission for all new vehicles sold by the dealer. On presentation of a bill of sale executed on forms prescribed by the Commission, by a manufacturer or dealer for a new vehicle sold in this state, accompanied by remittance in the sum of Eleven Dollars (\$11.00), together with any motor vehicle excise tax or license fee that may be due, a certificate of title shall be issued in accordance with the provisions of the Oklahoma Vehicle License and Registration Act. One Dollar (\$1.00) of each fee shall be deposited in the Oklahoma Tax Commission Reimbursement Fund through December 31, 2022, and beginning January 1, 2023, this fee shall be deposited in the Service Oklahoma Reimbursement Fund. For purposes of this subsection, "charitable organization" shall mean any organization which is exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3) and which is registered as a charitable organization with the Oklahoma Secretary of State and the Oklahoma Attorney General's office; "off-road vehicles" means all-terrain vehicles, utility vehicles, and motorcycles used exclusively for off-road use; "retail implement dealer" means a business engaged primarily in the sale of farm tractors as defined in Section 1-118 of this title or

implements of husbandry as defined in Section 1-125 of this title or a combination thereof.

C. Any person violating the provisions of this section shall be guilty of a misdemeanor and upon the first conviction thereof shall be punished by a fine not to exceed Five Hundred Dollars (\$500.00), with impoundment of the vehicle until all taxes and fees are paid. A second or subsequent conviction shall be punished by a fine not to exceed One Thousand Dollars (\$1,000.00), with impoundment of the vehicle until all taxes and fees are paid. If a vehicle is impounded pursuant to the provisions of this section, the vehicle shall not be released to the owner until the owner provides proof of security or an affidavit that the vehicle will not be used on public highways or public streets, as required pursuant to Section 7-600 et seq. of this title. Each vehicle involved in a violation of this section shall be considered a separate offense.

SECTION 2. This act shall become effective November 1, 2022.
