This bill proposes to amend 47 O.S. § 1135.5(A) by creating the Epilepsy Foundation special license plate for any person wishing to demonstrate support for Epilepsy Foundation. The Oklahoma Tax Commission shall be authorized to enter into a licensing agreement with the Epilepsy Foundation for any licensing fees which may be required in order to use the organization's logo or design. The licensing agreement shall provide for a payment to the Epilepsy Foundation of not more than Twenty Dollars (\$20.00).

This bill proposes to amend 47 O.S. § 1135.5(A) by creating the Epilepsy Foundation special license plate for any person wishing to demonstrate support for Epilepsy Foundation. The Oklahoma Tax Commission shall be authorized to enter into a licensing agreement with the Epilepsy Foundation for any licensing fees which may be required in order to use the organization's logo or design. The licensing agreement shall provide for a payment to the Epilepsy Foundation of not more than Twenty Dollars (\$20.00).

The annual fee for special license plates authorized by this section is \$35 and shall be in addition to all other annual vehicle registration fees. Twenty Dollars (\$20.00) of the \$35 fee amount shall be apportioned to the designated entity [Epilepsy Foundation], \$8 shall be deposited into the OTC Reimbursement Fund and the remaining \$7 shall be apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. \$ 1104.

REVENUE IMPACT

The estimated revenue impact associated with this measure would be a minimal increase in motor vehicle collections for FY 22 and FY 23 should the 100 prepaid application requirement be met to initiate the creation and issuance of the Epilepsy Foundation special license plate.

ADMINISTRATIVE IMPACT

Minimal administrative costs would be incurred as a result of this request.
