PROPOSAL: Amendatory

Sections 1-8, 11 & 12 relates to the administrative responsibilities of the Oklahoma Corporation Commission and the Department of Transportation. Sections 13 and 14 repeal 47 O.S. §§ 116.13¹ & 171.2², respectively.

Section 9 proposes to amend 47 O.S. § 1112.2 which provides that the provisions relating to the transfer of license plates and certificate of registration shall not apply to commercial vehicles or trailer registrations issued by the Oklahoma Corporation Commission.

Section 10 proposes to amend 47 O.S. § 1113 by requiring the Oklahoma Tax Commission (OTC) to design appropriate official license plates for vehicles of the Oklahoma Corporation Commission (OCC). The license plates shall contain the letters "OCC" followed by the Osage warrior's shield and a minimum of three additional numbers or letters as designated by the Director of the agency. The words "Oklahoma Corporation Commission" shall also be included on such license plates. It further directs the Oklahoma Tourism and Recreation Department to submit all commercial motor vehicle license plate designs to the OCC for its approval prior to being issued by OTC for the purposes of ensuring compatibility with commercial license plate reader technology.

REVENUE IMPACT

Sections 9 and 10 have no estimated effect on motor vehicle tax collections.

ADMINISTRATIVE IMPACT

Section 10 would result in an estimated \$2,500 increase in costs to be incurred by the Tax Commission.
