10 An Act relating to general appropriations for the  
11 expenses of various agencies of the executive,  
12 legislative, and judicial departments of the state;  
13 making appropriations to the State Board of  
14 Education, the Oklahoma Arts Council, the State Board  
15 of Career and Technology Education, the Office of  
16 Educational Quality and Accountability, the Oklahoma  
17 Educational Television Authority, the Oklahoma State  
18 Regents for Higher Education, the Commissioners of  
19 the Land Office, the Oklahoma Department of  
20 Libraries, the Physician Manpower Training  
21 Commission, the Board of Trustees of the Oklahoma

7 Hospitals Authority, the Oklahoma Department of  
8 Veterans Affairs, the Oklahoma Commission on Children  
9 and Youth, the Office of Disability Concerns, the  
10 Department of Human Services, the Office of Juvenile  
11 Affairs, the State Department of Rehabilitation  
12 Services, the Oklahoma Department of Agriculture,  
13 Food, and Forestry, the Oklahoma Conservation  
14 Commission, the Corporation Commission, the  
15 Department of Environmental Quality, the Oklahoma  
16 Historical Society, the J.M. Davis Memorial  
17 Commission, the Department of Labor, the Department  
18 of Mines, the Oklahoma Tourism and Recreation  
19 Department, the Oklahoma Water Resources Board, the  
20 Alcoholic Beverage Laws Enforcement Commission, the  
21 Department of Corrections, the Oklahoma State Bureau  
22 of Investigation, the Council on Law Enforcement  
23 Education and Training, the Board of Medicolegal  
24 Investigations, the Oklahoma State Bureau of  
Narcotics and Dangerous Drugs Control, the Department  
of Public Safety, the Office of the Attorney General,  
the Court of Criminal Appeals, district attorneys and  
the District Attorneys Council, the Supreme Court,  
the Oklahoma Indigent Defense System, the Pardon and  
Parole Board, the Multiple Injury Trust Fund, the  
Special Cash Fund, The State Emergency Fund, and the  
Emergency Management Assistance Compact and Rescue  
Out of State Deployments Revolving Fund; stating  
amounts of the appropriations; stating purposes and  
restrictions; authorizing certain expenditures;  
directing certain transfers; and providing an  
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2023, the sum of One Billion Four Hundred Fifty-  
3 seven Million Sixty-eight Thousand Six Hundred Sixty-eight Dollars  
4 (\$1,457,068,668.00) or so much thereof as may be necessary for the  
5 financial support of public schools.

6 SECTION 2. There is hereby appropriated to the State Board of  
7 Education from any monies not otherwise appropriated from the  
8 Education Reform Revolving Fund created in Section 34.89 of Title 62  
9 of the Oklahoma Statutes, the sum of Eight Hundred Ninety Million  
10 One Hundred Twenty Thousand Three Hundred Seventy-five Dollars  
11 (\$890,120,375.00) or so much thereof as may be necessary for the  
12 financial support of public schools.

13 SECTION 3. The State Board of Education is hereby authorized to  
14 expend during the fiscal year ending June 30, 2023, from the Common  
15 Education Technology Revolving Fund of the State Treasury, the sum  
16 of Forty-seven Million Twenty-five Thousand Seven Hundred One  
17 Dollars (\$47,025,701.00) or so much thereof as may be necessary for  
18 the financial support of public schools.

19 SECTION 4. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Mineral Leasing Fund of the State Treasury for the fiscal year  
22 ending June 30, 2023, the sum of Four Million Seven Hundred Fifty  
23 Thousand Dollars (\$4,750,000.00) or so much thereof as may be  
24 necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Mineral Leasing Fund of the State Treasury for the fiscal year  
4 ending June 30, 2021, the sum of Two Hundred Forty Thousand Seven  
5 Hundred Sixty-three Dollars (\$240,763.00) or so much thereof as may  
6 be necessary for the financial support of public schools.

7 SECTION 6. There is hereby appropriated to the State Board of  
8 Education from any monies not otherwise appropriated from the  
9 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
10 fiscal year ending June 30, 2023, the sum of Twenty-five Million Six  
11 Hundred Fifty Thousand Dollars (\$25,650,000.00) or so much thereof  
12 as may be necessary for the financial support of public schools.

13 SECTION 7. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
16 fiscal year ending June 30, 2021, the sum of Twelve Million Three  
17 Hundred Ninety-one Thousand One Hundred Ninety-two Dollars  
18 (\$12,391,192.00) or so much thereof as may be necessary for the  
19 financial support of public schools.

20 SECTION 8. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 General Revenue Fund of the State Treasury for the fiscal year  
23 ending June 30, 2023, the sum of One Hundred Seventeen Million Nine  
24 Hundred Nineteen Thousand Twenty-six Dollars (\$117,919,026.00) or so

1 much thereof as may be necessary for the support of public school  
2 activities.

3 SECTION 9. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2023, the sum of Forty-five Million One Hundred  
7 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may  
8 be necessary for the purchase of textbooks and instructional  
9 materials.

10 SECTION 10. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2023, the sum of Three Hundred Fifty-nine Million  
14 One Hundred Ninety-three Thousand Four Hundred Seventy Dollars  
15 (\$359,193,470.00) or so much thereof as may be necessary for the  
16 Certified Employee Health Benefit Allowance.

17 SECTION 11. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 General Revenue Fund of the State Treasury for the fiscal year  
20 ending June 30, 2023, the sum of One Hundred Ninety-four Million Two  
21 Hundred Eleven Thousand Three Hundred Fifty-nine Dollars  
22 (\$194,211,359.00) or so much thereof as may be necessary for the  
23 Support Personnel Health Benefit Allowance.

24

1 SECTION 12. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2023, the sum of Nineteen Million One Hundred Forty-  
5 five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so  
6 much thereof as may be necessary for administrative and support  
7 functions of the State Department of Education.

8 SECTION 13. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2023, the sum of Two Million Eight  
12 Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as  
13 may be necessary for transfer to the School Consolidation Assistance  
14 Fund.

15 SECTION 14. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
18 fiscal year ending June 30, 2021, the sum of One Million Three  
19 Hundred Seventy-six Thousand Seven Hundred Ninety-nine Dollars  
20 (\$1,376,799.00) or so much thereof as may be necessary for transfer  
21 to the School Consolidation Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2023, the sum of Two Million Eight  
2 Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as  
3 may be necessary for transfer to the Teachers' Retirement System  
4 Dedicated Revenue Revolving Fund.

5 SECTION 16. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2021, the sum of One Million Three  
9 Hundred Seventy-six Thousand Seven Hundred Ninety-nine Dollars  
10 (\$1,376,799.00) or so much thereof as may be necessary for transfer  
11 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

12 SECTION 17. For the fiscal year ending June 30, 2023, the State  
13 Board of Education is hereby authorized to transfer from the  
14 Teachers' Retirement System Dedicated Revenue Revolving Fund to the  
15 Teachers' Retirement System of Oklahoma the sum of Four Hundred One  
16 Million Nine Hundred Six Thousand One Hundred Ninety Dollars  
17 (\$401,906,190.00) and from the funds appropriated in Sections 15 and  
18 16 of this act, in the amounts provided in those sections for the  
19 purposes prescribed in Section 34.93 of Title 62 of the Oklahoma  
20 Statutes.

21 SECTION 18. There is hereby appropriated to the Oklahoma Arts  
22 Council from any monies not otherwise appropriated from the General  
23 Revenue Fund of the State Treasury for the fiscal year ending June  
24 30, 2023, the sum of Three Million Two Hundred Forty-three Thousand

1 Thirty Dollars (\$3,243,030.00) or so much thereof as may be  
2 necessary to perform the duties imposed upon the Oklahoma Arts  
3 Council by law.

4 SECTION 19. There is hereby appropriated to the State Board of  
5 Career and Technology Education from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2023, the sum of One Hundred Thirty-  
8 seven Million Six Hundred Two Thousand Nine Hundred Thirty-two  
9 Dollars (\$137,602,932.00) or so much thereof as may be necessary to  
10 perform the duties imposed upon the State Board of Career and  
11 Technology Education by law.

12 SECTION 20. There is hereby appropriated to the State Board of  
13 Career and Technology Education from any monies not otherwise  
14 appropriated from the Oklahoma Education Lottery Trust Fund of the  
15 State Treasury for the fiscal year ending June 30, 2023, the sum of  
16 Three Million One Hundred Thirty-five Thousand Dollars  
17 (\$3,135,000.00) pursuant to paragraph 2 of subsection E of Section  
18 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
19 Board of Career and Technology Education for the education and  
20 general operating budgets of the institutions and for other  
21 programs, construction, renovations, or repairs administered by the  
22 State Board of Career and Technology Education.

23 SECTION 21. There is hereby appropriated to the State Board of  
24 Career and Technology Education from any monies not otherwise



1 appropriated from the Oklahoma Education Lottery Trust Fund of the  
2 State Treasury for the fiscal year ending June 30, 2021, the sum of  
3 One Million Five Hundred Fourteen Thousand Four Hundred Eighty  
4 Dollars (\$1,514,480.00) pursuant to paragraph 2 of subsection E of  
5 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
6 the State Board of Career and Technology Education for the education  
7 and general operating budgets of the institutions and for other  
8 programs, construction, renovations, or repairs administered by the  
9 State Board of Career and Technology Education.

10 SECTION 22. There is hereby appropriated to the Office of  
11 Educational Quality and Accountability from any monies not otherwise  
12 appropriated from the General Revenue Fund of the State Treasury for  
13 the fiscal year ending June 30, 2023, the sum of One Million Sixty-  
14 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much  
15 thereof as may be necessary to perform the duties imposed upon the  
16 Office of Educational Quality and Accountability by law. Of those  
17 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)  
18 shall be deposited in the Teacher Certification Scholarship  
19 Revolving Fund created pursuant to Section 6-187C of Title 70 of the  
20 Oklahoma Statutes. Of those funds appropriated, the sum of One  
21 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
22 the Education Leadership Oklahoma Revolving Fund created pursuant to  
23 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

24

1 SECTION 23. There is hereby appropriated to the Office of  
2 Educational Quality and Accountability from any monies not otherwise  
3 appropriated from the Cash-flow Reserve Fund (Fund 090) of the State  
4 Treasury the sum of Five Hundred Thousand Dollars (\$500,000.00) or  
5 so much thereof as may be necessary to perform the duties imposed  
6 upon the Office of Educational Quality and Accountability by law.

7 SECTION 24. There is hereby appropriated to the Oklahoma  
8 Educational Television Authority from any monies not otherwise  
9 appropriated from the General Revenue Fund of the State Treasury for  
10 the fiscal year ending June 30, 2023, the sum of Two Million Eight  
11 Hundred Seventy-nine Thousand Four Dollars (\$2,879,004.00) or so  
12 much thereof as may be necessary to perform the duties imposed upon  
13 the Oklahoma Educational Television Authority by law.

14 SECTION 25. There is hereby appropriated to the Oklahoma State  
15 Regents for Higher Education from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury for  
17 the fiscal year ending June 30, 2023, the sum of Seven Hundred  
18 Twenty-five Million Nine Hundred Sixty-four Thousand Eight Hundred  
19 Ninety-nine Dollars (\$725,964,899.00) or so much thereof as may be  
20 necessary for allocation by the Oklahoma State Regents for Higher  
21 Education pursuant to the provisions of Article XIII-a of the  
22 Oklahoma Constitution for the education and general operating  
23 budgets of the institutions and for other programs, construction,  
24 renovations, or repairs administered by the Oklahoma State Regents

1 for Higher Education. Of those funds appropriated, the sum of Three  
2 Million One Hundred Forty-nine Thousand Eight Hundred Ninety-seven  
3 Dollars (\$3,149,897.00) shall be transferred to the Oklahoma Tuition  
4 Equalization Grant Trust Fund to implement the provisions of the  
5 Oklahoma Tuition Equalization Grant Act.

6 SECTION 26. The Oklahoma State Regents for Higher Education are  
7 hereby authorized to expend during the fiscal year ending June 30,  
8 2023, the sum of Forty-seven Million Twenty-five Thousand Seven  
9 Hundred One Dollars (\$47,025,701.00) from the Higher Education  
10 Capital Revolving Fund of the State Treasury for allocation by the  
11 Oklahoma State Regents for Higher Education pursuant to the  
12 provisions of Article XIII-a of the Oklahoma Constitution for the  
13 education and general operating budgets of the institutions and for  
14 other programs, construction, renovations, or repairs administered  
15 by the Oklahoma State Regents for Higher Education.

16 SECTION 27. The Oklahoma State Regents for Higher Education are  
17 hereby authorized to expend during the fiscal year ending June 30,  
18 2023, the sum of Forty-seven Million Twenty-five Thousand Seven  
19 Hundred One Dollars (\$47,025,701.00) from the Oklahoma Student Aid  
20 Revolving Fund of the State Treasury for allocation by the Oklahoma  
21 State Regents for Higher Education pursuant to the provisions of  
22 Article XIII-a of the Oklahoma Constitution for the education and  
23 general operating budgets of the institutions and for other  
24

1 programs, construction, renovations, or repairs administered by the  
2 Oklahoma State Regents for Higher Education.

3 SECTION 28. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2023, the sum of Fifteen Million  
7 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
8 (\$15,764,823.00) or so much thereof as may be necessary for  
9 expenditures for concurrent enrollment pursuant to Section 628.13 of  
10 Title 70 of the Oklahoma Statutes.

11 SECTION 29. There is hereby appropriated to the Oklahoma State  
12 Regents for Higher Education from any monies not otherwise  
13 appropriated from the Oklahoma Education Lottery Trust Fund of the  
14 State Treasury for the fiscal year ending June 30, 2023, the sum of  
15 Twenty-two Million Five Hundred Fifteen Thousand Dollars  
16 (\$22,515,000.00) pursuant to paragraph 2 of subsection E of Section  
17 713 of Title 3A of the Oklahoma Statutes for allocation by the  
18 Oklahoma State Regents for Higher Education pursuant to the  
19 provisions of Article XIII-a of the Oklahoma Constitution for  
20 construction, renovations, or repairs administered by the Oklahoma  
21 State Regents for Higher Education or for any other purpose  
22 authorized by paragraph 2 of subsection E of Section 713 of Title 3A  
23 of the Oklahoma Statutes.

24

1 SECTION 30. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of the  
4 State Treasury for the fiscal year ending June 30, 2021, the sum of  
5 Ten Million Eight Hundred Seventy-six Thousand Seven Hundred  
6 Thirteen Dollars (\$10,876,713.00) pursuant to paragraph 2 of  
7 subsection E of Section 713 of Title 3A of the Oklahoma Statutes for  
8 allocation by the Oklahoma State Regents for Higher Education  
9 pursuant to the provisions of Article XIII-a of the Oklahoma  
10 Constitution for construction, renovations, or repairs administered  
11 by the Oklahoma State Regents for Higher Education or for any other  
12 purpose authorized by paragraph 2 of subsection E of Section 713 of  
13 Title 3A of the Oklahoma Statutes.

14 SECTION 31. Of the funds appropriated in this act the Oklahoma  
15 State Regents for Higher Education are authorized to expend during  
16 the fiscal year ending June 30, 2023, the sum of Seventeen Million  
17 Three Hundred Seventy-eight Thousand Five Hundred Dollars  
18 (\$17,378,500.00) for the Teacher Shortage Employment Incentive  
19 Program, pursuant to subsection A of Section 698.3 of Title 70 of  
20 the Oklahoma Statutes.

21 SECTION 32. Of the funds appropriated in this act the Oklahoma  
22 State Regents for Higher Education are authorized to expend during  
23 the fiscal year ending June 30, 2023, the sum of Six Million Eight  
24

1 Hundred Fifty Thousand Dollars (\$6,850,000.00) for the purpose of  
2 student enrollment, retention, and graduation assistance.

3 SECTION 33. Of the funds appropriated in this act the Oklahoma  
4 State Regents for Higher Education are authorized to expend during  
5 the fiscal year ending June 30, 2023, the sum of Eleven Million Five  
6 Hundred Thousand Dollars (\$11,500,000.00) for the purpose of a STEM  
7 workforce development initiative.

8 SECTION 34. Of the funds appropriated in this act the Oklahoma  
9 State Regents for Higher Education are authorized to expend during  
10 the fiscal year ending June 30, 2023, the sum of Two Hundred  
11 Thousand Dollars (\$200,000.00) for the purpose of establishing a  
12 food pantry.

13 SECTION 35. Of the funds appropriated in this act the Oklahoma  
14 State Regents for Higher Education are authorized to expend during  
15 the fiscal year ending June 30, 2023, the sum of One Million Five  
16 Hundred Thousand Dollars (\$1,500,000.00) pursuant to the provisions  
17 of Sections 2620 through 2627 of Title 70 of the Oklahoma Statutes.

18 SECTION 36. There is hereby appropriated to the Oklahoma State  
19 Regents for Higher Education from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2023, the sum of Four Million Two  
22 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars  
23 (\$4,232,974.00) or so much thereof as may be necessary for the  
24

1 general operating budget of the administrative offices of the  
2 Oklahoma State Regents for Higher Education.

3 SECTION 37. There is hereby appropriated to the Commissioners  
4 of the Land Office from any monies not otherwise appropriated from  
5 the Commissioners of the Land Office Fund of the State Treasury for  
6 the fiscal year ending June 30, 2023, the sum of Six Million Seven  
7 Hundred Three Thousand Four Hundred Twenty-one Dollars  
8 (\$6,703,421.00) or so much thereof as may be necessary to perform  
9 the duties imposed upon the Commissioners of the Land Office by law.

10 SECTION 38. There is hereby appropriated to the Oklahoma  
11 Department of Libraries from any monies not otherwise appropriated  
12 from the General Revenue Fund of the State Treasury for the fiscal  
13 year ending June 30, 2023, the sum of Four Million Five Hundred  
14 Thirty-six Thousand Three Hundred Fifteen Dollars (\$4,536,315.00) or  
15 so much thereof as may be necessary to perform the duties imposed  
16 upon the Oklahoma Department of Libraries by law.

17 SECTION 39. There is hereby appropriated to the Physician  
18 Manpower Training Commission from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2023, the sum of Six Million Eight  
21 Hundred Thirty-six Thousand Three Hundred Twenty-nine Dollars  
22 (\$6,836,329.00) or so much thereof as may be necessary to perform  
23 the duties imposed upon the Physician Manpower Training Commission  
24 by law.

1 SECTION 40. There is hereby appropriated to the Physician  
2 Manpower Training Commission from any monies not otherwise  
3 appropriated from the Cash-flow Reserve Fund (Fund 090) of the State  
4 Treasury the sum of Four Hundred Thousand Dollars (\$400,000.00) or  
5 so much thereof as may be necessary to perform the duties imposed  
6 upon the Physician Manpower Training Commission by law.

7 SECTION 41. There is hereby appropriated to the Board of  
8 Trustees of the Oklahoma School of Science and Mathematics from any  
9 monies not otherwise appropriated from the General Revenue Fund of  
10 the State Treasury for the fiscal year ending June 30, 2023, the sum  
11 of Six Million Five Hundred Sixteen Thousand Three Hundred Seventy-  
12 three Dollars (\$6,516,373.00) or so much thereof as may be necessary  
13 to perform the duties imposed upon the Board of Trustees of the  
14 Oklahoma School of Science and Mathematics by law.

15 SECTION 42. There is hereby appropriated to the Oklahoma Center

17 otherwise appropriated from the General Revenue Fund of the State  
18 Treasury for the fiscal year ending June 30, 2023, the sum of  
19 Sixteen Million Eight Hundred Forty-six Thousand Five Hundred Forty-  
20 two Dollars (\$16,846,542.00) or so much thereof as may be necessary  
21 to perform the duties imposed upon the Oklahoma Center for the  
22 Advancement of Science and Technology by law. Of those funds  
23 appropriated, the sum of Seven Million Six Hundred Eighteen Thousand  
24 Six Hundred Seventeen Dollars (\$7,618,617.00) shall be deposited in

23 SECTION 143. There is hereby appropriated to the State Board of  
24 Education from the General Revenue Fund of the State Treasury for



1 the fiscal year ending June 30, 2021, the sum of Ninety-five Million  
2 Two Hundred Eighty-three Thousand One Hundred Seventy-four Dollars  
3 (\$95,283,174.00) to be transferred to the Ad Valorem Reimbursement  
4 Fund, created pursuant to Section 193 of Title 62 of the Oklahoma  
5 Statutes, for the purpose of reimbursing counties for school  
6 districts that claim a loss of revenue due to a tax exemption  
7 granted pursuant to the provisions of Section 6B of Article X of the  
8 Oklahoma Constitution.

9 SECTION 144. There is hereby appropriated to the Office of  
10 Management and Enterprise Services from any monies not otherwise  
11 appropriated from the Special Cash Fund of the State Treasury, the  
12 sum of Seven Million Five Hundred Thousand Dollars (\$7,500,000.00)  
13 for the implementation of Service Oklahoma.

14 SECTION 145. There is hereby appropriated to the Office of  
15 Management and Enterprise Services from any monies not otherwise  
16 appropriated from the Special Cash Fund of the State Treasury, the  
17 sum of Three Million Two Hundred Thousand Dollars (\$3,200,000.00) or  
18 so much thereof as may be necessary to perform the duties imposed  
19 upon the Office of Management and Enterprise Services by law.

20 SECTION 146. There is hereby appropriated to The State  
21 Emergency Fund, created pursuant to Section 139.42 of Title 62 of  
22 the Oklahoma Statutes, from any monies not otherwise appropriated  
23 from the General Revenue Fund of the State Treasury for the fiscal  
24 year ending June 30, 2023, the sum of Four Million Four Hundred

1 Thousand Dollars (\$4,400,000.00), or so much thereof as may be  
2 necessary for matching federal disaster funds and for other  
3 disaster-related assistance.

4 SECTION 147. There is hereby appropriated to the Oklahoma Tax  
5 Commission from any monies not otherwise appropriated from the State  
6 Public Safety Fund of the State Treasury for the fiscal year ending  
7 June 30, 2023, the sum of Four Million Dollars (\$4,000,000.00) for  
8 the purpose of reimbursement of REAL ID expenditures.

9 SECTION 148. There is hereby appropriated to the Department of  
10 Transportation from any monies not otherwise appropriated from the  
11 Special Cash Fund of the State Treasury, the sum of Twenty-two  
12 Million Dollars (\$22,000,000.00) or so much thereof as may be  
13 necessary to perform the duties imposed upon the Oklahoma Department  
14 of Transportation by law. Of the funds appropriated, the Department  
15 of Transportation is authorized to transfer an amount not to exceed  
16 Five Million Dollars (\$5,000,000.00) to the Public Transit Revolving  
17 Fund, created by Section 4031 of Title 69 of the Oklahoma Statutes.

18 SECTION 149. There is hereby appropriated to the Emergency  
19 Management Assistance Compact and Rescue Out of State Deployments  
20 Revolving Fund, created by Enrolled House Bill No. 4143 of the 2nd  
21 Session of the 58th Oklahoma Legislature, from any monies not  
22 otherwise appropriated from the General Revenue Fund of the State  
23 Treasury for the fiscal year ending June 30, 2023, the sum of One  
24

1 Million Dollars (\$1,000,000.00) to be expended in accordance with  
2 law.

3 SECTION 150. Sections 1 through 135 and Sections 146 through  
4 149 of this act shall become effective July 1, 2022.
