6 AS INTRODUCED

7 An Act relating to motor vehicles; amending 47 O.S.  
8 2021, Section 1135.5, which relates to special  
9 license plates; creating the Ally's House License  
10 Plate; providing for design and issue; authorizing  
11 certain licensing agreement; providing for payment;  
12 and providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1135.5, is  
15 amended to read as follows:

16 Section 1135.5 A. The Oklahoma Tax Commission is hereby  
17 authorized to design and issue appropriate official special license  
18 plates to persons wishing to demonstrate support and provide  
19 financial assistance as provided by this section.

20 Special license plates shall not be transferred to any other  
21 person but shall be removed from the vehicle upon transfer of  
22 ownership and retained. The special license plate may then be used  
23 on another vehicle but only after such other vehicle has been  
24 registered for the current year with a motor license agent.

1 Special license plates shall be renewed each year by the Tax  
2 Commission or a motor license agent, unless authorized by the Tax  
3 Commission to be renewed for a period greater than one (1) year.  
4 The Tax Commission shall notify by mail all persons issued special  
5 license plates. The notice shall contain all necessary information  
6 and shall contain instructions for the renewal procedure upon  
7 presentation to a motor license agent or the Tax Commission. The  
8 license plates shall be issued on a staggered system.

9 The Tax Commission is hereby directed to develop and implement a  
10 system whereby motor license agents are permitted to accept  
11 applications for special license plates authorized under this  
12 section. The motor license agent shall confirm the applicant's  
13 eligibility, if applicable, collect and deposit any amount  
14 specifically authorized by law, accept and process the necessary  
15 information directly into such system and generate a receipt  
16 accordingly. For performance of these duties, motor license agents  
17 shall retain the fee provided in Section 1141.1 of this title for  
18 registration of a motor vehicle. The motor license agent fees for  
19 acceptance of applications and renewals shall be paid out of the  
20 Oklahoma Tax Commission Reimbursement Fund.

21 If fewer than one hundred of any type of special license plates  
22 authorized prior to January 1, 2004, are issued prior to January 1,  
23 2006, the Tax Commission shall discontinue issuance and renewal of  
24 that type of special license plate. Any such authorized special

1 license plate registrant shall be allowed to display the license  
2 plate upon the designated vehicle until the registration expiration  
3 date. After such time the expired special license plate shall be  
4 removed from the vehicle.

5 For special license plates authorized on or after July 1, 2004,  
6 no special license plates shall be developed or issued by the Tax  
7 Commission until the Commission receives one hundred prepaid  
8 applications therefor. The prepaid applications must be received by  
9 the Tax Commission within one hundred eighty (180) days of the  
10 effective date of the authorization or the authority to issue shall  
11 be null and void. In the event one hundred prepaid applications are  
12 not received by the Tax Commission within such prescribed time  
13 period any payment so received shall be refunded accordingly.

14 B. The special license plates provided by this section are as  
15 follows:

16 1. University or College Supporter License Plate - such plates  
17 shall be designed and issued to any person wishing to demonstrate  
18 support to any state-supported or private university or college. As  
19 provided in this section, an amount of the fee collected shall be  
20 apportioned as provided in Section 1104.1 of this title;

21 2. Environmental Awareness License Plate - such plates shall be  
22 designed, subject to the criteria to be presented to the Tax  
23 Commission by the Department of Environmental Quality in  
24 consultation with the Oklahoma Arts Council, and issued to any

1 person wishing to demonstrate support to implement the statewide  
2 general public environmental education program created pursuant to  
3 the provisions of the Oklahoma Environmental Quality Code. Such  
4 plates shall be designed and issued to any person in any combination  
5 of numbers and letters from one to a maximum of seven, as for  
6 personalized license plates. A dealer's license plate issued  
7 pursuant to Section 1116.1 or 1128 of this title may be designated  
8 an Environmental Awareness License Plate upon payment of the fee  
9 imposed by this section and any other registration fees required by  
10 the Oklahoma Vehicle License and Registration Act. As provided in  
11 this section, an amount of the fee collected shall be apportioned  
12 pursuant to Section 1104.2 of this title;

13 3. Firefighter License Plate - such plates shall be designed  
14 for any career or retired firefighter, volunteer or paid.  
15 Firefighters may apply for firefighter plates for up to four  
16 vehicles with a rated capacity of one (1) ton or less or for a  
17 motorcycle upon proof of a fire department membership by either an  
18 identification card or letter from the chief of the fire department.  
19 Retirees who are eligible for such plates shall provide proof of  
20 eligibility upon initial application, but shall not be required to  
21 provide proof of eligibility annually. The surviving spouse of any  
22 deceased firefighter, if the spouse has not since remarried, may  
23 apply for a firefighter license plate for one vehicle with a rated  
24 carrying capacity of one (1) ton or less or for a motorcycle upon

1 proof that the deceased firefighter was a member of a fire  
2 department by either an identification card or letter from the chief  
3 of the fire department. The license plate shall be designed in  
4 consultation with the Oklahoma Firefighters Association.

5 As provided in this section, an amount of the fee collected  
6 shall be deposited to the Oklahoma State Firemen's Museum Building &  
7 Memorial Fund for support of the Oklahoma Firefighters Museum and  
8 the Oklahoma Fallen and Living Firefighters Memorial;

9 4. Wildlife Conservation License Plate - such plates shall be  
10 designed, subject to the criteria to be presented to the Tax  
11 Commission by the Oklahoma Department of Wildlife Conservation in  
12 consultation with the Oklahoma Arts Council, and issued to any  
13 person wishing to demonstrate support for wildlife conservation in  
14 this state through the Wildlife Diversity Fund, provided for in  
15 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may  
16 be designed and issued to any person as for personalized license  
17 plates.

18 As provided in this section, an amount of the fee collected  
19 shall be apportioned pursuant to subsection D of Section 3-310 of  
20 Title 29 of the Oklahoma Statutes;

21 5. Child Abuse Prevention License Plate - such plates shall be  
22 designed, subject to the criteria to be presented to the Tax  
23 Commission by the Office of Child Abuse Prevention in the State  
24 Department of Health and the Oklahoma Committee to Prevent Child

1 Abuse, and issued to any person wishing to demonstrate support for  
2 the prevention of child abuse.

3 As provided in this section, an amount of the fee collected  
4 shall be deposited in the Child Abuse Prevention Fund;

5 6. United States Olympic Committee Supporter License Plate -  
6 such plates shall be designed and issued to any person wishing to  
7 demonstrate support for the United States Olympic Committee. The  
8 plates shall be issued to any person in any combination of numbers  
9 and letters from one to a maximum of seven, as for personalized  
10 license plates. The plate shall contain the official United States  
11 Olympic Committee logo. The Tax Commission shall be authorized, if  
12 necessary, to enter into a licensing agreement with the United  
13 States Olympic Committee for any licensing fees which may be  
14 required in order to use the United States Olympic Committee logo or  
15 design. The licensing agreement shall provide for a payment of not  
16 more than Twenty-five Dollars (\$25.00) for each license plate  
17 issued;

18 7. Oklahoma History License Plate - such plates shall be  
19 designed and issued to any person wishing to demonstrate interest in  
20 Oklahoma history. As provided in this section, an amount of the fee  
21 collected shall be deposited to the Oklahoma Historical Society  
22 Revolving Fund to be used for educational purposes;

23 8. Historic Route 66 License Plate - such:  
24

1           a.    vehicle plates shall be designed to honor historic  
2                Route 66, also known as the "Mother Road". As  
3                provided in this section, an amount of the fee  
4                collected for each vehicle license plate shall be  
5                apportioned to the Oklahoma Historical Society  
6                Revolving Fund to be distributed to the Route 66  
7                Museum located in Clinton, Oklahoma, and

8           b.    motorcycle plates shall be designed in consultation  
9                with the Oklahoma Route 66 Association, Inc. The  
10               Oklahoma Tax Commission shall be authorized to enter  
11               into a licensing agreement with the Oklahoma Route 66  
12               Association, Inc., for any licensing fees which may be  
13               required in order to use the Oklahoma Route 66  
14               Association, Inc., logo or design. The licensing  
15               agreement shall provide for a payment to the Oklahoma  
16               Route 66 Association, Inc., of not more than Twenty  
17               Dollars (\$20.00) for each motorcycle license plate  
18               issued;

19        9.   Heart of the Heartland License Plate - such plates shall be  
20   designed and issued to any person wishing to honor the victims of  
21   the terrorist bombing attack on the Alfred P. Murrah Federal  
22   Building in downtown Oklahoma City on April 19, 1995. As provided  
23   in this section, an amount of the fee collected shall be deposited  
24

1 in the Heart of the Heartland Scholarship Fund, as established in  
2 Section 2282 of Title 70 of the Oklahoma Statutes;

3 10. Emergency Medical Technician License Plate - such plates  
4 shall be designed and issued to any person who is an emergency  
5 medical technician. Such persons may apply for an emergency medical  
6 technician license plate for each vehicle with a rated carrying  
7 capacity of one (1) ton or less upon proof of an emergency medical  
8 technician's license. The license plate shall be designed in  
9 consultation with the state association of emergency medical  
10 technicians. As provided in this section, an amount of the fee  
11 collected shall be apportioned to the Emergency Medical Personnel  
12 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63  
13 of the Oklahoma Statutes;

14 11. Fight Breast Cancer License Plate - such plates shall be  
15 designed to demonstrate support for the prevention and treatment of  
16 breast cancer in this state. As provided in this section, an amount  
17 of the fee collected shall be apportioned to the Breast Cancer Act  
18 Revolving Fund;

19 12. Crime Victims Awareness License Plate - such plates shall  
20 be designed and issued to any person wishing to demonstrate  
21 awareness of and support for victims of crimes. The license plates  
22 shall be designed in consultation with the Oklahoma Crime Victims  
23 Centre. As provided in this section, an amount of the fee collected  
24 shall be apportioned to the Attorney General's Revolving Fund for



1 the Office of the Attorney General, which is hereby directed to use  
2 such funds to contract with a statewide nonprofit organization to  
3 provide services to crime victims;

4 13. Oklahoma Safe Kids Association License Plate - such plates  
5 shall be designed and issued to any person wishing to demonstrate  
6 support and awareness of the Oklahoma Safe Kids Association. The  
7 license plate shall be designed in consultation with the Oklahoma  
8 Safe Kids Association. As provided in this section, an amount of  
9 the fee collected shall be deposited in the Children's Hospital -  
10 Oklahoma Safe Kids Association Revolving Fund to be distributed to  
11 the Oklahoma Safe Kids Association program;

12 14. Four-H Club License Plate - such plates shall be designed,  
13 subject to criteria to be presented to the Tax Commission by the  
14 Four-H Foundation, and issued to any person wishing to demonstrate  
15 support of the Four-H Club. Such plates may be designed and issued  
16 to any person as for personalized license plates. As provided in  
17 this section, an amount of the fee collected shall be apportioned to  
18 the OSU Extension Service License Plate Revolving Fund created in  
19 Section 1104.4 of this title;

20 15. Agricultural Awareness License Plate - such plates shall be  
21 designed, subject to criteria to be presented to the Tax Commission,  
22 by the Oklahoma Department of Agriculture, Food, and Forestry in  
23 consultation with the Oklahoma Arts Council, and issued to any  
24 person wishing to demonstrate support of the Department's Ag in the

1 Classroom Education Program. As provided in this section, an amount  
2 of the fee collected shall be apportioned as provided in Section  
3 1104.3 of this title;

4 16. Oklahoma Statehood Centennial License Plate - such plates  
5 shall be designed and issued to any person wishing to commemorate  
6 the centennial of Oklahoma's admission to statehood in 1907. The  
7 license plates shall be designed in consultation with the Oklahoma  
8 Capitol Complex and Centennial Commemoration Commission. As  
9 provided in this section, an amount of the fee collected shall be  
10 deposited in the Oklahoma Department of Commerce Revolving Fund  
11 created in Section 5012 of Title 74 of the Oklahoma Statutes;

12 17. Support Education License Plate - such plates shall be  
13 designed, subject to criteria to be presented to the Tax Commission  
14 by the State Department of Education in consultation with the  
15 Oklahoma Arts Council, and issued to any person wishing to  
16 demonstrate support for education in this state. All motor license  
17 agents shall display a sample of the Support Education License plate  
18 in the area of the business accessed by the public. Twenty-three  
19 Dollars (\$23.00) of the fee collected shall be apportioned as  
20 follows:

- 21 a. five percent (5%) shall be deposited to the Education  
22 Reform Revolving Fund,
- 23 b. five percent (5%) shall be deposited to the Higher  
24 Education Revolving Fund,

- 1           c.     five percent (5%) shall be deposited to the State  
2                 Career Technology Fund, and  
3           d.     eighty-five percent (85%) shall be deposited to the  
4                 Teachers' Retirement Benefit Fund as set forth in  
5                 Section 17-108 of Title 70 of the Oklahoma Statutes.

6         However, when the Teachers' Retirement Benefit Fund attains a  
7         seventy percent (70%) funded ratio based on an annual actuarial  
8         valuation as required by law, the amount of the fee shall be  
9         apportioned equally pursuant to subparagraphs a, b and c of this  
10        paragraph;

11        18.   Retired Oklahoma Highway Patrol Officers License Plate -  
12        such plates shall be designed and issued to any retired officer of  
13        the Oklahoma Highway Patrol. The license plate shall have the  
14        legend "Oklahoma" and shall contain, in the center of the plate, the  
15        Highway Patrol Officers patch using the same colors and pattern as  
16        used in the patch. Centered on the bottom of the license plate  
17        shall be the word "Retired". The letters "TRP" shall be used in  
18        combination with three numbers on either side of the insignia or  
19        emblem. The color of the letters and numbers shall be brown.  
20        Retirees who are eligible for such plates shall provide proof of  
21        eligibility upon initial application, but shall not be required to  
22        provide proof of eligibility annually. The surviving spouse of any  
23        deceased retired officer of the Oklahoma Highway Patrol, if the  
24        spouse has not since remarried, or if remarried, the remarriage is

1 terminated by death, divorce, or annulment, may apply for a Retired  
2 Oklahoma Highway Patrol Officers license plate. As provided in this  
3 section, an amount of the fee collected shall be deposited into the  
4 Law Enforcement Retirement Fund;

5 19. Boy Scouts of America Supporter License Plate - such plates  
6 shall be designed and issued to any person wishing to demonstrate  
7 support for the Boy Scouts of America. The plates shall be issued  
8 to any person in any combination of numbers and letters from one to  
9 a maximum of seven, as for personalized license plates. The plate  
10 shall contain the official Boy Scouts of America logo. The Tax  
11 Commission shall be authorized, if necessary, to enter into a  
12 licensing agreement with the Boy Scouts of America for any licensing  
13 fees which may be required in order to use the Boy Scouts of America  
14 logo or design. The licensing agreement shall provide for a payment  
15 to the Boy Scouts of America of not more than Twenty Dollars  
16 (\$20.00) for each license plate issued;

17 20. Urban Forestry and Beautification License Plate - such  
18 plates shall be designed, subject to criteria to be presented to the  
19 Tax Commission, by the Oklahoma Department of Agriculture, Food, and  
20 Forestry in consultation with nonprofit organizations in this state  
21 that develop and operate programs to encourage urban forestry and  
22 beautification, and issued to any person wishing to demonstrate  
23 support of such programs. As provided in this section, an amount of  
24

1 the fee collected shall be apportioned as provided in Section 1104.5  
2 of this title;

3 21. Oklahoma State Parks Supporter License Plate - such plates  
4 shall be designed, subject to criteria to be presented to the Tax  
5 Commission by the Oklahoma Tourism and Recreation Department, and  
6 issued to any person wishing to demonstrate support for the Oklahoma  
7 state parks system. Twenty-three Dollars (\$23.00) of the fee  
8 collected shall be deposited in the Oklahoma Tourism and Recreation  
9 Department Revolving Fund. Such money shall be designated for and  
10 may only be expended for the support of Oklahoma state parks;

11 22. Adoption Creates Families License Plate - such plates shall  
12 be issued to any person wishing to demonstrate support of pregnant  
13 women who are committed to placing their children for adoption and  
14 wishing to provide assistance to guardians, adoptive parents and  
15 other created families to assist in the adoption and placement of  
16 children in permanent, safe homes. The license plates shall be  
17 designed and final terminology delivered in consultation with the  
18 Oklahoma Adoption Coalition and the Department of Human Services.  
19 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited  
20 in a revolving fund established in the State Treasury for and to be  
21 used by the Department of Human Services for the implementation of  
22 the Investing in Stronger Oklahoma Families Act specifically for  
23 created families;

1        23. Choose Life License Plate - such plates shall be designed,  
2 subject to criteria presented to the Tax Commission, by Choose Life,  
3 Inc., and issued to any person who wishes to demonstrate support of  
4 organizations that encourage adoption as a positive choice for women  
5 with unplanned pregnancies. As provided in this section, an amount  
6 of the fee collected shall be deposited in the Choose Life  
7 Assistance Program Revolving Fund established in Section 1104.6 of  
8 this title;

9        24. Future Farmers of America License Plate - such plates shall  
10 be designed and issued to persons wishing to demonstrate support for  
11 the Oklahoma FFA (formerly known as Future Farmers of America). The  
12 license plates shall be designed in consultation with the Oklahoma  
13 FFA Foundation Board of Directors. As provided in this section, an  
14 amount of the fee collected shall be apportioned as provided in  
15 Section 1104.7 of this title;

16        25. Lions Club License Plate - such plates shall be designed  
17 and issued to persons wishing to demonstrate support for the Lions  
18 Club of Oklahoma. The plates shall be issued to any person in any  
19 combination of numbers and letters from one to a maximum of seven,  
20 as for personalized license plates. The license plates shall be  
21 designed in consultation with the Oklahoma Lions Service Foundation  
22 and shall contain the official logo of the International Association  
23 of Lions Clubs. The Tax Commission shall be authorized to enter  
24 into a licensing agreement with the Oklahoma Lions Service

1 Foundation. The licensing agreement shall provide for a payment to  
2 the Oklahoma Lions Service Foundation of not more than Ten Dollars  
3 (\$10.00) for each license plate issued;

4 26. Color Oklahoma License Plate - such plates shall be  
5 designed, subject to criteria to be presented to the Tax Commission  
6 by the Oklahoma Native Plant Society, and issued to any person  
7 wishing to demonstrate support for preserving and planting  
8 wildflowers and native plants in Oklahoma and to promote Oklahoma's  
9 wildflower heritage through education. As provided in this section,  
10 an amount of the fee collected shall be apportioned as provided in  
11 Section 1104.8 of this title;

12 27. Girl Scouts of the United States of America Supporter  
13 License Plate - such plates shall be designed and issued to any  
14 person wishing to demonstrate support for the Girl Scouts of the  
15 United States of America. The plates shall be issued to any person  
16 in any combination of numbers and letters from one to a maximum of  
17 seven, as for personalized license plates. The plate shall contain  
18 the official Girl Scouts of the United States of America logo. The  
19 Tax Commission shall be authorized, if necessary, to enter into a  
20 licensing agreement with the Girl Scouts of the United States of  
21 America for any licensing fees which may be required in order to use  
22 the Girl Scouts of the United States of America logo or design. The  
23 licensing agreement shall provide for a payment to the Girl Scouts  
24 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout

1 councils, of not more than Twenty Dollars (\$20.00) for each license  
2 plate issued;

3 28. Oklahoma City Memorial Marathon License Plate - such plates  
4 shall be designed and issued to any person wishing to demonstrate  
5 support for the Oklahoma City Memorial Marathon. The plate shall be  
6 designed in consultation with the Oklahoma City Memorial Marathon.  
7 The Tax Commission shall be authorized to enter into a licensing  
8 agreement with the Oklahoma City Memorial Marathon for any licensing  
9 fees which may be required in order to use the Oklahoma City  
10 Memorial Marathon logo or design. The licensing agreement shall  
11 provide for a payment to the Oklahoma City Memorial Marathon of not  
12 more than Twenty Dollars (\$20.00) for each license plate issued;

13 29. Oklahoma Scenic Rivers License Plate - such plates shall be  
14 designed to demonstrate support for the Oklahoma Scenic Rivers. The  
15 plates shall be designed in consultation with the Oklahoma Scenic  
16 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be  
17 apportioned to the Oklahoma Scenic Rivers Commission;

18 30. Fight Cancer License Plate - such plates shall be designed  
19 to demonstrate support for the Oklahoma Central Cancer Registry.  
20 The plate shall contain the American Cancer Society logo. The  
21 American Cancer Society logo shall be used in accordance with the  
22 American Cancer Society's branding guidelines and shall only be  
23 utilized to support the Oklahoma Central Cancer Registry. Twenty  
24



1 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma  
2 Central Cancer Registry Revolving Fund;

3 31. Animal Friendly License Plate - such plates shall be  
4 designed and issued to any person wishing to demonstrate support for  
5 controlling the overpopulation of dogs and cats through educational  
6 and sterilization efforts. The plates shall be designed in  
7 consultation with the Veterinary Medical Association. Twenty  
8 Dollars (\$20.00) of the fee collected shall be designated by the  
9 purchaser of the plate to be deposited in the Oklahoma Pet  
10 Overpopulation Fund created in Section 2368.13 of Title 68 of the  
11 Oklahoma Statutes or the Animal Friendly Revolving Fund created in  
12 Section 1104.10 of this title;

13 32. Patriot License Plate - such plates shall be designed in  
14 consultation with the Military Department of Oklahoma and issued to  
15 any person wishing to demonstrate support for Oklahoma residents who  
16 are members of the Oklahoma National Guard and deployed on active  
17 duty. The plates shall be issued to any person in any combination  
18 of numbers and letters from one to a maximum of seven, as for  
19 personalized license plates. As provided in this section, a portion  
20 of the fee collected shall be deposited in the Patriot License Plate  
21 Revolving Fund created in Section 1104.11 of this title;

22 33. Global War on Terrorism License Plate - such plate shall be  
23 designed in consultation with the Military Department of Oklahoma  
24 and issued to any person wishing to demonstrate support for Oklahoma

1 residents who are members of the Armed Forces of the United States  
2 or Oklahoma National Guard that have served in the Global War on  
3 Terrorism. The plate shall be issued to any person in any  
4 combination of numbers and letters from one to a maximum of six. As  
5 provided in this section, a portion of the fee collected shall be  
6 deposited in the Oklahoma National Guard Museum Fund created in  
7 Section 235.1 of Title 44 of the Oklahoma Statutes;

8 34. Boys and Girls Clubs of America Supporter License Plate -  
9 such plates shall be designed and issued to any person wishing to  
10 demonstrate support for the Boys and Girls Clubs of America. The  
11 plates shall be issued to any person in any combination of numbers  
12 and letters from one to a maximum of seven, as for personalized  
13 license plates. The plate shall contain the official Boys and Girls  
14 Clubs of America logo. The Tax Commission, if necessary, may enter  
15 into a licensing agreement with the Boys and Girls Clubs of America  
16 for any licensing fees which may be required in order to use the  
17 Boys and Girls Clubs of America logo or design. The licensing  
18 agreement shall provide for a payment to the Boys and Girls Clubs of  
19 America of not more than Twenty Dollars (\$20.00) for each license  
20 plate issued;

21 35. Oklahoma Quarter Horse License Plate - such plates shall be  
22 designed and issued to any person wishing to demonstrate support for  
23 the American Quarter Horse in Oklahoma. The plate shall be designed  
24 in consultation with the Oklahoma Quarter Horse Association. As

1 provided in this section, a portion of the fee collected shall be  
2 deposited in the Oklahoma Quarter Horse Revolving Fund created in  
3 Section 1104.12 of this title;

4 36. Oklahoma Association for the Deaf License Plate - such  
5 plates shall be designed in consultation with the Oklahoma  
6 Association for the Deaf and issued to any person wishing to  
7 demonstrate support for Oklahoma residents who are deaf. The plates  
8 shall be issued to any person in any combination of numbers and  
9 letters from one to a maximum of seven, as for personalized license  
10 plates. As provided in this section, a portion of the fee collected  
11 shall be deposited in the Oklahoma Association for the Deaf License

12 licensing agreement with the Woodward School District for any  
13 licensing fees which may be required in order to use the school  
14 district's logo or design. The licensing agreement shall provide  
15 for a payment to the Woodward School District of not more than  
16 Twenty Dollars (\$20.00) for each license plate issued;

17 79. Clinton Public School Foundation License Plate - such  
18 plates shall be designed and issued to any person wishing to  
19 demonstrate support for the Clinton Public School Foundation. The  
20 license plates shall be designed in consultation with the Clinton  
21 Public School Foundation. The Tax Commission shall be authorized to  
22 enter into a licensing agreement with the Clinton Public School  
23 Foundation for any licensing fees which may be required in order to  
24 use the school foundation's logo or design. The licensing agreement

1 shall provide for a payment to the Clinton Public School Foundation  
2 of not more than Twenty Dollars (\$20.00) for each license plate  
3 issued;

4 80. Navajo School Foundation License Plate - such plates shall  
5 be issued to any person wishing to demonstrate support for the  
6 Navajo School Foundation. The license plates shall be designed in

9 enter into a licensing agreement with the Navajo School Foundation  
10 for any licensing fees which may be required in order to use the  
11 Foundation's logo or design. The licensing agreement shall provide  
12 for a payment to the Navajo School Foundation of not more than  
13 Twenty Dollars (\$20.00) for each license plate issued;

14 81. Oklahoma Music Hall of Fame Inc. License Plate - such  
15 plates shall be designed in consultation with the Oklahoma Music  
16 Hall of Fame Inc. and issued to any member of the organization  
17 wishing to demonstrate support. The Tax Commission shall be  
18 authorized to enter into a licensing agreement with the Oklahoma  
19 Music Hall of Fame Inc. for any licensing fees which may be required  
20 in order to use the organization's logo or design. The licensing  
21 agreement shall provide for a payment to the Oklahoma Music Hall of  
22 Fame Inc. of not more than Twenty Dollars (\$20.00) for each license  
23 plate issued. The plates shall incorporate a numbering system  
24 agreed upon by the Oklahoma Music Hall of Fame Inc. and the Tax

1 Commission. Subject to the provisions of subsection A of this  
2 section, the Oklahoma Music Hall of Fame Inc. License Plate is  
3 hereby reauthorized effective November 1, 2019;

4 82. Techlahoma Foundation License Plate - such plates shall be  
5 issued to any person wishing to provide financial support for the  
6 Techlahoma Foundation. The license plate shall be designed in  
7 consultation with the Techlahoma Foundation. The plate shall be  
8 issued to any person in any combination of numbers and letters from  
9 one to a maximum of seven, as for personalized license plates. The  
10 Tax Commission shall be authorized to enter into a licensing  
11 agreement with the Techlahoma Foundation for any licensing fees,  
12 which may be required in order to use the association's logo or  
13 design. The licensing agreement shall provide for a payment to the  
14 Techlahoma Foundation of not more than Twenty Dollars (\$20.00) for  
15 each license plate issued;

16 83. Bethany Public Schools Foundation License Plate - such  
17 plates shall be issued to any person wishing to demonstrate support  
18 for the Bethany Public Schools Foundation. The license plates shall  
19 be designed in consultation with the administration of the Bethany  
20 Public Schools Foundation. The Oklahoma Tax Commission shall be  
21 authorized to enter into a licensing agreement with the Bethany  
22 Public Schools Foundation for any licensing fees which may be  
23 required in order to use the Foundation's logo or design. The  
24 licensing agreement shall provide for a payment to the Bethany

1 Public Schools Foundation of not more than Twenty Dollars (\$20.00)  
2 for each license plate issued;

3 84. Cystic Fibrosis Foundation License Plate - such plates  
4 shall be issued to any person wishing to demonstrate support for the

7 Foundation. The Oklahoma Tax Commission shall be authorized to  
8 enter into a licensing agreement with the Cystic Fibrosis Foundation  
9 for any licensing fees which may be required in order to use the  
10 Foundation's logo or design. The licensing agreement shall provide  
11 for a payment to the Cystic Fibrosis Foundation of not more than  
12 Twenty Dollars (\$20.00) for each license plate issued;

13 85. Down Syndrome Association of Central Oklahoma License Plate  
14 - such plates shall be designed and issued to any person wishing to  
15 demonstrate support for the Down Syndrome Association of Central  
16 Oklahoma. Such plates shall be designed in consultation with the  
17 Association. As provided in this section, an amount of the fee  
18 collected shall be deposited in the Down Syndrome Association of  
19 Central Oklahoma License Plate Revolving Fund created in Section  
20 1104.30 of this title;

21 86. Elk City Education Foundation License Plate - such plates  
22 shall be designed and issued to any person wishing to demonstrate  
23 support for the Elk City Education Foundation. Such plates shall be  
24 designed in consultation with the Foundation. As provided in this



1 section, an amount of the fee collected shall be deposited in the  
2 Elk City Education Foundation License Plate Revolving Fund created  
3 in Section 1104.31 of this title;

4 87. A Brotherhood Aiming Toward Education of Oklahoma (ABATE)  
5 License Plate - such plates shall be designed and issued to any  
6 person wishing to provide financial support for ABATE of Oklahoma.  
7 Such plates shall be designed in consultation with ABATE of  
8 Oklahoma. The plates shall be issued to any person in any  
9 combination of numbers and letters from one to a maximum of seven,  
10 as for personalized plates. The license plate for a motorcycle may  
11 be of similar design as space permits or a new design in order to  
12 meet the space requirements of a motorcycle license plate. The  
13 Oklahoma Tax Commission shall be authorized to enter into a  
14 licensing agreement with ABATE of Oklahoma for any licensing fees  
15 which may be required in order to use the ABATE of Oklahoma logo or  
16 design. The licensing agreement shall provide for a payment to  
17 ABATE of Oklahoma of not more than Twenty Dollars (\$20.00) for each  
18 license plate issued;

19 88. Downed Bikers Association License Plate - such plates shall  
20 be designed for a vehicle or motorcycle in any combination of  
21 numbers and letters from one to a maximum of seven, as for  
22 personalized license plates, and issued to any person wishing to  
23 demonstrate support for the Downed Bikers Association, a nonprofit  
24 charitable organization exempt from taxation pursuant to the

provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), which provides emotional and financial support for downed bikers. The license plate shall be designed in consultation with the Central Oklahoma Chapter of the Downed Bikers Association and shall contain any official logo or design of the organization. The license plate for a motorcycle may be of similar design as space permits or a new design in order to meet the space requirements of a motorcycle license plate. The Tax Commission, if necessary, may enter into a licensing agreement with the Downed Bikers Association for any licensing fees which may be required in order to use the organization's logo or design. 89. Eagle Scout License Plate - such plates shall be designed to demonstrate support for Eagle Scouts and shall include the Eagle Scout logo. Plates may be issued to any person who can show proof of having obtained the rank of Eagle Scout. The Oklahoma Tax Commission shall be authorized to enter into a licensing agreement with the various Oklahoma local councils for any licensing fees which may be required in order to use the applicable logo or design. The licensing agreement shall provide for a payment of not more than Twenty Dollars (\$20.00) for each license plate issued to the specific Oklahoma local area Council designated by the applicant;

1        90. Extraordinary Educators License Plate - such plates shall

11        91. Former Oklahoma Legislator License Plate - such plates  
12 shall be designed and issued to any person who previously served as  
13 a member of the Oklahoma House of Representatives or Oklahoma State  
14 Senate. The license plates shall be designed in consultation with  
15 the Oklahoma Historical Society. As provided in this section, an  
16 amount of the fee collected shall be deposited in the Oklahoma  
17 Historical Society Capital Improvement and Operations Revolving Fund  
18 created in Section 1.10a of Title 53 of the Oklahoma Statutes. The  
19 Tax Commission shall create and maintain a list of former members of  
20 the Oklahoma House of Representatives and Oklahoma State Senate  
21 eligible to be issued such plates; provided, that no former member  
22 of the Oklahoma House of Representatives and Oklahoma State Senate  
23 shall be eligible to possess more than two of such plates at any one

6 membership in the Oklahoma Veterans of Foreign Wars organization.

7 The license plates shall be designed in consultation with the  
8 Oklahoma Veterans of Foreign Wars organization. The Tax Commission  
9 shall be authorized to enter into a licensing agreement with the  
10 Oklahoma Veterans of Foreign Wars organization for any licensing  
11 fees which may be required in order to use the organization's logo  
12 or design. The licensing agreement shall provide for a payment to  
13 the Oklahoma Veterans of Foreign Wars organization of not more than

11 The license plates shall be designed in consultation with the  
12 administration of FIRST. The Oklahoma Tax Commission shall be  
13 authorized to enter into a licensing agreement with FIRST for any  
14 licensing fees which may be required in order to use the FIRST logo  
15 or design. The licensing agreement shall provide for a payment to  
16 FIRST of not more than Twenty Dollars (\$20.00) for each license  
17 plate issued;

18 97. Pittsburg State University License Plate - such plates  
19 shall be designed and issued to any person wishing to demonstrate  
20 support for the Pittsburg State University. The license plates  
21 shall be designed in consultation with Pittsburg State University.  
22 The Tax Commission shall be authorized to enter into a licensing  
23 agreement with Pittsburg State University for any licensing fees  
24 which may be required in order to use the school foundation's logo

1 or design. The licensing agreement shall provide for a payment to  
2 the Pittsburg State University of not more than Twenty Dollars  
3 (\$20.00) for each license plate issued;

4 98. Historic Greenwood District License Plate - such plates  
5 shall be issued to persons wishing to demonstrate support for the  
6 Historic Greenwood District Juneteenth Festival held in the Historic  
7 Greenwood District in Tulsa, Oklahoma. The plates shall be issued  
8 to any person in any combination of numbers and letters from one to  
9 a maximum of seven, as for personalized license plates. The license  
10 plates shall be designed in consultation with the Black Wall Street  
11 Chamber of Commerce. The Tax Commission shall be authorized to  
12 enter into a licensing agreement with the Historic Greenwood  
13 District Juneteenth Festival for any licensing fees which may be  
14 required in order to use the Festival's logo or design. For each  
15 license plate issued, the licensing agreement shall provide for a

6 104. Paramedic License Plate - such plates shall be designed  
7 and issued to any person who is a paramedic. Such persons may apply  
8 for a paramedic license plate for each vehicle with a rated carrying  
9 capacity of one (1) ton or less upon proof of a paramedic license.  
10 The license plates shall be designed in consultation with the  
11 Oklahoma State University-Oklahoma City Paramedicine Program and the  
12 Oklahoma Emergency Medical Technicians Association. The Tax  
13 Commission shall be authorized to enter into a licensing agreement  
14 with the Oklahoma Emergency Medical Technicians Association for any

24 the Oklahoma Department of Veterans Affairs. The license plates

1 shall be designed in consultation with the Oklahoma Department of  
2 Veterans Affairs. The Tax Commission shall be authorized to enter  
3 into a licensing agreement with the Oklahoma Department of Veterans  
4 Affairs for any licensing fees which may be required in order to use  
5 the Department's logo or design. The licensing agreement shall  
6 provide for a payment to the Oklahoma Department of Veterans Affairs  
7 of not more than Twenty Dollars (\$20.00) for each license plate  
8 issued;

9 106. University of Oklahoma RUF/NEKS License Plate - such  
10 plates shall be designed and issued to any past or present member of

12 membership in the organization as may be required by the Tax  
13 Commission. The license plates shall be designed in consultation  
14 with the University of Oklahoma RUF/NEKS. The Tax Commission shall  
15 be authorized to enter into a licensing agreement with the  
16 University of Oklahoma RUF/NEKS for any licensing fees which may be  
17 required in order to use the organization's logo or design. The

1 licensing agreement with Tulsa Community College for any licensing  
2 fees which may be required in order to use the organization's logo

4 Tulsa Community College of not more than Twenty Dollars (\$20.00) for  
5 each license plate issued;

6 108. Guthrie Street Kings License Plate - such plates shall be  
7 designed and issued to any person wishing to demonstrate support for

9 consultation with the Guthrie Street Kings. The Tax Commission  
10 shall be authorized to enter into a licensing agreement with the

18 consultation with the Epilepsy Foundation of Oklahoma. The Tax  
19 Commission shall be authorized to enter into licensing agreements  
20 with the Epilepsy Foundation for any licensing fees which may be  
21 required in order to use the organization's logo or design. The  
22 licensing agreement shall provide for a payment to the Epilepsy  
23 Foundation of not more than Twenty Dollars (\$20.00) for each license

1 110. America First License Plate - such plates shall be  
2 designed and issued to any person wishing to demonstrate support for  
3 the proclamation of "America First". The license plates shall be  
4 designed in consultation with Warriors for Freedom and the Honoring  
5 America's Warriors Foundations. The Tax Commission shall be  
6 authorized to enter into licensing agreements with the Warriors for  
7 Freedom and Honoring America's Warriors Foundations for any

19 may be required in order to use the organization's logo or design.

23 C. The fee for such plates shall be Thirty-five Dollars  
24 (\$35.00) per year of renewal and shall be in addition to all other

2 Registration Act. The fee shall be apportioned as follows:

3 1. Twenty Dollars (\$20.00) per year of renewal or any other  
4 amount as provided in this title of the fee shall be apportioned as  
5 provided or deposited in a fund as specified within the paragraph  
6 authorizing the special license plate;

7 2. Eight Dollars (\$8.00) per year of renewal of the fee shall  
8 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be  
9 used for the administration of the Oklahoma Vehicle License and  
10 Registration Act; and

11 3. Any remaining amounts of the fee shall be apportioned as  
12 provided in Section 1104 of this title.

13 SECTION 2. This act shall become effective November 1, 2022.
