18	now buried on said property be and the same are placed known
19	historically as the Union Soldiers Cemetery located on the southeast
20	corner of Northeast 36th Street and Martin Luther King Avenue in
21	Oklahoma City shall remain under the supervision and care of the
22	Adjutant General of the State of Oklahoma <u>until such time as the</u>
23	Executive Director of the Oklahoma Department of Veterans Affairs
24	certifies to the Oklahoma Veterans Commission receipt of such funds
