in the Oklahoma Statutes as Section 3235.3 of Title 70, unless there
sis created a duplication in numbering, reads as follows:

Universities within the Oklahoma State System of Higher

Education shall receive one-third of the monies within the Needed

Oklahoma Workers Fund for nursing students. The money shall be

divided amongst the universities on a per enrolled nursing student

basis.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 3235.4 of Title 70, unless there is created a duplication in numbering, reads as follows:

Universities within the Oklahoma State System of Higher

Education shall receive one-third of the monies within the Needed

Oklahoma Workers Fund for engineering students. The money shall be divided amongst the universities on a per enrolled engineering student basis.

SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 3235.5 of Title 70, unless there is created a duplication in numbering, reads as follows:
