Prominent examples 13 include the "Yellow Peril", the Chinese Exclusion Act, and the 14 internment of Japanese Americans during World War II; and 15 WHEREAS, since the COVID-19 pandemic began, there has been a 16 spike in discrimination and hate crimes toward the Asian American 17 and Pacific Islander community. More than thirty percent (30%) of 18 Asian Americans and Pacific Islanders have reported being subjected 19 to discrimination since the beginning of the pandemic. According to 20 "Stop AAPI Hate", 3,795 incidents have been reported between March 21 19, 2020, and February 28, 2021, from all 50 states. Incidents have 22 included physical assault, verbal harassment, shunning, workplace 23 discrimination, refusal of service, and online harassment; and

1 WHEREAS, acts of hate and discrimination are antithetical to our 2 values as Oklahomans and Americans. As civic leaders, it is our 3 duty to promote respect, inclusion, and a welcoming community for 4 people of all races, national origins, and ethnicities; and 5 WHEREAS, all Oklahomans can play a role in establishing a safe and welcoming community by intervening and reporting instances of 6 7 hate and discrimination. Reporting these incidents is critical to holding perpetrators accountable and fully addressing the issue; and 8 9 WHEREAS, the Oklahoma House of Representatives condemns hate 10 crimes, hateful rhetoric, and hateful acts against the Asian 11 American and Pacific Islander community; and 12
