Germaneness: No point of order shall be considered related to the germaneness of any amendment offered to the measures listed in this Special Rule, and the provisions of the House Rules governing germaneness of a floor amendment to a House measure shall not be applicable to the measures listed in this Special Rule.

9 Floor Amendments: Except for floor amendments proposed by the 10 Principal Author of any measure listed in this Special Rule, no 11 floor amendment shall be presented to or considered by the House on 12 the measures listed in this Special Rule, and except as otherwise 13 provided by this Special Rule, the provisions of House Rule No. 8.8 14 shall not be applicable to these measures.

15 Legislative Procedural Schedule: The measures listed in this 16 Special Rule shall not be subject to the provisions of Joint Rule 17 7(a).

SECTION 3. The terms of this Special Rule shall take precedence when in conflict with the House Rules; otherwise, the House Rules shall remain applicable. The presiding officer shall strictly construe the provisions of this Special Rule.
