Soliciting, accepting, or performing uncompensated volunteer 10 services for a partisan election or any partisan campaign; 11 Soliciting or discouraging political activity; 7. 12 8. Campaigning for or against referendum questions, 13 constitutional amendments, and municipal ordinances; 14 9. Campaigning for or against candidates in partisan elections; 15 10. A teacher may not be compelled to discuss a particular
current event or widely debated and currently controversial issue of
public policy or social affairs.

C. Failure to comply with the provisions of this section may
lead to the suspension of a teacher's employment subject to the
provisions of the Teacher Due Process Act of 1990.

SECTION 2. This act shall become effective July 1, 2022. SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
