SECTION 1. AMENDATORY 47 O.S. 2011, Section 1116, is amended to read as follows:

3 Section 1116. A. Twelve registration periods shall be 4 established for vehicles required to be registered on a staggered 5 basis. The registration periods shall start on the first day of 6 each calendar month and shall end on the last day of that month. 7 Unless otherwise provided, all such vehicles where the date of 8 execution of transfer of ownership occurs in this state at any time 9 during a calendar month shall be subject to registration and payment 10 of the fee for the registration period commencing the first day of 11 the month of such date of execution of transfer.

B. A person who registers more than one vehicle may have all of such vehicles initially registered at the same time or at separate times. Any person who obtains a vehicle may, upon registration, have the registration period adjusted to allow future registration of all such vehicles at the same period or at a different period.

17 <u>C. On and after January 1, 2022, if a special or personalized</u> 18 <u>license plate is issued pursuant to this title for a vehicle which</u> 19 <u>is subject to the requirements of Section 1132 of this title, the</u> 20 <u>registration periods for the vehicle may be combined into a single</u> 21 <u>registration period. The Oklahoma Tax Commission shall determine,</u> 22 <u>by rule, a method for adjusting the twelve-month period.</u>

SECTION 2. AMENDATORY 47 O.S. 2011, Section 1132, as amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2020, Section 1132), is amended to read as follows:

Section 1132. A. For all vehicles, unless otherwise
specifically provided by the Oklahoma Vehicle License and
Registration Act, a registration fee shall be assessed at the time
of initial registration by the owner and annually thereafter, for
the use of the avenues of public access within this state in the
following amounts:

10 1. For the first through the fourth year of registration in 11 this state or any other state, Eighty-five Dollars (\$85.00);

12 2. For the fifth through the eighth year of registration in 13 this state or any other state, Seventy-five Dollars (\$75.00);

¹⁴ 3. For the ninth through the twelfth year of registration in ¹⁵ this state or any other state, Fifty-five Dollars (\$55.00);

¹⁶ 4. For the thirteenth through the sixteenth year of ¹⁷ registration in this state or any other state, Thirty-five Dollars ¹⁸ (\$35.00); and

19 5. For the seventeenth and any following year of registration
 20 in this state or any other state, Fifteen Dollars (\$15.00).

The registration fee provided for in this subsection shall be in lieu of all other taxes, general or local, unless otherwise specifically provided.

1	On and after January 1, 2022, if a special or personalized
2	license plate is issued pursuant to Sections 1135.1 through 1135.7
3	of this title, any registration fee required for such plate and the
4	fee required pursuant to this subsection shall be remitted at the
5	same time and subject to a single registration period. The Oklahoma
6	Tax Commission shall determine, by rule, a method for making
7	required fee adjustments when a special or personalized license
8	plate is obtained during a twelve-month period for which a
9	registration fee has already been remitted pursuant to this
10	subsection. The combination of fees in a single remittance shall
11	not alter the apportionment otherwise provided for by law.
12	B. For all-terrain vehicles and motorcycles used exclusively
13	for use off roads or highways purchased on or after July 1, 2005,
14	and for all-terrain vehicles and motorcycles used exclusively for
15	use off roads or highways purchased prior to July 1, 2005, which the
16	owner chooses to register pursuant to the provisions of Section
17	1115.3 of this title, an initial and nonrecurring registration fee
18	of Eleven Dollars (\$11.00) shall be assessed at the time of initial
19	registration by the owner. Nine Dollars (\$9.00) of the registration
20	fee shall be deposited in the Oklahoma Tax Commission Reimbursement
21	Fund. Two Dollars (\$2.00) of the registration fee shall be retained
22	by the motor license agent. The fees required by subsection A of
23	this section shall not be required for all-terrain vehicles or
24 27	motorcycles used exclusively off roads and highways.

1 C. For utility vehicles used exclusively for use off roads or 2 highways purchased on or after July 1, 2008, and for utility 3 vehicles used exclusively for use off roads or highways purchased 4 prior to July 1, 2008, which the owner chooses to register pursuant 5 to the provisions of Section 1115.3 of this title, an initial and 6 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be 7 assessed at the time of initial registration by the owner. Nine 8 Dollars (\$9.00) of the registration fee shall be deposited in the 9 Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of 10 the registration fee shall be retained by the motor license agent. 11 The fees required by subsection A of this section shall not be 12 required for utility vehicles used exclusively off roads and 13 highways.

D. There shall be a credit allowed with respect to the fee for registration of a new vehicle which is a replacement for:

16 1. A new original vehicle which is stolen from the 17 purchaser/registrant within ninety (90) days of the date of purchase 18 of the original vehicle as certified by a police report or other 19 documentation as required by the Oklahoma Tax Commission; or

20 2. A defective new original vehicle returned by the 21 purchaser/registrant to the seller within six (6) months of the date 22 of purchase of the defective new original vehicle as certified by 23 the manufacturer.

The credit shall be in the amount of the fee for registration which was paid for the new original vehicle and shall be applied to the registration fee for the replacement vehicle. In no event will the credit be refunded.

5 Upon every transfer or change of ownership of a vehicle, the Ε. 6 new owner shall obtain title for and, except in the case of salvage 7 vehicles and manufactured homes, register the vehicle within thirty 8 (30) days of change of ownership and pay a transfer fee of Fifteen 9 Dollars (\$15.00) in addition to any other fees provided for in this 10 act the Oklahoma Vehicle License and Registration Act. No new decal 11 shall be issued to the registrant. Thereafter, the owner shall 12 register the vehicle annually on the anniversary date of its initial 13 registration in this state and shall pay the fees provided in 14 subsection A of this section and receive a decal evidencing such 15 payment. Provided, used motor vehicle dealers shall be exempt from 16 the provisions of this section.

F. In the event a new or used vehicle is not registered, titled and tagged within thirty (30) days from the date of transfer of ownership, the penalty for the failure of the owner of the vehicle to register the vehicle within thirty (30) days shall be One Dollar (\$1.00) per day, provided that in no event shall the penalty exceed One Hundred Dollars (\$100.00). No penalty shall be waived by the Oklahoma Tax Commission or any motor license agent except as

7 3. Fifty-eight cents (\$0.58) shall be deposited in the General

9 SECTION 3. AMENDATORY 47 O.S. 2011, Section 1135.1, as 10 amended by Section 1, Chapter 26, O.S.L. 2016 (47 O.S. Supp. 2020, 11 Section 1135.1), is amended to read as follows:

Section 1135.1. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons as provided by this section.

Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year.

Except as provided in subsection B of this section, special license plates shall be renewed each year by the Tax Commission or a motor license agent. The Tax Commission shall annually notify by mail all persons issued special license plates. The notice shall contain all necessary information and shall contain instructions for

21	political subdivisions shall file an annual report with the Tax			
22	Commission stating the agency where such vehicle is located. Such			
23	license plates shall be permanent in nature and designed in such a			
24 27	manner as to remain with the vehicle for the duration of the life			

1 span of the vehicle or until the title is transferred to an owner 2 who is not a political subdivision.

The registration fee shall be Eight Dollars (\$8.00) and shall be in addition to all other registration fees provided by law, except the registration fees levied by Section 1132 of this title;

6 2. Tax-Exempt or Nonprofit License Plates - such plates shall 7 be designed for:

8	a.	any motor bus, manufactured home, or mobile chapel and
9		power unit owned and operated by a religious
10		corporation or society of this state holding a valid

12		501(a) of the Internal Revenue Code, 26 U.S.C.,

1 501(c)(3), and which is primarily funded by a 2 fraternal or civic service organization with at 3 least one hundred local chapters or clubs, and 4 (2) is designed and used to provide mobile health 5 screening services to the general public at no 6 cost to the recipient, and for which no 7 reimbursement of any kind is received from any 8 health insurance provider, health maintenance 9 organization or governmental program, or 10 any vehicle owned and operated by the Civil Air q. 11 Patrol, a congressionally chartered corporation that 12 also serves an auxiliary of the United States Air 13 Force and which is exempt from taxation pursuant to 14 the provisions of Section 501(c)(3) of the Internal 15 Revenue Code, 26 U.S.C., Section 501(c)(3), and is 16 used exclusively for its corporate missions of 17 aerospace education, cadet programs and emergency 18 services. Such license plates shall be permanent in 19 nature and designed in such a manner as to remain with 20 the vehicle for the duration of the life span of the 21 vehicle or until the title to such vehicle is 22 transferred to an owner who is not subject to this 23 exemption. Such vehicles shall be exempt from the 24 registration fees levied under Section 1132 of this - م

title, except that an initial registration fee of Twenty-five Dollars (\$25.00) shall apply to each vehicle.

4 Any person claiming to be eligible for a tax-exempt or nonprofit 5 license plate under the provisions of this paragraph must have the 6 name of the tax-exempt or nonprofit organization prominently 7 displayed upon the outside of the vehicle, except those vehicles 8 registered pursuant to the provisions of subparagraph b of this 9 paragraph, unless such display is prohibited by federal or state law 10 or by state agency rules. No vehicle shall be licensed as a tax-11 exempt or nonprofit vehicle unless the vehicle has affixed on each 12 side thereof, in letters not less than two (2) inches high and two 13 (2) inches wide, the name of the tax-exempt or nonprofit 14 organization or the insignia or other symbol of such organization 15 which shall be of sufficient size, shape and color as to be readily 16 legible during daylight hours from a distance of fifty (50) feet 17 while the vehicle is not in motion.

Except as provided in subparagraph g of this paragraph, the registration fee shall be Eight Dollars (\$8.00) and shall be in addition to all other registration fees provided by law, except the registration fees levied by Section 1132 of this title;

3. Physically Disabled License Plates - such plates shall be designed for persons who are eligible for a physically disabled placard under the provisions of Section 15-112 of this title. It

1 shall prominently display the international accessibility symbol, 2 which is a stylized human figure in a wheelchair. The Tax 3 Commission shall also design physically disabled license plates for 4 motorcycles owned by persons who are eligible for a physically 5 disabled placard pursuant to the provisions of Section 15-112 of 6 this title. Upon the death of the physically disabled person, the 7 disabled license plate shall be returned to the Tax Commission. 8 There shall be no fee for such plate in addition to the rate 9 provided by the Oklahoma Vehicle License and Registration Act for 10 the registration of the vehicle. For an additional fee of Ten 11 Dollars (\$10.00), a person eligible for a physically disabled 12 license plate shall have the option of purchasing a duplicate 13 physically disabled special license plate which shall be securely 14 attached to the front of the vehicle. The original physically 15 disabled special license plate shall be securely attached to the 16 rear of the vehicle at all times.

Any person who is eligible for a physically disabled license plate and whose vehicle has had modifications because of the physical disability of the owner or of a family member within the second degree of consanguinity of the owner, may register the vehicle for a flat fee of Twenty-five Dollars (\$25.00). This fee shall be in lieu of all other registration fees provided by the Oklahoma Vehicle License and Registration Act;

4. Indian Tribal License Plates - such plates shall be designed
 for any vehicle of a native American Indian Tribal Association
 exempted in Sections 201 through 204 of Public Law 97-473 and used
 by the tribal association exclusively for the furtherance of its
 tribal functions.

The registration fee shall be Eight Dollars (\$8.00) and shall be in addition to all other registration fees provided by law, except the registration fees levied by Section 1132 of this title;

9 5. Hearing Impaired License Plates - such plates shall be 10 designed for persons who are hearing impaired. Such persons may 11 apply for a hearing-impaired license plate for each vehicle with a 12 rated carrying capacity of one (1) ton or less upon the presentment 13 of an application on a form furnished by the Tax Commission and 14 certified by a physician holding a valid license to practice 15 pursuant to the licensing provisions of Title 59 of the Oklahoma 16 Statutes, attesting that the person is hearing impaired. The 17 license plate shall be designed so that such persons may be readily 18 identified as being hearing impaired. There shall be no additional 19 fee for the plate, but all other registration fees provided by the 20 Oklahoma Vehicle License and Registration Act shall apply;

6. Antique or Classic Vehicles License Plates - such plates shall be designed and issued for any vehicle twenty-five (25) years of age or older, based upon the date of manufacture thereof and

¹ which travels on the highways of this state primarily incidental to ² historical or exhibition purposes only.

3 The registration fee shall be Eight Dollars (\$8.00) and shall be 4 in addition to all other registration fees provided by law, except 5 the registration fees levied by Section 1132 of this title. Any 6 person registering an antique or classic vehicle may elect to have 7 the vehicle registered for a ten-year period. The registration fee 8 for the elected ten-year registration shall be Seventy-five Dollars 9 (\$75.00). The motor license agent registering the antique or 10 classic vehicle for a ten-year period shall receive one hundred 11 percent (100%) of the fees the motor license agent would have 12 otherwise received pursuant to subsection A of Section 1141.1 of 13 this title if the antique or classic vehicle had been registered on 14 an annual basis; and

15 7. Honorary Consul License Plates - such plates shall be 16 designed to include the words "Honorary Consul" and issued to 17 persons who are honorary consuls authorized by the United States to 18 perform consular duties. Persons applying for such license plates 19 must show proof of standing as an honorary consul. The fee for such 20 plate shall be Eight Dollars (\$8.00) and shall be in addition to all 21 other registration fees required by the Oklahoma Vehicle License and 22 Registration Act. The owner of the vehicle that possesses such 23 license plates shall return the special license plates to the 24 Oklahoma Tax Commission if the owner disposes of the vehicle during _ _

¹ the registration year or ceases to be authorized to perform consular ² duties.

C. Special license plates provided by this section shall be designed in such a manner as to identify the use or ownership of the vehicle. Use of any vehicle possessing a special license plate provided by this section for any purpose not specified herein shall be grounds for revocation of the special license plate and registration certificate.

9 D. The fees provided by this section shall be deposited in the
 10 Oklahoma Tax Commission Reimbursement Fund.

Section 1135.2. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons in recognition of their service or awards as provided by this section.

Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year.

Special license plates shall be renewed each year by the Tax
Commission or a motor license agent. The Tax Commission shall

1 annually notify by mail all persons issued special license plates. 2 The notice shall contain all necessary information and shall contain 3 instructions for the renewal procedure upon presentation to a motor 4 license agent or the Tax Commission. The license plates shall be 5 issued on a staggered system except for legislative plates and 6 amateur radio operator license plates.

7 On and after January 1, 2022, if a special license plate is 8 issued pursuant to this section, any registration fee required for 9 such plate pursuant to this section and the fee required pursuant to 10 Section 1132 of this title shall be remitted at the same time and 11 subject to a single registration period. The Oklahoma Tax 12 Commission shall determine, by rule, a method for making required 13 fee and registration period adjustments if a special license plate 14 is obtained during a twelve-month period for which a registration 15 fee has already been remitted pursuant to Section 1132 of this 16 title. The combination of fees in a single remittance shall not 17 alter the apportionment otherwise provided for in this section. 18 The Tax Commission is hereby directed to develop and implement a 19 system whereby motor license agents are permitted to accept 20 applications for special license plates authorized under this 21 The motor license agent shall confirm the applicant's section. 22

⁶ B. The special license plates provided by this section are as ⁷ follows:

8 1. Prisoner of War License Plates - such plates shall be 9 designed for honorably discharged or present members of the United 10 States Armed Forces and civilians who were former prisoners of war 11 held by a foreign country and who can provide proper certification 12 of that status. Such persons may apply for a prisoner of war 13 license plate for no more than two vehicles with each vehicle having 14 a rated carrying capacity of one (1) ton or less. The surviving 15 spouse of any deceased former prisoner of war, if the spouse has not 16 since remarried, or if remarried, the remarriage is terminated by 17 death, divorce, or annulment, may apply for a prisoner of war 18 license plate for one vehicle with a rated carrying capacity of one 19 (1) ton or less. The fee provided by this section for the special 20 license plate authorized by this paragraph shall be in addition to 21 all other registration fees provided by law, except the registration 22 fees levied by Section 1132 of this title;

23 2. National Guard License Plates - such plates shall be 24 designed for active or retired members of the Oklahoma National

Guard. Retirees who are eligible for such plates shall provide proof of eligibility upon initial application, but shall not be required to provide proof of eligibility annually;

Air National Guard License Plates - such plates shall be
designed for active or retired members of the Oklahoma Air National
Guard. Retirees who are eligible for such plates shall provide
proof of eligibility upon initial application, but shall not be
required to provide proof of eligibility annually;

9 4. United States Armed Forces - such plates shall be designed 10 for active, retired, former or reserve members of the United States 11 Armed Forces, and shall identify which branch of service, and carry 12 the emblem and name of either the Army, Navy, Air Force, Marines or 13 Coast Guard, according to the branch of service to which the member 14 belongs or did belong. Former members who have been dishonorably 15 discharged shall not be eligible for such plates. Persons applying 16 for such license plate must show proof of present or past military 17 service by presenting a valid Uniformed Services Identity Card or 18 the United States Department of Defense Form (DD)214. Retired or 19 former members who are eligible for such plates shall provide proof 20 of eligibility upon initial application, but shall not be required 21 to provide proof of eligibility annually;

5. Congressional Medal of Honor Recipient License Plates - such plates shall be designed for any resident of this state who has been awarded the Congressional Medal of Honor. Such persons may apply

¹ for a Congressional Medal of Honor recipient license plate for each ² vehicle with a rated carrying capacity of one (1) ton or less. ³ There shall be no registration fee for the issuance of this plate;

4 6. Missing In Action License Plates - such plates shall be 5 designed to honor members of the United States Armed Forces who are 6 missing in action. The spouse of such missing person, if the spouse 7 has not since remarried, or if remarried, the remarriage is 8 terminated by death, divorce, or annulment, and each parent of the 9 missing person may apply for a missing in action license plate upon 10 presenting proper certification that the person is missing in action 11 and that the person making the application is the qualifying spouse 12 or the parent of the missing person. The qualifying spouse and each 13 parent of the missing person may each apply for the missing in 14 action license plate for each vehicle with a rated carrying capacity 15 of one (1) ton or less;

The 6 license plate shall be designed in consultation with the Special 7 Forces Association, Chapter 32-50. The Tax Commission shall produce 8 up to two distinct designs for the Special Forces Association 9 license plate. Qualified persons may select one design at the time 10 of application. The plates shall be issued to any qualified person 11 in any combination of numbers and letters from one to a maximum of 12 seven, as for personalized license plates.

C. Unless otherwise provided by this section, the fee for such plates shall be Eight Dollars (\$8.00) and shall be in addition to all other registration fees provided by the Oklahoma Vehicle License and Registration Act. Such fees shall be deposited in the Oklahoma Tax Commission Reimbursement Fund to be used for the administration of the Oklahoma Vehicle License and Registration Act.

SECTION 5. AMENDATORY 47 O.S. 2011, Section 1135.3, as last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp. 2020, Section 1135.3), is amended to read as follows:

Section 1135.3. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support, interest, or

title. The combination of fees in a single remittance shall not alter the apportionment otherwise provided for in this section.

3 The Tax Commission is hereby directed to develop and implement a 4 system whereby motor license agents are permitted to accept 5 applications for special license plates authorized under this 6 section. The motor license agent shall confirm the applicant's 7 eligibility, if applicable, collect and deposit any amount 8 specifically authorized by law, accept and process the necessary 9 information directly into such system and generate a receipt 10 accordingly. For performance of these duties, motor license agents 11 shall retain the fee provided in Section 1141.1 of this title for 12 registration of a motor vehicle. The motor license agent fees for 13 acceptance of applications and renewals shall be paid out of the 14 Oklahoma Tax Commission Reimbursement Fund.

15 If fewer than one hundred of any type of special license plates 16 authorized prior to January 1, 2004, are issued prior to January 1, 17 2006, the Tax Commission shall discontinue issuance and renewal of 18 that type of special license plate. Any such authorized special 19 license plate registrant shall be allowed to display the license 20 plate upon the designated vehicle until the registration expiration 21 date. After such time the expired special license plate shall be 22 removed from the vehicle.

Except as otherwise provided in law, for special license plates authorized on or after July 1, 2004, no special license plates shall

Unless otherwise 9 provided in this section, Fifteen Dollars (\$15.00) of the fee shall 10 be apportioned as follows: Eight Dollars (\$8.00) of the special 11 license plate fee shall be deposited in the Oklahoma Tax Commission 12 Reimbursement Fund to be used for the administration of the Oklahoma 13 Vehicle License and Registration Act and the remaining amounts of 14 the special license plate fee shall be apportioned as provided in 15 Section 1104 of this title.

16 D. The fee for special license plates that provide financial 17 assistance shall be determined in accordance with Section 1 of this 18 act 1135.9 of this title. Provided, the fee shall be no less than 19 Thirty-five Dollars (\$35.00) and shall be in addition to all other 20 registration fees provided by the Oklahoma Vehicle License and 21 Registration Act. Thirty-five Dollars (\$35.00) per year of renewal 22 of the fee shall be apportioned as follows:

Any remaining amounts of the fee shall be apportioned as
provided in Section 1104 of this title.

9 If a person applies for a special license plate that Ε. 10 provides financial assistance, the application shall designate a 11 state agency to be responsible for expending the funds generated by 12 the special license plate and the application shall designate a 13 specific public purpose for which the funds are to be used. The 14 application shall include an acknowledgment from the designated 15 state agency of their agreement with acceptance of the designated 16 funds.

F. Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year.

Special license plates shall be renewed each year by the Tax Commission or a motor license agent, unless authorized by the Tax Commission to be renewed for a period greater than one (1) year.

The Tax Commission shall notify all persons issued special license plates of the renewal procedures prior to the expiration of the special license plate. The notice shall contain all necessary information and shall contain instructions for the renewal procedure upon presentation to a motor license agent or the Tax Commission. The license plates shall be issued on a staggered system.

7 On and after January 1, 2022, if a special license plate is 8 issued pursuant to this section, any registration fee required for 9 such plate and the fee required pursuant to Section 1132 of this 10 title shall be remitted at the same time and subject to a single 11 registration period. The Oklahoma Tax Commission shall determine, 12 by rule, a method for making required fee and registration period 13 adjustments if a special license plate is obtained during a twelve-14 month period for which registration has already been remitted 15 pursuant to Section 1132 of this title. The combination of fees in 16 a single remittance shall not alter the apportionment otherwise 17 provided for in this section.

G. All special plates issued by the Tax Commission prior to the

Section 1151 of this title and of subsection A of Section 2103 of Title 68 of the Oklahoma Statutes.

The balance of the funds collected shall be remitted to the A Oklahoma Tax Commission as provided in Section 1142 of this title to be apportioned pursuant to Section 1104 of this title.

6 Β. For each certificate of registration issued for boats and 7 motors, each motor license agent shall be entitled to retain the 8 greater of One Dollar and twenty-five cents (\$1.25) or an amount to 9 be determined by the Tax Commission according to the provisions of 10 this subsection. At the end of fiscal year 1997 and each fiscal 11 year thereafter, the Tax Commission shall compute the average amount 12 of registration fees for all boats and motors registered in this 13 state during the fiscal year and shall multiply the result by six 14 and twenty-two one-hundredths percent (6.22%). The resulting 15 product shall be the amount which may be retained by each motor 16 license agent for each certificate of registration for boats and 17 motors issued during the following calendar year.
