11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. AMENDATORY 63 O.S. 2011, Section 1-201, is
13	amended to read as follows:
14	Section 1-201. There is hereby created in each county of the
15	state a county board of health, which shall consist of five (5)
16	members, who shall serve without compensation, and who shall be
17	residents of the county, appointed as follows:
18	(a) <u>A.</u> The State Commissioner of Health shall appoint one
19	member, whose term shall expire on June 30, 1964, and each four (4)
20	years thereafter.
21	(b) <u>B.</u> The State Commissioner of Health shall appoint another
22	member, whose term shall expire on June 30, 1965, and each four (4)
23	years thereafter. However, in any county of this state with a
24 2 -	population of more than two hundred twenty-five thousand (225,000),

¹ but not more than five hundred thousand (500,000), according to the ² latest Federal Decennial Census, such member shall be appointed by ³ the board of county commissioners of such county beginning upon ⁴ expiration of the term of the current member as of the effective ⁵ date of this act.

6 (c) C. The judge of the district court shall appoint one
7 member, who shall be the holder of a school administrator's
8 certificate issued by the State Board of Education, and whose term
9 of office shall expire on June 30, 1966, and each four (4) years
10 thereafter.

11 (d) <u>D.</u> The Board of County Commissioners board of county 12 <u>commissioners</u> shall appoint one member, who shall be a doctor of 13 medicine, doctor of osteopathy, or, if no doctor of medicine or 14 doctor of osteopathy is available, the board of county commissioners 15 may appoint a dentist, optometrist, or registered nurse. The term 16 of office of such member shall expire on June 30, 1967, and each 17 four (4) years thereafter.

¹⁸ (e) <u>E</u>. The board of county commissioners shall appoint another ¹⁹ member who may be a member of the board of county commissioners, and ²⁰ who shall serve at the pleasure of the board of county ²¹ commissioners.

SECTION 2. This act shall become effective November 1, 2021.
