6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State  
8 to refer to the people for their approval or  
9 rejection a proposed amendment to Section 1 of  
10 Article XXII of the Oklahoma Constitution; providing  
11 ballot title; prohibiting certain ownership of land  
12 through business entity or trust; decreasing  
allowable time period for disposition of certain  
property; modifying exception to certain ownership  
requirements; providing ballot title; and directing  
filing.

14 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE  
15 2ND SESSION OF THE 58TH OKLAHOMA LEGISLATURE:

16 SECTION 1. The Secretary of State shall refer to the people for  
17 their approval or rejection, as and in the manner provided by law,  
18 the following proposed amendment to Section 1 of Article XXII of the  
19 Oklahoma Constitution to read as follows:

20 Section 1. No alien or person who is not a citizen of the  
21 United States, shall acquire title to or own land in this state  
22 either directly or indirectly through a business entity or trust,  
23 and the Legislature shall enact laws whereby all persons not  
24 citizens of the United States, and their heirs, who may hereafter

1 acquire real estate in this state by devise, descent, or otherwise,  
2 shall dispose of the same within ~~five years~~ one (1) year upon  
3 condition of escheat or forfeiture to the State: Provided, This  
4 shall not apply to Indians born within the United States, nor to  
5 aliens or persons not citizens of the United States who may become  
6 bona fide residents of this State, or any lawfully recognized  
7 business entity, the majority of the voting stock or equivalent  
8 controlling equity interest of which is owned by one or more  
9 resident aliens: And Provided Further, That this section shall not  
10 apply to lands now owned by resident aliens in this State.

11 SECTION 2. The Ballot Title for the proposed Constitutional  
12 amendment as set forth in SECTION 1 of this resolution shall be in  
13 the following form:

16 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

17 This measure will amend Section 1 of Article 22 of the Oklahoma  
18 Constitution. The measure will prohibit ownership of land in  
19 Oklahoma by a business entity or trust of an alien or person who  
20 is not a citizen of the United States. The measure will  
21 decrease to 1 year the time period for such land to be returned  
22 to the state. The measure provides an exception to lawful  
23 resident aliens.
