There is hereby created in the State Treasury a revolving fund for the Department of Environmental Quality to be designated 6 7 the "Blue River-Little Blue Creek Stream Health Assessment Study Revolving Fund". The fund shall be a continuing fund, not subject 8 9 to fiscal year limitations, and shall consist of all monies received 10 by the Department from appropriations, apportionments, donations, 11 and federal grants received for the purpose of completing the study 12 created pursuant to subsection B of this section. All monies 13 accruing to the credit of the fund are hereby appropriated and may 14 be budgeted and expended by the Department for the purpose provided 15 for in this section. Expenditures from the fund shall be made upon 16 warrants issued by the State Treasurer against claims filed as 17 prescribed by law with the Director of the Office of Management and 18 Enterprise Services for approval and payment.

B. Pursuant to the requirements of Section 1-3-101 of Title 27A of the Oklahoma Statutes as it relates to waters emanating from a sensitive sole source aquifer, the Department shall establish and perform a Blue River-Little Blue Creek Stream Health Assessment Study. The Department shall first seek to coordinate with a qualified in-state university for the purpose of defining the study
