15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. NEW LAW A new section of law to be codified
17	in the Oklahoma Statutes as Section 1210.210 of Title 70, unless
18	there is created a duplication in numbering, reads as follows:
19	A. The State Department of Education Office of Federal Programs
20	shall, in conjunction with the Office of Planning and Coordination
21	for Services to Children and Youth Steering Committee established in
22	Section 601.6c of Title 10 of the Oklahoma Statutes, adopt a
23	standard form to be used by all school districts to identify
24	students who are homeless children and youth as defined in Section

600 of Title 10 of the Oklahoma Statutes. Beginning with the 2024-2025 school year, the form shall be completed annually at enrollment by the parent or guardian of a student or by the student if he or she is not in the physical custody of a parent or guardian. Districts shall report the results to the Department, in a manner prescribed by the Department, no later than June 1 of each year.

7 B. Beginning July 1, 2025, the Department shall compile a 8 report of the number of students identified as being homeless, by 9 district and grade level. The report shall be distributed annually 10 to the Governor, Speaker of the Oklahoma House of Representatives, 11 Chair of the House Common Education Committee, President Pro Tempore 12 of the Oklahoma State Senate, Chair of the Senate Education 13 Committee, and the Oklahoma Commission on Children and Youth. 14 SECTION 2.
