- SECTION 1. NEW LAW A new section of law to be codified
 in the Oklahoma Statutes as Section 835 of Title 62, unless there is
 created a duplication in numbering, reads as follows:
- This act shall be known and may be cited as the "Oklahoma Second

 Amendment Support and Promotion Act".
- SECTION 2. NEW LAW A new section of law to be codified
 in the Oklahoma Statutes as Section 836 of Title 62, unless there is
 created a duplication in numbering, reads as follows:
 - A. There is hereby created in the State Treasury a revolving fund for the Oklahoma Department of Commerce to be designated the "Oklahoma Second Amendment Support and Promotion Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of:
 - All monies apportioned or allocated to the fund pursuant to law;
 - 2. Any amounts appropriated by the Legislature to the fund;
 - 3. Donations from private entities; and

- 4. Interest earned on the investment of money in the fund.
- B. The fund shall be capped at Five Million Dollars (\$5,000,000.00).
- C. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Department of Commerce for the purpose of assisting counties in the attraction, development, and promotion of the firearms industry, with seventy-

- five percent (75%) of the awarded funds to be designated for
 existing businesses relocating to Oklahoma and twenty-five percent
 (25%) of the awarded funds to be designated for existing businesses
 located within the state.
 - D. In order to qualify for any funds from the Oklahoma Second Amendment Support and Promotion Fund, the county making application shall be engaged with a business that manufactures firearms, ammunition, firearm accessories, or firearm or ammunition parts, including the raw materials needed for those parts, or is otherwise engaged in the direct commerce of firearms or ammunition, including sales and distribution. The Department of Commerce shall give initial preference to developers of raw materials.
 - E. Counties may participate in infrastructure projects with local tax funds or apply to the Department of Commerce for funding from the Oklahoma Second Amendment Support and Promotion Fund. The Department of Commerce shall work with the chair of the board of county commissioners in each applicant county to identify potential sites which would benefit from the fund, including:
 - 1. Identifying infrastructure needs;
 - 2. Identifying needed utilities;

- 3. Local assistance in the attraction of new businesses; and
- 4. The further development of existing businesses.
- F. For selections of projects in an amount over Five Hundred
 Thousand Dollars (\$500,000.00), the Governor, in consultation with

- the Speaker of the Oklahoma House of Representatives and the
 President Pro Tempore of the Oklahoma State Senate, shall review and
 approve applications for funds from the Oklahoma Second Amendment
 Support and Promotion Fund.
 - G. In selecting applicant counties, the Department of Commerce shall consider the potential impact of the business with which the applicant county is engaged.
 - H. The Department of Commerce shall develop rules for the process of reviewing proposed expenditures from the Oklahoma Second Amendment Support and Promotion Fund and for the determination of whether or not proposed expenditures meet the criteria identified within this act.
 - I. The Department of Commerce may use up to two percent (2%) of funds from the Oklahoma Second Amendment Support and Promotion Fund for the administration of this act.
 - SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
