9	credibility of peace officers; authorizing peace officers to dispute reports of misconduct; directing
10	the Office of the Attorney General to refer petitions to an administrative law judge; directing the
11	administrative law judge to find in favor of the peace officer under certain circumstances; directing
12	administrative law judge to make certain determination based on evidence; requiring copy of
13	findings of fact and conclusions of law be provided to the court; providing for codification; and
14	providing an effective date.

17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 39.1 of Title 22, unless there
20	is created a duplication in numbering, reads as follows:
21	A. As used in this section:
22	1. "Attorney representing the state" means an attorney
23	authorized by law to represent the state in a criminal case
24	

1 including, but not limited to, a district attorney or city or 2 municipal attorney; and

2. "Law enforcement agency" means an agency of the state or an agency of a political subdivision of the state authorized by law to employ peace officers.

B. When evaluating the credibility of a peace officer who is
serving or will serve as a witness in a criminal proceeding, the
attorney representing the state may not disqualify the peace officer
as a witness on the basis of an allegation of misconduct by the
peace officer that has not been finally adjudicated as sustained.

11 C. For purposes of this section, an allegation of misconduct by 12 a peace officer is not considered finally adjudicated as sustained 13 if the allegation is under appeal through an administrative process 14 or judicial proceeding.

15 D. A peace officer who:

Is the subject of an allegation of misconduct reported by a
 law enforcement agency to an attorney representing the state;

18 2. Has been notified of a determination by an attorney 19 representing the state that the peace officer is not considered 20 credible to testify in a criminal proceeding as a result of an 21 allegation of misconduct; or

3. Has his or her name placed on a Brady/Giglio list or other similar list of noncredible peace officers by a law enforcement agency or an attorney representing the state,

1 may dispute that report, determination, or listing by filing a petition with the Office of the Attorney General for the purpose of 2 contesting said allegation, determination, listing, or other similar 3 4 action that adversely reflects on the credibility of the peace 5 officer. Upon request by the affected peace officer, the attorney representing the state or relevant law enforcement agency shall 6 7 provide the underlying facts affecting the credibility of the peace officer to the peace officer for purposes of a hearing under 8 9 subsection E of this section.

10 The Office of the Attorney General shall refer the petition Ε. 11 to an administrative law judge for an evidentiary hearing. The 12 administrative law judge shall provide findings of fact and 13 conclusions of law as to the validity of the allegations of 14 misconduct by the peace officer that resulted in the peace officer 15 being placed on a Brady/Giglio list or similar list of noncredible 16 peace officers. The respondent in the hearing shall be the law 17 enforcement agency that reported or alleged the misconduct by the 18 peace officer.

F. 1. If a peace officer has been placed on a Brady/Giglio list or similar list of noncredible peace officers due to an allegation of misconduct and the administrative process addressing said allegation is still pending or has been appealed, the administrative law judge shall find in favor of the peace officer.

1	2. If the administrative law judge finds the allegations of
2	misconduct are not supported by a preponderance of the evidence, the
3	law enforcement agency and attorney for the state may not rely on
4	said allegations for any purpose. Any court that considers the
5	credibility of a peace officer who has filed a petition with the
6	Office of the Attorney General, as authorized under the provisions
7	of this section, shall be provided a copy of the findings of fact
8	and conclusions of law issued by the administrative law judge.
9	SECTION 2. This act shall become effective November 1, 2023.
