7 PROPOSED COMMITTEE SUBSTITUTE

8 An Act relating to schools; amending 70 O.S. 2021,
9 Section 8-103.2, which relates to student transfers
10 participating in certain athletic competition;
11 granting eligibility for certain transfer students;
12 requiring immediate eligibility for students who
13 transfer prior to sophomore year; modifying criteria
14 of a one-year waiting period for certain students;
15 and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 70 O.S. 2021, Section 8-103.2, is
18 amended to read as follows:

19 Section 8-103.2 A. Except as otherwise provided, a student who
20 ~~enrolls~~ transfers, pursuant to the Education Open Transfer Act or
21 pursuant to Section ~~2~~ 8-113 of this ~~act~~ title, ~~in~~ to a school
22 district in which the student is not a resident shall ~~not~~ be
23 eligible to participate in school-related extramural athletic
24 competition governed by the Oklahoma Secondary School Activities
Association ~~for a period of one (1) year from~~ on the first day of

1 attendance at the receiving school ~~unless the transfer is from a~~
2 ~~school district which does not offer the grade the student is~~
3 ~~entitled to pursue~~ if the student did not letter in the school-
4 related extramural athletic competition at the student's prior
5 school.

6 B. A student who transfers prior to his or her sophomore year
7 of high school, pursuant to the Education Open Transfer Act or
8 Section 8-113 of this title, shall be eligible to participate in
9 school-related extramural athletic competition governed by the
10 Oklahoma Secondary School Activities Association on the first day of
11 attendance at the receiving school.

12 C. If the student is granted an emergency transfer pursuant to
13 Section 8-104 of this title, was granted a transfer for any reason
14 prior to January 1, 2000, or enrolls pursuant to the Education Open
15 Transfer Act and qualifies for a hardship waiver pursuant to the
16 rules of the Oklahoma Secondary School Activities Association,
17 eligibility to participate in school-related extramural athletic
18 competition shall be determined by the Oklahoma Secondary School
19 Activities Association. If the student does not meet the criteria
20 provided in subsection A or B of this section and does not qualify
21 for a hardship waiver, the student shall not be eligible to
22 participate in school-related extramural athletic competition
23 governed by the Oklahoma Secondary School Activities Association for
24

1 a period of one (1) year from the first day of attendance at the
2 receiving school.

3 SECTION 2. This act shall become effective November 1, 2023.
