PROPOSED COMMITTEE SUBSTITUTE

An Act relating to emergency management,  
appropriating disaster and emergency management  
funding; identifying revolving funds; establishing  
amounts, sources, and purposes; and declaring an  
emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be  
codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the State Emergency Fund,  
created pursuant to Section 139.42 of Title 62 of the Oklahoma  
Statutes, from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2023, the sum of Fifteen Million Dollars  
2 (\$15,000,000.00) to be utilized in accordance with law.

3 SECTION 2. NEW LAW A new section of law not to be  
4 codified in the Oklahoma Statutes reads as follows:

5 There is hereby appropriated to the State Assistance Dedicated  
6 for Disaster-impacted Local Economies Revolving Fund, created  
7 pursuant to Enrolled House Bill No. 2912 of the 2nd Session of the  
8 59th Oklahoma Legislature, from any monies not otherwise  
9 appropriated from the General Revenue Fund of the State Treasury for  
10 the fiscal year ending June 30, 2023, the sum of Thirty Million  
11 Dollars (\$30,000,000.00) to be utilized in accordance with law.

12 SECTION 3. It being immediately necessary for the preservation  
13 of the public peace, health or safety, an emergency is hereby  
14 declared to exist, by reason whereof this act shall take effect and  
15 be in full force from and after its passage and approval.
