3 SECTION 2. NEW LAW A new section of law not to be 4 codified in the Oklahoma Statutes reads as follows:

5 The Oklahoma Legislature hereby amends judicial salaries to take 6 effect July 1, 2024. The amended salary schedule provided for in 7 this section provides a salary increase of seven percent (7.0%) 8 above the salary levels existing during fiscal year 2024 for 9 positions listed as follows; all other judicial salaries shall 10 remain at the levels that existed as of January 1, 2024:

11 District Judges

12 Associate District Judges

13 Special District Judges.

14 SECTION 3. It being immediately necessary for the preservation 15 of the public peace, health or safety, an emergency is hereby 16 declared to exist, by reason whereof this act shall take effect and 17 be in full force from and after its passage and approval.
