There is hereby appropriated to the Legislative Service Bureau 3 from monies not otherwise appropriated from the Statewide Recovery 4 5 Fund of the State Treasury created in Enrolled House Bill No. 3349 6 of the 2nd Session of the 58th Oklahoma Legislature, the sum of 7 Fourteen Thousand One Hundred Ten Dollars (\$14,110.00) or so much 8 thereof as may be necessary to pay obligations that may arise out of 9 contracts during the Fiscal Year 2023 and Fiscal Year 2024 related 10 to the American Rescue Plan Act of 2021.

11 SECTION 3. It being immediately necessary for the preservation 12 of the public peace, health or safety, an emergency is hereby 13 declared to exist, by reason whereof this act shall take effect and 14 be in full force from and after its passage and approval.
