16	SECTION 1. AMENDATORY 28 O.S. 2021, Section 152.1, is
17	amended to read as follows:
18	Section 152.1 A. In civil cases, the court clerk shall collect
19	and deposit in the court fund the following charges in addition to
20	the flat fee:
21	1. For posting notices and filing
22	certificates required by statute\$30.00

2		setoff pursuant to Section 1758 of

4	3.	For mailing by any type of mail writs,

18	6.	For sheriff's fees on court-ordered

20		fee to be paid by the purchaser of the

1	b. for any other purchaser, an amount equal to three
2	percent (3%) of the sales price paid by the purchaser
3	for the property
4	7. When a jury is requested
5	8. For issuing each summons for each person\$10.00
6	9. For services of a court reporter at each
7	trial held in the case\$20.00
8	10. For filing a motion for summary
9	judgment or summary disposition of
10	issue(s)\$50.00
11	The fees prescribed in paragraphs 5 and 6 of this subsection
12	shall be paid by the court clerk into the Sheriff's Service Fee
13	Account, created pursuant to the provisions of Section 514.1 of
14	Title 19 of the Oklahoma Statutes, of the sheriff in the county
15	where service is made or attempted or where the sheriff's sale
16	occurs. All other fees shall be deposited into the local court fund
17	in the county where collected.
18	B. The fee prescribed in paragraph 7 of subsection A of this
19	section shall be paid at the time of the pretrial conference by the
20	party requesting a jury.
21	SECTION 2. This act shall become effective July 1, 2023.
22	SECTION 3. It being immediately necessary for the preservation
23	of the public peace, health or safety, an emergency is hereby
