8 An Act relating to schools; amending 70 O.S. 2021,
9 Sections 5-132 and 5-132.1, which relate to adult
10 high school completion; removing reasons for which
11 certain persons were unable to attend school;
12 updating statutory language; updating statutory
13 reference; providing exemption from certain
14 assessments for certain persons; providing an
15 effective date; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 70 O.S. 2021, Section 5-132, is
18 amended to read as follows:

19 Section 5-132. A. Any person who is of legal age and a
20 resident of ~~Oklahoma~~ this state, over the age of twenty-one (21) and
21 under the age of twenty-six (26), and who has not completed the
22 twelfth grade in school shall be given the same educational
23 privileges and opportunities provided by law for children over the
24 age of five (5) and under the age of twenty-one (21), upon
submitting to the board of education of the school district in which
the person resides evidence satisfactory to that board showing that

1 during the time before he or she was twenty-one (21) years of age he
2 or she was unable to attend school for a definite period or periods
3 of time ~~because of physical disability, or service in the United~~
4 ~~States Armed Forces or Auxiliary Organizations,~~ by reason whereof it
5 was impossible for him or her to complete the twelfth grade before
6 reaching the age of twenty-one (21). Provided, further, the pupil
7 shall be counted in the average daily attendance of the district
8 where he or she attends school during the period of time provided
9 for in this ~~article~~ section for the purpose of calculating State Aid
10 for the district.

11 B. Any resident of the state who is nineteen (19) years of age
12 or older, who is not enrolled in any high school program, and who
13 has not completed the twelfth grade may attend any adult high school
14 completion program which is established by a school district and
15 approved by the State Board of Career and Technology Education if
16 such attendance has the approval of the district offering the
17 program. Such attendance shall not be counted in the average daily
18 attendance of the district unless the Legislature appropriates
19 monies for adult high school completion programs. Such attendance
20 shall not be counted to meet minimum numbers for accreditation of
21 the school district involved, and such students shall not attend
22 classes which are a part of the normal class structure of the
23 district.

1 C. A person subject to the provisions of subsection A or B of
2 this section shall not be required to take the student assessments
3 required by Section 1210.508 of this title.

4 SECTION 2. AMENDATORY 70 O.S. 2021, Section 5-132.1, is
5 amended to read as follows:

6 Section 5-132.1. A. Any person other than those persons
7 provided for in Section 5-132 of this title, who is twenty-one (21)
8 years of age or older and who has not completed the requirements for
9 a high school diploma or ~~received a General Education Diploma~~
10 Development (GED) requirements, upon proper application to an
11 independent school district may be given the opportunity to complete
12 the requirements for and receive a regular high school diploma.

13 B. The school district or technology center school district in
14 which such person resides may give the person the option of
15 attending regular classes if class size restrictions are not
16 violated, or of participating in other programs which may be
17 provided pursuant to provisions of the Oklahoma Statutes or rules
18 promulgated by the State Board of Education or State Board of Career
19 and Technology Education. ~~Providing~~ Provided, however, that the
20 school district may deny admittance of persons over twenty-one (21)
21 years of age to its classes.

22 C. The school district or technology center school district may
23 charge such person an amount of tuition not to exceed the average
24 expenditure per pupil of the district for the preceding school year.

1 ~~Said~~ The tuition may be prorated by the number of contact hours for
2 which the person is enrolled.

3 D. A person subject to the provisions of subsection A of this
4 section shall not be required to take the student assessments
5 required by Section 1210.508 of this title.

6 SECTION 3. This act shall become effective July 1, 2024.

7 SECTION 4. It being immediately necessary for the preservation
8 of the public peace, health, or safety, an emergency is hereby
9 declared to exist, by reason whereof this act shall take effect and
10 be in full force from and after its passage and approval.
