1 63 O.S. 2021, Sections 1-879.2 and 1-879.3, which relate to the Alzheimer's Research Advisory Council 2 and duties, development, and enhancement of the Core Neuropathy Laboratory; providing for codification; and providing an effective date. 3 4 5 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 6 7 SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-879.11 of Title 63, unless 8 9 there is created a duplication in numbering, reads as follows: This act shall be known and may be cited as the "Alzheimer's 10 Disease and Related Dementia Infrastructure Act". 11 12 SECTION 2. NEW LAW A new section of law to be codified 13 in the Oklahoma Statutes as Section 1-879.12 of Title 63, unless 14 there is created a duplication in numbering, reads as follows: 15 As used in this act: 1. "Alzheimer's Disease and Related Dementia State Plan" or 16 17 "state plan" means a plan developed by the state in conjunction with 18 stakeholders for meeting the needs of individuals with Alzheimer's 19 disease and related dementia and their caregivers; 20 2. "Caregiver" means any person other than a paid provider who 21 provides care for a person with dementia; and 22 3. "Dementia" means a degenerative disease of the central 23 nervous system characterized especially by premature cognitive 24 deterioration. This includes Alzheimer's disease and related

1 dementia and diagnoses which are similarly marked by irreversible 2 deterioration of intellectual faculties with concomitant emotional disturbance resulting from organic brain disorder, such as: 3 4 chronic traumatic encephalopathy, a. 5 b. Creutzfeldt-Jakob disease, frontotemporal dementia, 6 с. 7 d. Huntington's disease, Korsakoff syndrome, 8 e. 9 f. Lewy body dementia, Parkinson's disease, 10 q. 11 h. progressive supranuclear palsy, 12 i. vascular dementia, or 13 j. any other neurocognitive disorder that results in the irreversible deterioration of intellectual faculties. 14 15 A new section of law to be codified SECTION 3. NEW LAW 16 in the Oklahoma Statutes as Section 1-879.13 of Title 63, unless 17 there is created a duplication in numbering, reads as follows: 18 The State Department of Health shall compile and publish an Α. 19 Alzheimer's Disease and Related Dementia State Plan and shall update 20 the state plan every four (4) years. The Department shall consult 21 with relevant stakeholders when compiling and updating the state 22 plan. 23 Components of the state plan shall include, but not be в.

Information on statewide coordination and service system
 development for Alzheimer's disease and related dementia;

3 2. Information on education, support, and other available4 services for Alzheimer's disease and related dementia;

3. Progress reports, updates, and measures of improvement or
decline in relevant metrics regarding dementia diagnosis, treatment,
services, and outcomes as compared to the previous state plan;

8 4. Public policy recommendations concerning Alzheimer's disease9 and related dementia for state policymakers; and

10 5. Information on all grant awardees, projects, and amounts 11 awarded under Section 5 of this act.

12 C. The Department shall publish the state plan on its Internet 13 website and shall submit the state plan to the Speaker of the 14 Oklahoma House of Representatives, the President Pro Tempore of the 15 Oklahoma State Senate, the Governor, and the appropriate cabinet 16 secretary.

D. The State Department of Health shall create and publish an
annual report that consists of the progress of implementing the
state plan, and the use and distribution of the Dementia Caregiver
Support Group and Education Program Development Fund and the
Alzheimer's Disease and Related Dementia Research Fund.

E. The Department shall publish the annual report on itsInternet website.

1 SECTION 4. NEW LAW A new section of law to be codified 2 in the Oklahoma Statutes as Section 1-879.14 of Title 63, unless there is created a duplication in numbering, reads as follows: 3 4 There is hereby created in the State Treasury a revolving fund 5 for the State Department of Health to be designated the "Dementia Caregiver Support Group and Education Program Development Fund". 6 7 The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies deposited to the credit 8 9 of the fund by law. All monies accruing to the credit of the fund 10 are hereby appropriated and may be budgeted and expended by the 11 Department for the purpose of awarding grants as described in 12 Section 5 of this act. Expenditures from the fund shall be made 13 upon warrants issued by the State Treasurer against claims filed as 14 prescribed by law with the Director of the Office of Management and 15 Enterprise Services for approval and payment.

16 SECTION 5. NEW LAW A new section of law to be codified 17 in the Oklahoma Statutes as Section 1-879.15 of Title 63, unless 18 there is created a duplication in numbering, reads as follows:

19 A. The State Department of Health shall develop a program to 20 award grants to nonprofit organizations operating in areas of this 21 state that meet the United States Census Bureau classification of 22 "rural" to support community efforts to establish support groups and 23 evidence-based community education programs for caregivers of

persons with Alzheimer's disease and related dementia. Subject to
 available funding, the grants shall be awarded annually.

B. The Department shall develop an application process and
eligibility requirements for receiving the grants. The Department
shall be responsible for distributing and managing the grant awards.

6 C. The State Commissioner of Health may promulgate rules as7 necessary to implement this act.

D. The State Department of Health shall include information on
the awardee(s), project(s), and dollars awarded in the annual report
as described in Section 3 of this act.

E. This fund shall sunset five (5) years from the enactment of this act.

SECTION 6. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-879.16 of Title 63, unless there is created a duplication in numbering, reads as follows:

16 There is hereby created in the State Treasury, subject to Α. 17 the availability of funds, a revolving fund for the State Department 18 of Health to be designated the "Alzheimer's Disease and Related 19 Dementia Research Fund". The Alzheimer's Disease and Related 20 Dementia Research Fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies deposited 21 22 to the credit of the fund by law. All monies accruing to the credit 23 of the fund are hereby appropriated and may be budgeted and expended 24 by the State Department of Health for the purposes listed in Section

5 of this act. Expenditures from the fund shall be made upon
 warrants issued by the State Treasurer against claims filed as
 prescribed by law with the Director of the Office of Management and
 Enterprise Services for approval and payment.

B. The awards shall be made through an awards committee of
seven (7) members, coordinated by the Dementia Services Manager,
consisting of three (3) representatives from the scientific and
medical communities, three (3) members of the general public, and
the Dementia Services Manager.

C. The awards shall be given annually to selected applicants residing and performing research in the State of Oklahoma in order to support research into the causes of Alzheimer's disease and related dementia, methods of treatment, ways that families can cope with the stresses of the disease, and the impact of the disease on Oklahoma.

D. Information on the awardee, project, and dollars awarded shall be included in the annual report as described in Section 3 of this act.

19SECTION 7.NEW LAWA new section of law to be codified20in the Oklahoma Statutes as Section 1-879.17 of Title 63, unless21there is created a duplication in numbering, reads as follows:

A. The State Department of Health shall maintain a minimum of at least one (1) dementia-specific trained and certified community 24

health worker, health educator, or other relevant employee in each
 health district to serve Oklahoma residents.

The State Department of Health shall have a dementia-3 Β. 4 specific trained and certified community health worker, health 5 educator, or other relevant employee in each health district by identifying and training one (1) relevant employee in three (3) 6 7 health districts the year after the enactment of this act, then one 8 (1) relevant employee in three (3) health districts each year 9 following until each health district has one (1) dementia-specific 10 trained and certified relevant employee serving each health district 11 or by year four after the enactment of this act, whichever comes 12 first.

C. Each health district shall select an employee to receive the dementia-specific training and certification based on that district's assessment of the employee's capabilities, workload, competency, and interest. The health district shall oversee the employee in the employee's day-to-day capacity.

D. The State Department of Health-trained and -certified dementia-specific employee shall serve Oklahoma residents in the following manner:

Connect caregivers and persons living with Alzheimer's
 disease or related dementia to community resources;

23 2. Provide community outreach, engagement, and education on
24 Alzheimer's disease and related dementia; and

3. Help connect caregivers and persons living with Alzheimer's
 disease or related dementia to relevant education and support
 groups.

E. The State Department of Health-trained and -certified
dementia-specific employee shall complete a dementia care training
program recognized by the Centers for Medicare and Medicaid Services
(CMS) from a certified training source or trainer.

8 F. The State Department of Health-trained and -certified
9 dementia-specific employee shall complete annual continuing
10 education.

G. Each health district shall work with the employee acting as the director or manager of federal funds pertaining to the development of a dementia-friendly public health system to share data and quality metrics on the trained and certified dementiaspecific employee's impact in local communities. Data and quality metrics shall be established by the Center for Chronic Disease Prevention and Health Promotion.

H. The oversight of the trained and certified dementia-specific employee's certification status, continuing education, data and quality metrics analysis, and impact reporting shall reside with the employee acting as the director or manager of federal funds pertaining to the development of a dementia-friendly public health system. As part of this oversight, the employee acting as the director or manager of federal funds pertaining to the development

1 of a dementia-friendly public health system shall receive up to ten 2 percent (10%) of administrative funds to ensure sustainability of 3 the integrity of the trained and certified dementia-specific 4 employee program.

5 I. The State Department of Health shall include information on 6 the implementation of the trained and certified dementia-specific 7 employees and the data and quality metrics achieved in local 8 communities in the annual report as described in Section 3 of this 9 act.

10 SECTION 8. NEW LAW A new section of law to be codified 11 in the Oklahoma Statutes as Section 1280.5 of Title 59, unless there 12 is created a duplication in numbering, reads as follows:

13 Curriculum for certified community health workers shall include, 14 but not be limited to, training on Alzheimer's disease and related 15 dementia.

16 SECTION 9. REPEALER 63 O.S. 2021, Sections 1-879.2 and 17 1-879.3, are hereby repealed.

SECTION 10. This act shall become effective November 1, 2023.
